NOTE 1: DESCRIPTION OF PLAN

The following description of Priestly Fraternity of St. Peter, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a profit sharing/401(k) plan covering all employees of Priestly Fraternity of St. Peter, (the "Plan Sponsor") who have attained the age of twenty-one and have worked in excess of 500 hours. An employee becomes a participant on the first day of the month coincident with or next following the date of satisfaction of the eligibility requirements. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan Trustees are responsible for oversight of the Plan.

Contributions

Employees may elect to contribute, subject to defined limitations, any percentage or dollar amount of their base salary to the Plan pursuant to Section 401(k) of the Internal Revenue Code. The Plan Sponsor may make a discretionary profit sharing contribution to every eligible employee that participates in the Plan. For the years ended December 31, 2024 and 2023 profit sharing contributions were 8% of total salary for District Headquarters employees and 5% of total salary for Seminary employees. No contributions were made to the Priest's accounts for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution as well as the Plan Sponsor's profit sharing contribution, and plan earnings (losses); and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested with respect to their entire account.

Notes Receivable from Participants

The Plan does not permit participants to borrow from their accounts.

Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair-value of investments, and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC ("Empower Trust") (the trustee of the Plan).

Forfeited Accounts

For the years ended December 31, 2024 and 2023, there were no forfeited nonvested accounts.

Payment of Benefits

The Plan provides for separation from service, normal retirement, death and disability benefits. The beneficiary is entitled to 100% of the account balance upon death of the participant. If the participant becomes disabled the participant is entitled to 100% of the account balance. Benefits are recorded when paid. Benefits are payable in lump sums or installments.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting and are presented in the format prescribed by the DOL Rules and Regulations for Reporting and Disclosure under ERISA.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Sponsor to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair-value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair-value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair-value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Expenses

Investment expenses of the Plan are allocated among the participant's accounts. Administrative expenses paid to the third-party administrator are paid by the Plan Sponsor and are not charged to the Plan.

Subsequent Events

Subsequent events were evaluated through October 6, 2025, which is the date the financial statements were available to be issued.

NOTE 3: INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

For the years ended December 31, 2024 and 2023, the plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified as complete and accurate by Empower Trust Company, LLC, the Plan trustee, and Empower Retirement, the custodian of the pooled separate accounts, and was not subjected to any auditing procedures performed by the independent auditors:

- A. Investments at fair-value as shown in the accompanying statements of net assets available for benefits of \$7,549,442 and \$6,903,980 as of December 31, 2024 and 2023, respectively.
- B. Investments at contract value shown in the accompanying statements of net assets available for benefits of \$101,114 and \$75,085 as of December 31, 2024 and 2023, respectively.

- C. Investment income as shown in the accompanying statements of changes in net assets available for benefits was \$275,479 and \$163,356 for the years ended December 31, 2024 and 2023, respectively.
- D. Realized and unrealized gains and (losses) as shown in the accompanying statements of changes in net assets available for benefits was \$554,530 and \$861,237 for the years ended December 31, 2024 and 2023, respectively.
- E. All investment-related information in the accompanying supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

NOTE 4: TAX STATUS

The Internal Revenue Service ("IRS") has determined and informed the Plan Sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits in progress for any tax periods.

NOTE 5: FAIR-VALUE MEASUREMENTS

The Plan's investments are reported at fair-value in the accompanying statements of net assets available for benefits. The methods used to measure fair-value may produce an amount that may not be indicative of net realizable value or reflective of future fair-values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair-value of certain financial instruments could result in a different fair-value at the reporting date.

NOTE 5: FAIR-VALUE MEASUREMENTS (CONT'D)

The fair-value measurement accounting literature establishes a fair-value hierarchy that prioritizes the inputs to valuation techniques used to measure fair-value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair-value of its investments. When available, the Plan measures fair-value using Level 1 inputs because they generally provide the most reliable evidence of fair-value. Level 3 inputs are used only when Level 1 or Level 2 inputs were not available. As of December 31, 2024 and 2023, none of the Plan's investments are measured using Level 3 inputs.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation (depreciation) in fair-value of assets.

Following is a description of the valuation methodology used for assets measured at fair-value.

Mutual Funds

Share price reported on the Plan Summary Reports for NAV mutual funds are generally obtained from a file feed from the National Securities Clearing Corporation and/or directly from the fund house or a secondary pricing source, such as Interactive Data Corporation.

NOTE 6: INVESTMENTS AT CONTRACT VALUE

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Empower Trust totaling \$101,114 and \$75,085 at December 31, 2024 and 2023, respectively. Empower Trust maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not have a scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Trust, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal of their investment as a lump sum distribution with a market rate adjustment, or an installment payout, at contract value over a period of years.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

NOTE 7: PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Plan termination would have no effect on participant accounts since they are already 100% vested.

NOTE 8: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9: RECONCILIATION OF FINANCIAL STATEMENTS TO IRS FORM 5500

No differences exist between the amounts reported in the accompanying financial statements and the IRS Form 5500.
