Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Terlato Wine Group, Ltd. Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering eligible employees of Terlato Wine Group, Ltd. (the Company), and its wholly owned subsidiaries Terlato Wines International, Rutherford Hill Winery, and Chimney Rock Winery, LLC, as well as Sanford Winery Company (Sanford), a 95.95%-owned subsidiary. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility: Employees who have attained the age of 21, have worked a minimum of 1,000 hours of service if a part-time employee (no service requirement for full-time employees), and are not covered by a collective bargaining agreement are immediately eligible to participate in the Plan.

Contributions: Contributions to the Plan include salary reduction contributions authorized by participants, fixed matching contributions, discretionary matching contributions and rollovers from other plans. Contributions are subject to certain IRS limitations.

Each year, participants may contribute up to 60% of pretax compensation. Roth contributions are also permitted under the provisions of the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Employees are automatically enrolled into the Plan, unless elected otherwise, at a rate of 6% for new employees. As of January 1st of each plan year, current employees who are eligible to participate but not deferring will be automatically enrolled into the Plan at a rate of 6%, unless elected otherwise prior to January 1st.

Each pay period, the Plan provides for a fixed matching contribution of 25% of employee pretax contributions on the first 6% of eligible compensation, with the total matching contribution not to exceed 1.5% of compensation. Annually, the Company may make an additional discretionary matching contribution. In order to be eligible for the discretionary matching contribution, participants must be employed on the last day of the Plan year and have worked 1,000 hours during the Plan year. For the Plan year ended December 31, 2024, there were fixed matching contributions of \$346,078 and no discretionary contributions.

Participant Accounts: Accounts are credited with the participant's contributions and an allocation of the Company's contributions and Plan earnings. Their accounts are also charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on contributions, eligible compensation, account balances, or specific participant transactions, as defined. The participant is entitled to the participant's vested account. Investment options available under the Plan are directed by the participant to his or her account.

Vesting: Participants are immediately vested in their contributions plus earnings thereon. Vesting in the participating employer's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant's vested percentage in the employer contributions shall be no less than the percentage determined in the following schedule:

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's vested account balance and bear interest at rates that are commensurate with market rates for loans that would be made under similar circumstances. Principal and interest are paid ratably through payroll deductions over a period not longer than five years, unless loan proceeds were used to acquire a personal residence.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Payment of Benefits: Upon termination of service, a participant may receive an amount equal to the value of the participant's vested interest in his or her account. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may take distributions from the Plan upon attainment of age 59½. A participant may also elect to receive the payment of their benefits in the form of an annuity, if they participated in the Plan on or before April 1, 2003.

Forfeited Accounts: At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$42,604 and \$1,006, respectively. The forfeited accounts are used to pay any reasonable Plan expenses the Company does not pay and to reduce future employer contributions. During 2024, all forfeitures were used to pay administrative expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on an accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit responsive investment contracts, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. See Note 3 for discussion of fair value measurements. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Administrative expenses are paid by the Plan through forfeitures until fully utilized, then paid by the Company.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions, and the notes are collateralized by the participants' account balances.

NOTE 3 - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board has issued guidance that establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs using valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Participant directed accounts – Accounts primarily consist of mutual funds, exchange traded funds, and common stocks that are determined by obtaining quoted prices on nationally recognized securities exchange (Level 1 inputs). The accounts also include a money market fund for which the fair value is estimated to approximate the cost basis of the account balance, based upon the liquidity of the account and the credit quality of the issuer (Level 1 inputs). The Plan's investments in the money market fund occasionally exceed the federally insured balance.

NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Professional services for the audit of the Plan and other administrative expenses of the Plan are paid directly by the Company. The Plan holds a guaranteed investment contract with Transamerica Life Insurance Company, Inc. (TLIC), a stable value fund with Transamerica Financial Life Insurance Company, Inc. (TFLIC), and mutual funds managed by Transamerica Asset Management, Inc. (TAM). TFLIC and TLIC are affiliates of Transamerica Retirement Solutions, LLC (the Plan's third-party administrator), and therefore, these transactions and the Plan's payment of fees to these entities qualify as party-in-interest transactions. TAM is an affiliate of TFLIC and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to other service providers also qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 5 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica Financial Life Insurance Company, Inc., State Street Bank and Trust Company (SSBT, the trustee of the Plan) and Transamerica Life Insurance Company, Inc.

NOTE 6 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a fully benefit-responsive traditional investment contract that is reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. At December 31, 2024 and 2023, the investment contract was held in the TLIC Guaranteed Investment Option Fund. This fund is a group annuity contract where contributions are deposited into a guaranteed separate account. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The TLIC Guaranteed Investment Option Fund specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, bankruptcy, partial Plan termination, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Issuer may terminate the contract. Examples of circumstances which would allow the Issuer to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, the Issuer could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

The TLIC Guaranteed Investment Option Fund maintains minimum guaranteed interest rates. At the beginning of each calendar year, TLIC determines the declared interest rate which will be applicable to all monies invested in the Guaranteed Investment Option Fund during such calendar year. Assets under the contract will be credited with the greater of the declared interest rate and the applicable minimum guaranteed interest rate.

The Plan holds a fully benefit-responsive stable value fund that is reported at contract value, which is generally the amount the Plan would receive if it would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less withdrawals and administrative expenses. The contract is a stable value fund. Participants do not have the ability to invest in the stable value fund. Plan forfeitures are invested in the stable value fund.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Company contribution accounts.

NOTE 8 - TAX STATUS

The IRS issued an opinion letter dated June 30, 2020, indicating that the volume submitter plan adopted by the Plan Sponsor as then designed was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original volume submitter document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires management of the Plan to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, liquidity, market credit risks and global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through October 7, 2025, which is the date the financial statements were available to be issued. Effective January 1, 2025, the Plan adopted provisions under the Secure 2.0 Act related to additional catch-up provisions for participants aged 60-63 years.
