### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Rohrich Automotive Group, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1 - PLAN DESCRIPTION**

---

The following description of the Rohrich Automotive Group, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of Rohrich Automotive Group, Inc. (the "Company") who have been credited with one year of service and have attained twenty-one (21) years of age. The Company is a member of an affiliated service group, some of whom adopted the Plan as participating employees. Eligible employees are enrolled in the Plan the first day of the plan year quarter when eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Administrative Committee is responsible for oversight of the Plan and the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions**

Each year participants may elect to have compensation deferred, including Roth directed deferrals, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their account balance into various investment options offered by the Plan. The Plan includes an automatic salary deferral feature. Under this feature, participants may be automatically enrolled at a rate of 3% of their compensation. Effective January 1, 2024, the 3% rate will increase by 1% each year up to a maximum of 10% of eligible compensation. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company makes a discretionary matching contribution equal to a discretionary percentage, to be determined by the Company, based on the participant's elective deferrals and conditions of employment at the end of the Plan year. In addition, the Company may elect to make a discretionary profit sharing contribution. The Company did not make a discretionary profit sharing contribution for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company discretionary matching contributions, the participant's allocation of the Company's discretionary profit sharing contribution, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions and any discretionary profit sharing contributions plus actual earnings thereon. Participants are fully vested in the employer discretionary matching contributions upon completion of six years of credited service.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant can receive the value of their vested account as prescribed in the plan document. The Plan provides that if a participant's interest in the Plan is \$5,000 (\$1,000 before July 1, 2023) or less, a distribution will be made regardless of whether the participant consents to the distribution. If the participant's interest in the Plan exceeds \$5,000 (\$1,000 before July 1, 2023), then the participant's consent is generally needed in order to make the distribution. In-service distributions may be made to a participant who has not separated from service having attained the age of 59½. In addition, the Plan allows for hardship distributions if certain criteria are met.

**Forfeiture**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$2,400 and \$7,900, respectively. A forfeiture results from the non-vested portion of the employer discretionary matching accounts of a terminated participant. Forfeited amounts may be used to offset Plan administrative expenses or reduce Company contributions to the Plan. Forfeitures of approximately \$7,800 were used to pay plan expenses for the year ended December 31, 2024. Forfeitures of approximately \$2,200 were used to reduce the amount of the discretionary matching contributions due to the Plan as of December 31, 2024.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

---

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisor. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses in investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which participant contributions are withheld from compensation.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025. There were no 2023 excess contributions payable.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 8, 2025, the date the financial statements were available to be issued.

Effective February 5, 2025, the Plan changed trustees and entered into a directed trustee agreement with Mid Atlantic Trust Company. As a result, all plan assets were transferred from Charles Schwab Trust Bank to Mid Atlantic Trust Company.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These funds held by the Plan are deemed to be actively traded.

*Collective investment trusts:* Valued at net asset value ("NAV") of units of a collective investment trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) occur daily. At December 31, 2024 and 2023, there were no unfunded commitments and investments are redeemable on a daily basis and without restriction.

**NOTE 6 - TAX STATUS**

---

The Company has adopted a non-standardized pre-approved profit sharing plan with CODA sponsored by SDAdvantage Retirement Solutions LP. The IRS has determined and informed entities that are using the non-standardized pre-approved profit sharing plan in a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the plan's tax counsel believe that the Plan is currently designed and being operated in accordance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
