Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedule Required by ERISA**

The supplemental Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## 1. Description of Plan

The following description of the San Bernardino Medical Orthopaedic Group, Inc. dba Arrowhead Orthopaedics 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### *General*

The Plan is a defined contribution plan covering all eligible employees of San Bernardino Medical Orthopaedic Group, Inc. dba Arrowhead Orthopaedics (the “Plan Sponsor” and “Plan Administrator”). The Plan was established by the Plan Sponsor on January 1, 1990 to provide retirement income for its employees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (“ERISA”).

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement 2.0 Act (“Secure 2.0 Act”) was passed by Congress. The Secure 2.0 Act contains numerous provisions that impact employee benefit plans. Generally, the deadline for formally adopting any required plan amendments made pursuant to the Secure 2.0 Act is December 31, 2026; however, plans must be operated in accordance with the effective dates of each new provision. The Plan has administratively complied with and adopted all applicable provisions of the Secure 2.0 Act for the years ending December 31, 2024, and 2023. The Plan Sponsor expects the Plan to be formally amended prior to the Secure Act 2.0 deadlines.

### *Eligibility*

All employees are eligible to participate in the Plan upon attaining the age of 21 and completing one year of service with the Plan Sponsor. Plan entry date is the first day of the Plan Year or the first day of the seventh month of the Plan Year coinciding with or next following the date the requirements are met.

### *Contributions*

The Plan is a contributory plan whereby participants may contribute up to 100% of pre-tax annual compensation not to exceed the dollar limit set by law of \$23,000 for 2024. Participants age 50 or older may elect to defer an additional \$7,500 of “catch up” contributions to the Plan. In addition, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan Sponsor provides a safe-harbor non-elective contribution equal to 3% of each participant’s compensation. The Plan Sponsor may also make discretionary profit sharing contributions on behalf of non-highly compensated participants to the Plan. For the year ended December 31, 2024, the Plan Sponsor made safe-harbor non-elective contributions and profit sharing contributions to the Plan of approximately \$775,200 and \$1,036,249, respectively.

### *Participant Accounts*

Each participant’s individual account is credited with participant contributions, the Plan Sponsor’s contributions, and Plan investment earnings. Participants may choose to have their account balance deposited in various investment programs. Allocation of Plan investment earnings is based on the participant’s account balance, as defined.

***Vesting***

Participants are immediately vested in their contributions and actual earnings thereon and the Plan Sponsor's safe-harbor non-elective contributions. Vesting in the Plan Sponsor's discretionary profit sharing contributions and earnings thereon for employees is based on years of continuous service as follows:

***Participant Notes Receivable***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms have a maximum of 5 years. The notes are secured by the balance in the participant's account and bear a reasonable fixed rate of interest to be determined by the Plan Administrator. Interest rates on participant notes were from 5.25% to 10.50% as of December 31, 2024. Principal and interest is paid ratably through payroll deductions. As of December 31, 2024 and 2023, there were approximately \$569,676 and \$408,411 of participant notes outstanding, respectively.

***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as excess contributions owed to participants. As of December 31, 2024 and 2023, there was no excess contributions payable.

***Investment Options***

As of December 31, 2024, participants may self-direct employee and employer contributions in to various investment options available for investment. The investment options include mixes of various mutual funds.

***Payments of Benefits***

Upon termination of service due to death, disability, or retirement, a participant will receive, as benefits, an annuity or a lump sum amount equal to the value of his/her account, distributed in accordance with the Plan.

***Forfeitures***

Forfeitures are the non-vested portion of a participant's account that is lost upon termination of employment. Forfeitures may be used to pay administrative expenses as determined by the Plan Sponsor. Any remaining forfeitures may be used to reduce Plan Sponsor contributions. During the year ended December 31, 2024, \$1,751 in forfeitures was used to reduce Plan Sponsor contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$20,701 and \$1,751, respectively.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared using the accrual method of accounting. The Plan's investments are stated at fair market value. Quoted market prices are used to value investments. Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Sponsor to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. The Plan Sponsor believes that the estimates utilized in preparing these financial statements are reasonable and prudent. Actual results could differ from these estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation and depreciation in fair value of investments consists of realized gains and losses and the change in unrealized gains and losses in the Plan's investments. Realized gains and losses from the sale of investments are computed using the participant's cost basis in the investment aggregated at the Plan level. Net changes in unrealized appreciation/depreciation in investments represents the difference between the fair value of investments held at year-end and the cost of investments purchased in the current fiscal year or the fair value of investments held at the end of the preceding year.

***Participant Notes Receivable***

Participant notes receivable is recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on participant notes receivable is recorded when earned. Delinquent notes receivable from participants are recorded as a distribution based on upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when incurred.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Plan administrative expenses are paid by either the Plan Sponsor or the Plan, as provided in the Plan agreement. Fees paid by the Plan for certain administrative fees amounted to \$115,705 for the year ended December 31, 2024. Certain administrative expenses are paid by the Plan Sponsor. Most investment service fees are paid by the Plan and are offset against the related investment income.

***Reclassification***

The Plan determined that investments previously presented as Guaranteed Investment Account was more appropriately classified as Money Market Fund to conform with the Form 5500 reporting requirements. Accordingly, prior year amounts have been reclassified to conform to the current year presentation. This reclassification had no effect on the net assets available for benefits or the changes in net assets available for benefits as previously reported.

***Subsequent Events***

The Plan evaluated the impact of subsequent events through October 8, 2025, the date these financial statements were issued. Other than as disclosed below, there were no material subsequent events that required recognition or additional disclosure in these financial statements.

Subsequent to the 2024 Plan year-end, management identified an error related to a participant's profit sharing account that had been incorrectly forfeited during 2024 due to incomplete vesting data in the recordkeeping system. The participant was determined to be 100% vested, and in 2025 the Plan Sponsor plans to make a correction to restore the participant's account by reallocating approximately \$1,867 from the forfeiture account and contributing an additional \$317 to make the participant's account whole.

**3. Fair Value Measurements**

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

The Plan maximizes the use of observable inputs and minimizes the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the following fair value measurement.

- Level 1: quoted prices in active markets for identical assets or liabilities;
- Level 2: inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3: unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

- Mutual funds: Valued at the daily closing price as reported by the fund, which represents the net asset value (NAV) of shares held by the Plan at year-end (Level 1 inputs).
- Self-directed brokerage account: Accounts primarily consists of mutual funds and common stocks that are valued on the basis of readily determinable market prices (Level 1 inputs).

**4. Party-in-Interest Transactions**

The Plan invests in shares of mutual funds managed by Newport Trust Company, LLC ("Newport"). Newport acts as Trustee for only those investments as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules under ERISA. Fees incurred by the Plan for investment management services are included as a reduction of the return earned on each investment, as the fees are paid through revenue sharing, rather than paid as a direct payment. As described in Note 2, the Plan Sponsor made a direct payment to the third party administrator of \$54,025 for maintaining services related to the Plan, which was not covered by revenue sharing. The Plan Sponsor directly pays any other fees related to the Plan's operations.

**5. Information Certified by the Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Newport, the Custodian, a qualified institution, has certified that the following investment information included in the accompanying financial statements and supplemental schedule is complete and accurate: investments in the statements of net assets available for benefits as of December 31, 2024 and 2023; net appreciation in value of investments and interest and dividends in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and the investment information included in the supplemental Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

**6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**7. Plan Termination**

Although they have not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan at any time by resolution of its Trustees subject to the provisions of ERISA. In the event of Plan termination, the respective accounts of the participants under the Plan shall become fully vested and nonforfeitable.

**8. Prohibited Transactions**

There were no prohibited party-in-interest transactions during the year ended December 31, 2024.

**9. Tax Status**

The Plan is a volume submitter plan provided by the third party administrator. The third party administrator received a favorable determination letter from the Internal Revenue Service on June 30, 2020 indicating that the specimen document was designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). However, the determination did not constitute a determination of the qualification of an adopting plan sponsor. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The financial statement effects are recognized when the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
