## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Burpee Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Burpee Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

## **Basis for Opinion**

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**1. Description of Plan**

The following description of The Burpee Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General*

The Plan is a contributory defined contribution plan covering substantially all full-time, non-leased employees of W. Atlee Burpee Company and its subsidiaries (the “Company” or “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

*Eligibility*

An eligible employee becomes a participant in the Plan on the first day of the calendar month following 3 months of employment and having reached age 21. If the employee does not make an affirmative or negative election to participate, they will be automatically enrolled in the Plan at an initial period elective deferral of 6% of compensation, with their contributions invested in a designated fund until changed by the participant.

*Contributions*

Participants may contribute between 1% and 75% of annual compensation, as defined in the Plan. Participant-elected annual salary deferrals are limited to the maximum allowable under the Internal Revenue Code (“IRC”). Salary deferrals can be designated as on a portion of pretax compensation or designated as a Roth 401(k) contribution. The Company’s matching contribution, if any, shall be determined by the Company with respect to each plan year. The matching contribution, if any, is contributed to each eligible participant in accordance with an Internal Revenue Service acceptable nondiscriminatory formula. For the years ended December 31, 2024 and 2023, the Company matched 50% of the first 6% of the participant’s contributions. The Company may also make an annual discretionary profit-sharing contribution, which is allocated based on participant compensation. There were no discretionary profit-sharing contributions made during the years ended December 31, 2024 and 2023. Eligible rollover distributions, which may include Roth 401(k) contributions, from other qualified retirement plans may also be transferred into the Plan and retained as rollover contributions.

Participants direct the investment of all contributions into various investment options offered by the Plan and participant self-directed accounts and exercise investment control over the funds by appropriate direction to the trustee. Contributions are subject to certain limitations. Participants may change their deferral election at times (per pay period) throughout the year as defined in the plan document.

*Participant Accounts*

Each participant's account is credited with the participant's contribution, any rollover contributions, and allocations of (a) the Company's safe harbor contribution (b) the Company's discretionary profit-sharing contribution and (c) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting*

Participants are vested immediately and fully in their salary deferral account and rollover account regardless of the number of years of service. Employees are credited with a year of service for each plan year during which they have completed 12 months of service from their employment anniversary date.

The vested interest in the company matching and profit sharing contributions account is dependent upon the years of credited service, as follows:

*Notes Receivable from Participants*

Participants may borrow, from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at fixed rates. Principal and interest is paid ratably through payroll deductions over a period of up to five years, unless it is for the purchase of a participant's principal residence, in which the loan can be repaid over a period up to ten years. A participant may only have one loan outstanding at any time.

*Payment of Benefits*

On termination of service due to death, disability, retirement, or other reasons, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in their account. In addition, the Plan does allow for hardship distributions.

*Forfeiture Accounts*

Forfeited non-vested accounts totaled \$32,763 and \$141,270 at December 31, 2024 and 2023, respectively. These accounts are first used to pay administrative expenses under the Plan, then may be used to reduce future employer contributions. During the year ended December 31, 2024, no forfeited funds were used to pay administrative expenses and \$158,817 were utilized to reduce employer matching contributions under the Plan. During the year ended December 31, 2023, no forfeited funds were used to pay administrative expenses and \$84,625 were utilized to reduce employer matching contributions under the Plan.

**2. Summary of Accounting Policies**

*Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold, as well as held during the year.

**2. Summary of Accounting Policies (Continued)**

*Investment Fees*

Net investment returns reflect certain fees paid by the investment funds to their affiliated investment advisors, transfer agents, and others as further described in each fund prospectus or other published documents. These fees are deducted prior to allocation of the Plan's investment earnings activity and thus are not separately identifiable as an expense.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

*Benefit Payments*

Benefit payments to participants are recorded when paid.

*Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in net appreciation of fair value of investments.

**3. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosure*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Investments classified within Level 3 whose fair value measurements consider several inputs may include Level 1 and/or Level 2 inputs as components of the overall fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded

*Participant-directed brokerage accounts:* Valued at fair value based upon quoted prices.

*Common collective trust:* The common collective trust invests in a stable return fund which invests in investment contracts and security-backed contracts. The asset is valued at net asset value ("NAV") per unit as a practical expedient to measure fair value at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Information Certified by Trustee (Continued)**

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and the supplemental Schedule of Assets (Held at End of Year).

**5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

**6. Tax Status**

The Plan's prototype standardized profit-sharing plan document from Fidelity Investments has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the written form of the underlying prototype plan document is qualified under Section 401(a) of the Internal Revenue Code ("IRC") and that any employer adopting this form of the Plan may rely on the letter with respect to certain qualification issues. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, the accompanying financial statements do not include a provision for income taxes.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. Transactions with Parties in Interest**

Certain routine plan administrative expenses are incurred and/or paid by the plan sponsor. Certain Plan investments were shares of mutual funds managed by Fidelity Investments for the years ended December 31, 2024 and 2023. Fidelity Management Trust Company was the trustee of the Plan during 2024 and 2023; therefore, these investments qualify as party-in-interest transactions. Notes receivable from participants also qualify as exempt transactions with parties-in-interest. Other than the aforementioned, the Plan has no agreements or transactions with parties in interest.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**9. Subsequent Events**

Management has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued, and has determined that no material subsequent events exist that require recognition or disclosure.
