Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter – 2024 Supplemental Schedules Required by ERISA**

The supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Mountain View Child Care, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was originally established on January 1, 1998 and is a defined contribution plan covering all eligible employees of Mountain View Child Care, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Empower Trust Company, LLC and Empower Annuity Insurance Company of America (Empower) serve as the custodians and recordkeepers of the Plan.

Eligibility

Employees of the Company who are 21 and older of may participate in employee contributions match and any discretionary contributions after completing two months of service. Leased employees under Code Section 414(n), non-resident aliens, or any person covered by a collective bargaining agreement which does not specifically provide coverage of such employee are not eligible to participate in the Plan.

Expenses

Administrative expenses of the Plan are paid by the Company and by the Plan. Certain investment management fees and other charges are included in fund performance in the net appreciation in fair value of investments in the statement of changes in net assets available for plan benefits and are not, therefore, separately reflected as administrative expenses.

Contributions

Each year, participants may contribute a percent of annual compensation as defined in the Plan, not to exceed the maximum allowable amount as defined by the Internal Revenue Code (IRC). Participants may make pre-tax contributions and or Roth contributions to the Plan and participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make discretionary matching or discretionary profit sharing contributions for eligible participants.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Company's matching and discretionary contributions is earned at twenty percent per year beginning on the completion of a participants second year of service with full vesting on the completion of the participants sixth year.

Investment Options

Participants may direct all contributions as desired in any of several investment options offered by the Plan and may also utilize self-directed brokerage options. Participants may change their investment options daily.

**NOTE 1 – DESCRIPTION OF THE PLAN (Continued)**

Participant Accounts

An account is maintained for each participant. Each participant's account is credited with the participant's contributions, the Company's matching contributions, and allocations of (a) the Company's discretionary profit-sharing contributions and (b) Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances or compensation, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50 percent of their vested account balances. The loans are secured by the balance in the participant's account and bear interest at the prime interest rate plus two percentage points. Interest rates range from 4.25 percent to 10.5 percent on loans outstanding at the Plan year-end. Notes receivable from participants are repayable in equal monthly installments of principal and interest made through payroll deductions with a maximum of a five year term from the loan date, unless the loan is for the purchase of a participant's primary residence for which the maximum term is thirty years.

Payment of Benefits

A participant who attains normal retirement age of 55, or completes six years of service, or who retires because of disability shall have a vesting percentage of 100 percent. These participants shall be entitled to receive a distribution of the entire value of their participant's account as a single lump sum. Participants who terminate employment shall be entitled to a distribution of their vested accrued benefits in the same manner. If an active participant dies prior to attaining normal retirement age, their vesting percentage shall be 100 percent. Hardship distributions are available under the plan pursuant to IRC requirements. The Plan may elect to distribute accounts of terminated participants with an aggregate value of \$5,000 or less if the participant has not made an election to distribute their balance.

Plan Termination

Although the Company has not expressed any intent to do so, it has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$53,186 and \$26,532, respectively. These accounts will be used to reduce future Company contributions or to pay plan administrative expenses. During the year ended December 31, 2024, the Plan used \$2,717 of forfeitures to pay administrative expenses.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold as well as held during the year.

Management fees charged to the Plan for investments in registered investment companies (mutual funds) and collective trust funds are based on assets invested and are deducted on a daily basis. Management fees are reflected as a reduction of investment return for such investments.

The Plan maintains a fully benefit-responsive investment contract with Empower, the EI Fixed Account. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. For the year ended December 31, 2024 and 2023 the crediting rate of the EI Fixed Account was 1.41% and 1.23%, respectively.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero. The interest crediting rate is reset quarterly.

Investment Valuation and Income Recognition

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. Fair value of the investment contract prior to contract termination equals the contract value as presented in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded as a deemed distribution. Delinquent participant loans are reclassified as deemed distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Expenses incurred for administering the Plan, if not paid by the Company, are paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) No. 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC No. 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Registered investment companies (mutual funds):* Valued at the net asset value (NAV) of shares held by the Plan at year-end.

*Collective trust funds:* Valued at the NAV of units of a collective trust fund. The value is computed based on fair value of underlying assets owned by the fund, minus its liabilities, then divided by the number of units outstanding. The value is computed daily, with redemption transacted at the day's computed NAV. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The funds can be redeemed daily, there are no restrictions or penalties on redemption and there are no unfunded commitments. The collective trust funds are not required to be reported in the fair value hierarchy due to the fact that they utilize NAV as a practical expedient to report fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The custodian also certified to the completeness and accuracy of \$530,708 of net appreciation in fair value of investments, \$240,967 of interest and dividend income related to the aforementioned investments, and interest income on participant notes receivable of \$19,545 for the year ended December 31, 2024.

**NOTE 5 – TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by letter that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

**NOTE 6 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Empower. Empower is the custodian and recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Certain fees are not paid directly by the Plan but rather reduce the amount of investment earnings allocated to individual participant accounts. Fees for recordkeeping services, the administration of loans and distributions are paid by the Plan to the recordkeeper, Empower. Notes receivable from participants and the related interest income are also considered related party transactions. Fees paid by the Plan to Empower for the Investment management and recordkeeping services amounted to \$46,234 for the year ended December 31, 2024.

In addition parties-in-interest were paid by the Plan for investment advisory services of \$18,562 and contract administrations services of \$8,457 were provided by Monarch Corporate Advisors, Inc and Ascensus Holdings, Inc., respectively.

**NOTE 8 – SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.
