Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Indeck Energy Services, Inc. and Affiliated Employers 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

1. Description of the Plan

The following description of the Indeck Energy Services, Inc. and Affiliated Employers 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Indeck Energy Services, Inc. (the Company or Employer) and its subsidiaries who have completed three months of employment with a minimum of 250 hours of service, have attained the age of 21, and are not part of a collective-bargaining agreement, as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Company's subsidiaries included under the Plan are as follows:

- Indeck Energy Services, Inc.
- Indeck Power Equipment, Inc.
- Indeck Keystone, Inc.
- Indeck Energy - Ladysmith, LLC.
- AEL Financial, LLC.

The Plan is administered by the Indeck Energy Services, Inc. 401(k) Plan Committee (the Committee) that serves at the discretion of the Company's Board of Directors. The Committee is responsible for all matters, including, but not limited to, determining eligibility, rights to benefits, interpreting Plan documents, and directing the Plan's trustee and contract holder, Voya Institutional Trust Company (the Trustee) and Voya Retirement Insurance and Annuity Company, respectively.

Contributions

Each year, participants may contribute up to the maximum allowed under the Internal Revenue Code (IRC) limitations of their pretax annual compensation, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company may elect to make discretionary employer matching contributions to the Plan in an amount determined by the Company. For the Plan year ended December 31, 2024, the Company matched \$0.50 for every \$1.00 up to the first 6% of compensation that participants contributed to the Plan. For the year ended December 31, 2024, the Company made discretionary employer matching contributions totaling \$234,222.

Additional discretionary profit-sharing contributions may be contributed at the option of the Company's Board of Directors. Participants must have worked at least 1,000 hours during the Plan year and be employed on the last day of the Plan year in order to receive an allocation of any discretionary profit-sharing contributions. For the year ended December 31, 2024, the Company did not elect to make any discretionary profit-sharing contributions to the Plan.

Contributions are subject to certain IRC limitations.

Participants may direct all their contributions among one or more funds offered in the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to the Plan provisions.

Participant Accounts

Each participant's account is credited with the participant's contributions and any discretionary matching contributions, as well as allocations of (a) any additional discretionary profit-sharing contributions, and (b) Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at prime rate, as published in *The Wall Street Journal* on the day of the loan request, plus 1%. Interest rates on outstanding loans at December 31, 2024 range from 4.25% to 9.50%. Principal and interest are repaid ratably through bi-weekly payroll deductions over a period of five years or less, unless the loan is used for the purchase of a primary residence, in which case the term may be up to 20 years.

Payment of Benefits

Upon termination of service, death, disability, retirement, or attainment of age 59½, a participant will receive their benefits as a lump-sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan document.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company discretionary matching and discretionary profit-sharing contribution portion of their accounts plus actual earnings thereon is based on a graduated scale of 20% per year after two years of service. Participants are fully vested after six years of service. A participant must work a minimum of 1,000 hours a year of credited service to earn a year of vesting in the Company contribution portion of their accounts. Participants become fully vested in their accounts upon death or disability.

Forfeited Accounts

At December 31, 2024 and 2023, forfeitures were \$5,574 and \$51,079, respectively. Forfeited non-vested amounts attributable to Company contributions can be used at the Company's discretion to: (1) reduce future Company contributions, (2) pay the administrative expenses of the Plan, or (3) be allocated to participant accounts as defined in the Plan. Forfeitures used to pay Plan expenses were \$12,000 and \$24,692 at December 31, 2024 and 2023, respectively. There were \$55,248 of forfeitures used to reduce employer contributions for the year ended December 31, 2024.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value with the exception of fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and the Trustee. See Note 3 for a discussion of fair value measurements.

The Plan's fully benefit-responsive investment contract is valued at contract value. See Note 4 for further discussion.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and requests for distributions are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in net appreciation in fair value of investments.

Risks and Uncertainties

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks, such as interest risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodology used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Registered Investment Companies - These assets are valued at the daily closing prices, as reported by the fund. Registered investment companies held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with the other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Investments in Fully Benefit-Responsive Investment Contracts

The Plan held an interest in a fully benefit-responsive fixed-income account with the contract holder for the years ended December 31, 2024 and 2023. These investments are valued at contract value, as reported to the Plan by the contract holder.

Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. Because the fixed-income accounts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits. Participant transactions (purchases and sales) may occur daily. All other withdrawals of assets may be delayed for up to 12 months at the sole discretion of the Trustee. The guaranteed investment contract issuer is contractually obligated to repay the principal and interest based on a specified interest rate that is guaranteed to the Plan.

The contract value of the fixed-income accounts at December 31, 2024 and 2023 was \$1,911,581 and \$3,255,472, respectively. The guaranteed minimum interest rate for the Voya Fixed Account as of December 31, 2024 was 3%. The guaranteed minimum interest rate for the Voya Fixed Account (4062) as of December 31, 2024 was 1%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include amendments to the Plan documents. In the event a Plan amendment adversely affects the contract and/or changes the Plan's administrative practices in a way that would increase the amount of payments the Company would have to make under the contract, or reduce the interval between such payments, the Company will be obligated to make only the payments that would have been made if the amendment and/or change in administrative practices had not been made.

5. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company, a qualified institution.

6. Tax Status

The Plan adopted a pre-approved plan from FIS Business Systems LLC, which received an opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, stating that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by the Trustee and Voya Retirement Insurance and Annuity Company, the contract holder; therefore, these transactions qualify as party-in-interest transactions. Certain employees of the Company provide administrative services to the Plan. Employees are not paid by the Plan for their service.

Additionally, the Plan issues loans to participants, which are secured by the participants' account balances. These transactions qualify as party-in-interest transactions.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contribution portion of their account.

9. Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, which is the date these financial statements were available to be issued, and there were no material subsequent events that required recognition or additional disclosures in these statements.
