Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

December 31, 2024 and 2023

1. Description of Plan

The following description of the Pride Tree Holdings, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

On January 1, 2009 the Direct Brands 401(k) Savings Plan was created by the Plan sponsor Direct Brands, Inc. (the Company). Effective October 17, 2014, the Plan was amended and renamed from the Direct Brands 401(k) Savings Plan to the Pride Tree Holdings, Inc. 401(k) Savings Plan.

The Plan is a defined contribution plan sponsored by the Company covering all employees of the Company. These employees are immediately eligible to participate in the Plan upon being hired by the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In April 2020, the Company amended the Plan to allow coronavirus-related distributions to the affected participants of up to \$100,000 from all sources, which are to be repaid to the Plan during the three-year period after the distribution is received. The Plan was amended to increase the maximum qualified plan loan amount from (i) the lesser of \$50,000 or 50% of the affected participant's vested account balance to (ii) the lesser of \$100,000 or 100% of the affected participant's vested account balance.

Effective January 1, 2021, the employees of Book of the Month LLC, an affiliate of the Company, became eligible to participate in the Plan.

Effective April 1, 2023, the employees of The Quick Brown Fox & Company LLC, an affiliate of the Company, became eligible to participate in the Plan.

Contributions

Participants may contribute between 1% and 75% of their pretax annual compensation subject to limitations by the requirements of the Internal Revenue Code (\$23,000 and \$22,500 for years ended December 31, 2024 and 2023, respectively). Participants may also make ROTH 401(k) after-tax contributions to the Plan. Participants who have attained the age of 50 before the close of the Plan year may also make an additional contribution of \$7,500 for the years ended December 31, 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans under the rollover provisions.

1. Description of Plan (continued)

Contributions (continued)

Participants may change their salary deferral percentage at any time. Participants may also change their investment options or cease contributing to the Plan at any time and participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a stable value fund and mutual funds as investment options.

In May 2019, the Company reinstated employer contributions retroactive back to January 1, 2019. The Company matches \$0.50 for every \$1.00 of employee deferrals up to a maximum of 4% per employee. Employer contributions that the Company makes on behalf of the participants are directed pro-rata to the same investment options as the employee contributions. Contributions are subject to certain limitations, as defined in the Plan agreement. Employees must complete one year of employment to qualify for the employer contribution match.

Effective January 1, 2022, the Company began making discretionary matching contributions based on the following: One-year tenure entitles a 50% employer match of the first 4% of employee contributions, up to 2% of the total employee contribution; two-year tenure entitles a 100% employer match of the first 4% of employee contributions, up to 4% of the total employee contribution; and three-year tenure entitles a 100% employer match of the first 6% of employee contributions, up to 6% of the total employee contribution.

Participant Accounts

All employer and participant contributions to the Plan are invested in accordance with investment elections specified by each participant. Each participant's account is credited or charged with the participant's contribution and allocations of the Company's contribution, Plan earnings or losses, and Plan expenses. Allocations are based on participant earnings or account balances, as defined.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon and the Company's matching contributions plus actual earnings thereon.

1. Description of Plan (continued)

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior twelve-month period. Participants may only have one loan outstanding at any given time. Loan terms range from one to five years or, if earlier, by the participant's normal retirement date. Loans for the purchase of a primary residence may be repaid over a reasonable period which may exceed five years, provided that such repayment does not exceed beyond the participants retirement date. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan Administrator. The interest rate on the loan outstanding as of December 31, 2024 is 9.5%. Principal and interest is paid ratably through payroll deductions.

Payments of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant at age 59 ½ or older may receive the value of the vested interest in his or her account as a lump-sum distribution.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with U.S. generally accepted accounting principles.

Use of Estimates

The preparation of the Plan's financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting periods and, when applicable, disclosure of contingent assets and liabilities at the dates of the financial statements. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Risks and Uncertainties

The Plan provides for various investment options in any combination of mutual funds and the common collective trust with various investment objectives. Investment securities, including mutual funds, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Shares of mutual funds are valued at quoted market prices. Participant loans are valued at cost which approximates fair value.

The Plan's investment in the stable value fund is measured using the NAV per share of the investment as a practical expedient as permitted by Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement and Disclosures*.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of both realized and unrealized gains (losses) on these investments.

Purchases and sales of securities are recorded on a trade-date basis at the average cost of the security. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Fair Value Measurements

The Plan follows ASC 820 for all financial assets and liabilities and nonfinancial assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring basis. ASC 820 defines fair value, establishes a fair value hierarchy, and expands disclosures about fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Fair Value Measurements (continued)

The three levels of the fair value hierarchy are described below:

- Level 1 Inputs are based upon unadjusted quoted prices for identical instruments traded in active markets.

- Level 2 Inputs are based on quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

- Level 3 Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability. The fair values are therefore determined using model-based techniques that include option pricing models, discounted cash flow models, and similar techniques.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Payments of Benefits

Benefits are recorded when they have been approved for payment and paid by the Plan.

Administrative Expenses

The Plan pays for certain investment administrative fees. The Company pays for all other administrative expenses of the Plan.

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan certified to the Plan Administrator the following information related to their respective investments as complete and accurate, which has been relied on by the Plan Administrator in the preparation of the Plan's financial statements in compliance with ERISA:

(a) Investments

The cost and fair value of investments, in the aggregate and by fund, at December 31, 2024 and 2023.

(b) Interest and Dividend Income

The amount of interest and dividend income received by the Plan for the years ended December 31, 2024 and 2023.

(c) Net Appreciation/Depreciation

The amount of net appreciation/depreciation in the fair value of investments, individual and in the aggregate, for the years ended December 31, 2024 and 2023.

(d) Notes Receivable from Participants

The amount of notes receivable from participants plus any accrued but unpaid interest as of December 31, 2024 and 2023.

(e) Investment Transactions

All purchases and sales of investments for the years ended December 31, 2024 and 2023, including the gain or loss on sales.

Fidelity Management Trust Company is also the trustee and record keeper of the Plan and, therefore, notes receivable from participants, interest on loans, administrative expenses paid by the Company, and transactions with Fidelity Management Trust Company qualify as party-in-interest transactions.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Tax Status

The Company has not received a determination letter on its adoption of the Fidelity prototype plan. In accordance with Revenue Procedure 2005-16, the Company has chosen to rely on the advisory opinion letter dated March 31, 2014. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.
