Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan of Community Access Services, Inc. Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of 403(b) Thrift Plan of Community Access Services, Inc. Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of 403(b)

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE A – DESCRIPTION OF PLAN

The following description of the 403(b) Thrift Plan of Community Access Services, Inc. (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a 403(b) defined contribution plan covering substantially all employees of Community Access Services, Inc. (the Company), as defined in the Plan document. The Plan has an effective date of January 1, 2009. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended ("ERISA"). Community Access Services, Inc. is the Plan's sponsor and serves as the plan administrator. The custodian of the Plan is Mutual of America Life Insurance Company (Mutual of America). All participant account balances are held by Mutual of America.

Eligibility

Employees of the Company are eligible to participate in the Plan on the first day of employment. Employees are eligible to receive employer contributions after two years of service (the Plan defines a year of service as having worked 1,000 hours within a 12 month period).

Contributions

Employee salary deferral contributions are made voluntarily, subject to certain limits set by the Internal Revenue Code (IRC). A participant may elect to contribute up to the maximum allowed by the IRS. The Company makes contributions of 3% of eligible compensation for participants who have satisfied the two years of service eligibility requirement. Contributions are made to the Plan each pay period. Participants are allowed to make rollover contributions to the Plan from an individual retirement account or annuity.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions and an allocation of plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants are responsible for directing the investment of their contributions and the employer contributions into various investment options offered by the Plan and may change their directive at any time.

Vesting

Participants are immediately vested in their participant and employer contributions plus actual earnings thereon.

NOTE A – DESCRIPTION OF PLAN, continued

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or various forms of periodic payments as provided in the Plan agreement. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Hardship distributions are available only for the purpose of meeting immediate and heavy financial needs.

Participant Loans

Participants may pledge their vested account balances as collateral in order to secure a loan from Mutual of America. Under this arrangement, the loan is between the Plan participant and Mutual of America, and no amounts are withdrawn from Plan assets. Participants are required to maintain an amount equal to 120 percent of the original loan principal balance in Mutual of America's Interest Accumulation Account while the loan is outstanding. Loan terms range from one to five years, or up to ten years for the purchase of a primary residence. The minimum loan is \$1,000 and the maximum loan is the lesser of \$50,000 less the highest outstanding loan balance during the one year period prior to the new loan application date, or 50 percent of the participant's vested account balance, less any current outstanding loan balance. Principal and interest are paid ratably through payroll deductions. At December 31, 2024 and 2023, total assets pledged as collateral for participant loans were \$137,297 and \$147,109, respectively.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan follows the fair value measurement and disclosure requirements of Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, which defines fair value as the exchange price that would be received for the asset or paid to transfer a liability in principal or most advantageous market for the asset or liability.

Investment purchases and sales are accounted for on a trade date basis. Net appreciation in the fair value of investments includes both realized and unrealized gains and losses. Interest income is recorded as earned. Dividend income is recorded on the ex-dividend date.

Risks and Uncertainties

The Plan assets are invested in a variety of investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses related to the Plan are paid by the Company. Certain administrative expenses are paid from Plan assets and deducted from participant accounts in accordance with the Plan document.

Tax Status

The Plan has been designed to comply with the applicable requirements of Section 403(b) of the Internal Revenue Code (IRC). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (IRS). The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b). Management is not aware of any events that have occurred that might adversely affect the Plan from obtaining a qualified status.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE C – CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mutual of America, the custodian of the Plan.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts

Valued at the net asset value per unit as provided by the custodian of the Plan. Net asset values per unit are derived from values of similar investments that have quoted prices in active markets. The net asset value is used as a practical expedient to estimate the fair value, and is based on the fair value of the underlying investments less liabilities.

Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate accounts, the custodian reserves the right to temporarily delay withdrawal from the Plan in order to ensure securities liquidations are carried out in an orderly business manner. Investments valued at the net asset value per unit practical expedient are not subject to the fair value hierarchy defined above.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The investment objective for the pooled separate accounts is to lower the costs to investors through economies of scale available by combining the assets of multiple investors, to provide daily liquidity, and to provide better diversification. Each investor owns a participating interest that is calculated in units and represents its portion of the holdings of the fund.

NOTE E – INTEREST ACCUMULATION ACCOUNT

The Plan has entered into an interest accumulation account with Mutual of America. Mutual of America maintains contributions to this account in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The interest accumulation account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The interest accumulation account is carried at cost plus accrued interest.

Mutual of America has informed the Plan Administrator that they believe the interest accumulation account is comparable to a cash equivalent, as investments held in the contract are completely liquid, the value provided to the Plan is the redeemable value of the fund, and there are no deferred sales charges, load assessments, or interest rate adjustments that would affect the value as a result of a withdrawal request. The value of the interest accumulation account at December 31, 2024 and 2023 was \$984,976 and \$754,134, respectively. The Plan Administrator believes this investment is not subject to the fair value measurement requirements.

NOTE F – PLAN TERMINATION

Although it has not expressed any intent to do so, Community Access Services, Inc. has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE G – TRANSACTIONS WITH PARTIES IN INTEREREST

Certain Plan investments are sponsored or managed by Mutual of America. Mutual of America is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing rather than direct payment.

The Company is the Plan Sponsor and pays for certain administrative costs, including accounting, legal, and consulting fees on behalf of the Plan. These transactions qualify as party-in-interest transactions.

Participants in the Plan are permitted to pledge funds from their vested account balances for collateral to obtain loans from Mutual of America. These transactions qualify as party-in-interest transactions.

NOTE H – RECONCILIATION OF FINANCIAL STATEMENTS TO THE FORM 5500

As described in Note A, Plan loans are between the participant and Mutual of America, with the participant pledging funds from their account as collateral. For financial statement purposes, the portion of the participant's account balance representing collateral is included with the interest accumulation account in the statements of net assets available for benefits.

For Form 5500 purposes, the outstanding principal balance of the Plan loans between the participant and Mutual of America has been shown as a participant loan on Schedule H.

NOTE I – SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued, noting no matters that should be disclosed.
