1. Description of Plan

The following description of the Vintage Stock Safe Harbor 401(k) Plan, (Plan), sponsored by Vintage Stock, Inc. (Company), provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Vintage Stock, Inc. (the Plan Sponsor) and the following affiliates: Live Ventures Inc.; Marquis Industries, Inc; and Appliance Smart. Employees who are age 21 or older are eligible to make elective deferrals to the Plan and receive Company contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustees are responsible for oversight of the Plan.

Contributions: Each year, participants may contribute up to 100% of their annual wages, subject to certain IRS limitations, as defined in the Plan through pre-tax contributions or as after-tax Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes safe-harbor matching contributions equal to 100% of the first 4% of the participant's compensation which is deferred as a salary reduction.

Participant accounts: Each participant's account is credited with (a) the participant's contribution, (b) the Company's safe-harbor matching contribution, and (c) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Net income and asset revaluation are allocated to each participant based upon the earnings of the investments selected by the participant. These are allocated based upon the participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately 100% vested in their elective deferral contributions and safe harbor matching contributions plus actual earnings thereon.

Payment of benefits: A distribution of a participant's vested account balance can be made due to hardship, attainment of age 59.5, death, disability, retirement, qualified military service, when required by law, or upon termination of service with the Company. A distribution of a participant's rollover balance can be made at any time regardless of the limitations described above.

Upon termination of service, a participant is eligible to receive a lump-sum amount equal to the participant's interest in his or her account. Participants who terminated service and have reached 65 years of age will receive an automatic distribution of their vested balance.

2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are presented in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

Accounting estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits: Benefits are recorded when paid.

Subsequent events: Management has evaluated subsequent events between the end of the most recent fiscal year end and October 10, 2025, the date the financials statements were available to be issued.

3. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. Certified Information

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company, a qualified institution.

5. Related-Party Transactions & Party-In-Interest Transactions

The Plan holds investments in funds managed by the Plan's asset custodian, John Hancock Life Insurance Company. Investments in John Hancock Life Insurance Company funds totaled \$4,948,664 and \$4,560,121 at December 31, 2024 and 2023, respectively.

During years ended December 31, 2024 and 2023, fees of \$26,755 and \$25,281 were paid to John Hancock Life Insurance Company, respectively. These fees are included on the related statements of changes in net assets available for benefits with other administrative and investment expenses.

A portion of the administrative costs of the Plan are paid by the Company. Certain employees of the Company serve as the Plan's administrator and trustees. They do not receive any compensation for services rendered to the Plan.

6. Tax Status

The prototype plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended and restated since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. A tax liability would be recognized if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets and liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means;
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Group annuity pooled separate accounts (PSAs): Valued at the net asset value of the units held by the group annuity contract provider using the quoted net asset value of the shares of the underlying mutual funds adjusted for any dividends or distributions received by John Hancock Life Insurance Company and the daily equivalent of any fee charged pursuant to the contract. Mutual funds are registered with the Securities and Exchange Commission and are carried at the net asset value at which the mutual fund shares are actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
