### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Roland DGA 401(k) Plan and Investment Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the "financial statements").



**Notes to Financial Statements**

**December 31, 2024**

**1. Description of the Plan**

The following description of the Roland DGA Corporation 401(k) Savings and Investment Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General*

The Plan was established on January 1, 2003 and is a qualified, defined contribution plan established under the provisions of Section 401(k) of the Internal Revenue Code (“IRC”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan is sponsored by Roland DGA Corporation (the “Company”), who also serves as the Plan Administrator. Empower Trust Company, LLC (the “Trustee”) is the custodian and trustee of the Plan’s investment assets (Note 4).

*Eligibility*

The Plan covers all current employees of the Company. Employees become eligible after 90 days of employment with the Company.

*Contributions*

Participants may contribute up to the maximum dollar limit as defined by the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company may elect to make an annual discretionary matching contribution, up to a maximum of 50% the first 6% of the participant’s contribution, as defined by the Plan agreement. In addition, the Company, at its discretion, may make additional nonelective contributions. No nonelective contributions were made in 2024.

*Participant Accounts*

An account is maintained for each participant and credited with the participant’s contributions and the allocation of any investment income or losses. Investment income and losses are allocated among eligible participants in the ratio which the dollar value of the respective participant’s interest in the specific investment bears to the dollar value of all participant’s interests in that investment.

**1. Description of the Plan (continued)**

*Vesting*

Participants are immediately vested in their voluntary contributions, plus actual investment income and losses thereon. Vesting in the Company's matching and nonelective contributions occurs ratably at 25% per year over four years of service.

*Investment Options*

Upon enrollment in the Plan, a participant may direct his or her account into any of the investment options offered by the Plan. Participants may change or transfer their investment options daily.

*Payment of Benefits*

Upon termination of service due to death, disability, retirement, or other reasons, a participant or the participant's beneficiaries may receive the vested interest in the participant's account in a lump-sum distribution or rollover the value of the vested interest into another qualified benefit plan, less any loans outstanding. Account withdrawals are permitted by participants who suffer certain financial hardships and meet criteria established by the IRC.

*Notes Receivable from Participants*

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum of 50% of their vested account balance. Participants may never borrow more than \$50,000 minus the highest outstanding balance of their total Plan loans during the last 12 months. Notes receivable from participants are stated at their unpaid principal balance and are secured by the balance in the participant's account. Principal and interest are paid ratably through regular payroll deductions. All notes receivable must be repaid over a five-year period unless it is for the purchase of a principal residence. Interest on notes receivable from participants ranged from 4.25% to 9.50% as of December 31, 2024. For the year ended December 31, 2024, defaulted loans totaled \$39,288 resulting in a decrease to notes receivable from participants as of December 31, 2024.

**1. Description of the Plan (continued)**

*Administrative and Advisory Fees*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative and advisory fees. Fees paid by the Plan for investment management services during 2024 were included as a reduction of investment return on the related investment. Based upon the Company's discretion, additional costs of administering the Plan, including accounting and legal fees, are either paid by the Company or paid through forfeitures. Expenses that are paid by the Company are excluded from these financial statements.

*Forfeited Accounts*

At December 31, 2024, forfeited accounts totaled \$7,925 (\$2,022 at December 31, 2023). Under the Plan agreement, as amended, these amounts can be used to pay Plan administrative and advisory fees. Any remaining forfeitures can be used to reduce the Company's nonelective or matching contributions.

*Plan Termination*

It is the intention of the Company to maintain the Plan throughout its corporate existence. Nevertheless, the Company reserves the right, at any time, to discontinue or terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**2. Summary of Significant Accounting Policies**

*Basis of Presentation*

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**2. Summary of Significant Accounting Policies (continued)**

*Use of Estimates*

The preparation of financial statements in conformity with GAAP requires the Plan's administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting periods. Accordingly, actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

The Plan's investments are governed by a trust agreement with the Trustee. The Plan's mutual funds and pooled separate account investments are stated at fair value. Investments in pooled separate accounts ("PSAs") are valued on a net asset value ("NAV") per share basis. The PSAs are credited with earnings on the underlying investments and charged for Plan benefits paid and deductions for investment expenses and annual management fees. Redemptions may occur on a daily basis.

The Plan invests in a guaranteed income fund ("GIF") which is reported at contract value. Contract value reflects the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan and is the relevant measure for the portion of assets attributable to the fully benefit-responsive guaranteed income fund.

Investment income consists of interest earned and realized, and unrealized gains or losses in the fair value of investments, less investment expenses. Purchases and sales of securities are reflected on the settlement date. Dividends are recorded on the ex-dividend date.

*Benefit Payments*

In accordance with ERISA reporting requirements, benefit payments due to participants who have elected to withdraw from the Plan are recorded when paid.

*Subsequent Events*

The Plan Administrator evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

**3. Investments**

The Plan accounts for financial assets and liabilities that are being measured and reported at fair value on a recurring and non-recurring basis in accordance with Accounting Standards Codification (“ASC”) 820 Fair Value Measurements and Disclosures. ASC 820 defines fair value as the price that the Plan would receive to sell an asset, or pay to transfer a liability, in an orderly transaction between market participants at the measurement date. ASC 820 also establishes a framework for measuring fair value, and a three-level hierarchy for fair value measurements based upon the transparency of inputs to the valuation of an asset or liability. Inputs may be observable or unobservable and refer broadly to the assumptions that market participants would use in pricing the asset or liability. Observable inputs reflect the assumptions market participants would use in pricing the asset or liability based on market data obtained from sources independent of the reporting entity.

Unobservable inputs reflect the reporting entity’s own assumptions about the assumptions that market participants would use in pricing the asset or liability developed based on the best information available under the circumstances. The Plan’s investments are assigned a level based upon the observability of the inputs which are significant to the overall valuation. The three-tier hierarchy of inputs is summarized below.

Level 1: Valuation for assets and liabilities traded in active exchange markets. Valuations are obtained from readily available pricing sources for market transactions involving identical assets or liabilities.

Level 2: Valuations for assets and liabilities traded in less active dealer or broker markets. Valuations are obtained from third party pricing services for identical or comparable assets or liabilities.

Level 3: Valuations for assets and liabilities that are derived from other valuation methodologies, including option pricing models, discounted cash flow models, and similar techniques, and not based on market exchange, dealer, or broker traded transactions. These valuations incorporate certain assumptions and projections in determining the fair value assigned to such assets or liabilities.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Investments in PSAs are valued using the NAV as of the reporting date, which is the basis for current transactions. The NAV is used as a practical expedient to estimate fair value. PSAs are valued based on the underlying investments (i.e., common stock, mutual funds, and short-term securities) in the separate account as reported by the Trustee. While the majority of the underlying asset values are based on quoted prices, NAV of the PSAs are not publicly quoted. The NAV is reported by the Trustee as of the financial statement date based on recent transaction prices. The PSAs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. Investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been categorized in the fair value hierarchy.

The Plan is a party to a fully benefit-responsive guaranteed income fund with the Trustee. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed income fund issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the guaranteed income fund is fully benefit-responsive, contract value is the relevant measurement for that portion of the net assets available for plan benefits attributable to the guaranteed income fund. The guaranteed income fund is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by the Trustee, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**4. Information Certified by Trustee**

The Plan has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, as shown in the Statements of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, and as summarized in the tables in Note 3 of these financial statements.
- Outstanding plan participant loan balances as of December 31, 2024 and 2023.
- Investment transactions as shown in the Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024.
- Schedule H, Line 4i – Schedule of Assets (Held at End of Year), Supplemental Schedule.

**5. Income Tax Status**

The Plan was created from a plan instrument drafted by a service provider. The Internal Revenue Service (“IRS”) has determined and informed this service provider by a letter dated September 16, 2022, that the plan instrument, as originally written by the service provider, was subjected to IRS review and has been designed in accordance with applicable sections of the IRC and is, therefore, exempt from federal income taxes.

**6. Related Party and Party-In-Interest Transactions**

During the year ended December 31, 2024, certain administrative functions were performed by officers or employees of the Company and the Plan did not compensate such individuals for their services. Also, as discussed in Note 1, the Company pays certain costs of administering the Plan.

The Plan investments are managed by the Trustee, and therefore, they qualify as “party-in-interest” transactions, which are permitted by Department of Labor’s Rules and Regulations. Notes receivable from participants and the related interest income are also considered party-in-interest.

**7. Accounting for Uncertainty in Income Taxes**

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Risks and Uncertainties**

The Plan, as directed by participants, invests in investment securities that may be selected by the participant in any combination. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes would materially affect participant’s account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits and the Statement of Changes in Net Assets Available for Plan Benefits.
