Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Daaquam Lumber Maine Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation), and the related statement of changes in net assets available for benefits for the year ended (in liquidation), and the statement of net assets available for benefits (modified cash basis) as of December 31, 2023 (ongoing) and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the liquidation and modified cash basis of accounting as described in Note 2.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan termination and Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. As discussed in Note 6, the plan sponsor approved a resolution to terminate the Plan on December 30, 2024, and Plan management determined liquidation was imminent. As a result, the Plan changed its basis of accounting from the modified basis used in presenting the 2023 statements to the liquidation basis used in presenting the 2024 financial statements. The statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended and the supplemental schedule were prepared on the liquidation basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. The statement of net assets available for benefits as of December 31, 2023, was prepared on the modified cash basis of accounting, which is also a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the liquidation and modified cash bases of accounting described in Note 2, and for determining that the liquidation and modified cash bases of accounting are acceptable bases for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Daaquam Lumber Maine Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal controls relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the liquidation and modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the liquidation and modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental Schedule H, Line 4i (liquidation basis) Schedule of Assets (Held at End of Year) for December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

(1) DESCRIPTION OF THE PLAN

The following description of the Daaquam Lumber Maine Inc. 401(k) Plan (the "Plan") provides general information only. Participants should refer to the Plan document for more complete information.

- a. **GENERAL** - The Plan is a defined contribution savings plan sponsored by Daaquam Lumber Maine Inc. (the "Company") and is subject to the Employee Retirement Income Security Act of 1974 ("ERISA"). The plan adopted the Fidelity Basic Plan Document No. 17.
- b. **ELIGIBILITY** - All employees of the Company who have attained the age of eighteen and have three months of service are eligible for participation, except summer employees who must have attained the age of 21 and have 1,000 hours of service. After ninety days of employment, unless an eligible employee elects otherwise, they will be automatically enrolled into the Plan. The employee's elective contribution will be set at 5% of compensation and invested in a Fidelity Freedom Fund having a target retirement date closest to the year that they will turn age 65.
- c. **EMPLOYEE CONTRIBUTIONS** - Participants may elect to contribute to the Plan up to 50% of annual compensation on a pre-tax basis. Participants are also eligible to designate some or all of their deferral contributions as a Roth deferral contribution. Combined pre-tax and Roth deferral amounts are not to exceed \$23,000 and \$22,500 for the years ended December 31, 2024, and 2023, respectively. Additionally, participants may contribute rollover amounts representing distributions from other qualified defined benefit or defined contribution plans and those participants who have attained age 50 or older during a plan year may make "catch-up" contributions not to exceed \$7,500 for 2024 and 2023, in excess of the above limits.
- d. **EMPLOYER CONTRIBUTIONS** - The Company contributes a matching contribution based on a participant's pre-tax contributions (excluding catch-up contributions). The non-discretionary matching contribution was 50% of the employee's elective contribution up to 5% of compensation until August 7, 2021, when the match changed to discretionary and increased to 100% of the employee's elective contribution up to 5% of compensation deferred. Total contributions to a participant account cannot exceed the lesser of compensation or \$69,000 and \$66,000 in 2024 and 2023, respectively.
- e. **PARTICIPANT ACCOUNTS** - Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution (if any) and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- f. **VESTING** - Participants are immediately 100% vested in their contributions plus actual earnings thereon. Full vesting in the Company contributions, plus actual earnings thereon occurs after the participant has completed one year of service.

(1) DESCRIPTION OF THE PLAN (cont'd.)

- g. **NOTES RECEIVABLE FROM PARTICIPANTS** - Loans are permitted under the Plan at an amount not to exceed the lesser of \$50,000 or 50% of the vested portion of the participant's account balance. The minimum loan amount is \$1,000. The loans are collateralized by the participant's account and are repaid over a five-year period (10 years for a personal residence) through weekly payroll deductions. These loans bear interest at prevailing interest rates charged by institutions in the business of lending money for loans which would be made under similar circumstances. The interest rate remains fixed for the duration of the loan.
- h. **PAYMENTS OF BENEFITS** - Upon normal retirement, disability or death, or other means of termination of employment, the vested balance in the participant's account is paid to the participant or his or her beneficiaries in a method allowable under the Plan. Required minimum distributions (RMD) begin at age 73.
- i. **IN-SERVICE DISTRIBUTIONS** - A participant who reaches age 59 ½ may withdraw his or her vested balance (reduced by the outstanding loan balance of any loans made to the participant from such account) at any time. Any participant may withdraw his or her rollover contributions at any time.
- j. **HARDSHIP WITHDRAWALS** - A participant may withdraw from his or her elective deferral contributions account, and matching accounts, to satisfy an immediate and heavy financial need as defined by the Plan and subject to Internal Revenue Service (IRS) and 401(k) regulations (hardship distribution). Hardship distributions totaled \$20,261 in 2024 and \$16,483 in 2023.
- k. **FORFEITED ACCOUNTS** - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$50 and \$15,035, respectively. Plan expenses of \$25,181 and \$6,699, were paid from the forfeiture account during the years ended December 31, 2024, and 2023, respectively.

(2) SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying 2023 statement of net assets available for benefits was prepared on the modified cash basis of accounting. On the modified cash basis, investments are recorded at fair value and receivables are not recorded for participant contributions withheld but not yet received nor for interest earned and dividends declared but not yet received. The accompanying 2024 statement of net assets available for benefits, statement of changes in net assets available for benefits, and supplemental schedule were prepared on the liquidation basis of accounting. On the liquidation basis of accounting, the investments are valued at the estimated amount of cash to be distributed to the participants. The liquidation and modified cash basis of accounting are each a basis of accounting other than accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of the financial statements in conformity with the liquidation and modified cash basis of accounting requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 3 for further discussion and disclosures related to the fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded when received. Net appreciation in fair value includes the Plan's gains (losses) on investments bought and sold, as well as held during the year.

Interest income is recorded when received.

The Fidelity Managed Income Portfolio invests in benefit-responsive investment contracts. This fund is recorded in the financial statements at fair value of \$23,907 and \$33,250 as of December 31, 2024, and 2023, respectively. See Note 3 for further discussion and disclosures related to this fund and fair value measurements. Contract values of \$25,437 and \$35,257 as of December 31, 2024, and 2023, respectively, represent contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

Notes Receivable from Participants

Loans to participants are measured at their unpaid principal balance. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. No allowance for doubtful accounts is necessary since the loans are fully secured by the participant accounts.

Payments of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the origination and administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

Subsequent Events

Management evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

Daaquam Lumber Maine Inc. was sold effective January 4, 2025, and the Plan was terminated.

(3) FAIR VALUE MEASUREMENTS

Fair value is defined as that price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets or liabilities.
- Level 2 Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
- Quoted prices for similar asset or liabilities in active markets.
 - Quoted prices for identical or similar assets or liabilities in markets that are not active.
 - Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g. interest rate and yield curve quotes at commonly quoted intervals).
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Unobservable inputs for the asset or liability (i.e. supported by little or no market activity). Level 3 inputs include management's own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methods used for assets measured at fair value. There have been no significant changes in the methodologies used at December 31, 2024 as compared to 2023.

- *Registered investment companies:* The fair values of these securities are based on observable market quotations for identical assets and are priced on a daily basis at the close of business.
- *Interest-bearing cash:* The carrying value approximates fair value.
- *Common/collective trust:* The collective trust funds are public investment vehicles valued using a Net Asset Value (NAV) provided by the manager of each fund. The NAV is based on the underlying net assets owned by the fund, divided by the number of shares outstanding. Then NAV's unit price is quoted on a private market that is not active. However, the NAV is based on the fair value of the underlying securities within the fund, which are traded on an active market, and valued at the closing price reported on the active market on which those individual securities are traded. The significant investment strategies of the funds are as described in the financial statements provided by each fund. There are no restrictions on redemptions from these funds.
- *Common stocks:* The fair values of these securities are based on observable market quotations for identical assets and are valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments include the BrokerageLink account (a self-directed brokerage account) which allows participants to invest their contributions in a money market account or individual securities such as mutual funds and common stocks. At December 31, 2024 and 2023, the balance in the BrokerageLink account was \$52,173 and \$108,548, respectively.

The Fidelity Managed Income Portfolio is categorized as a common/collective trust. The fund's investment objective is to seek the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital. The fund primarily invests in assets (typically fixed income securities or bond funds) and may enter into "wrapper" contracts issued by third parties and invests in cash equivalents represented by shares in a money market fund. The fair value of this fund has been estimated based on the fair value of the underlying investment contracts in the fund as reported by the issuer to the fund.

(4) INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The following is a summary of certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

(5) RELATED PARTY TRANSACTIONS

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity Management Trust Company is the trustee of the Plan and these transactions, as well as notes receivable with participants, qualify as party-in-interest transactions.

(6) PLAN TERMINATION

On December 31, 2024, the plan sponsor of Daaquam approved a resolution to terminate the Plan effective January 4, 2025. All participants became 100% vested in their accounts at that time. Contributions of \$26,097 were received by the Plan in January of 2025, and net assets available for benefits of \$4,734,868 were distributed as of July 1, 2025.

(7) INCOME TAX STATUS

The Plan adopted the Fidelity Basic Plan Document No. 17. This is a volume submitter plan document intended to qualify under Code Section 401(a). On March 31, 2014, Fidelity Management received an opinion letter from the IRS that the form of the Plan is acceptable and that an employer that adopts the Plan may rely on the letter with respect to the qualification of its plan under Code Section 401(a).

Although the Plan has been amended since its adoption, except for the following matter, the Company believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified, and the related trust is exempt.

The liquidation and modified cash bases of accounting require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS or DOL. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain tax positions taken by the Plan that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS and the DOL; however, there are currently no audits in progress.

(8) PLAN AMENDMENTS

The Plan has implemented certain provisions of the Bipartisan Act of 2018, the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act). These plan changes are permitted as operational relief items for impacted plan participants, as defined by the act, which included formal amendment to the Plan in the year 2025.

(9) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits (liquidation and modified cash basis).

(10) CLASSIFICATION DIFFERENCES

The Form 5500 has certain assets, income and expense items that differ from amounts shown on the accompanying financial statements. These differences relate to classification only and have no effect on the net assets available for benefits for either period.
