## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of the  
Capitol Broadcasting Company, Inc. Retirement Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Capitol Broadcasting Company, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.



- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN:

The following description of the Capitol Broadcasting Company, Inc. Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General.** The Plan, established on January 1, 1965, is a defined contribution 401(k) plan sponsored by Capitol Broadcasting Company, Inc. (the "Company" or "Plan Sponsor"). The Administrative Committee, appointed by the Board of Directors of the Company, controls and manages the operations and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Principal Trust Company (the "Custodian") held the Plan's investment assets and executed investment transactions for the years ended December 31, 2024 and 2023.

**Eligibility.** Eligible participants, as defined by the Plan, are substantially all employees of the Company who have completed 1,000 hours of service with the Company over a consecutive 12-month period. Employees become eligible to defer pre-tax contributions or after-tax contributions and to receive the Company's safe harbor contribution and 401(k) matching contribution after completing 90 days of employment.

**Contributions.** The Company contributes a percentage, as determined by the Board of Directors, of each participant's gross annual compensation to the "Retirement Fund". The Company made a discretionary profit sharing contribution of 3% of compensation for the years ended December 31, 2024 and 2023. The Company also contributes 3% of compensation as a safe harbor contribution. The Plan allows employee after-tax contributions and pre-tax deferrals subject to certain Internal Revenue Code ("IRC") limitations. The Company matched up to 4% and 5% of eligible compensation deferred into the Plan for the years ended December 31, 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. All participants who have attained age 50 during the Plan year are eligible to make catch-up contributions.

**Automatic Deferral Election.** The Plan has an automatic enrollment feature. Under this feature, employees are automatically enrolled in the Plan and 3% of their eligible Plan compensation, as defined by the Plan, is contributed to the Plan. Employees have the option to modify or opt out of the automatic enrollment by completing a salary deferral election form with a different deferral amount or by specifically electing not to defer.

**Participant Accounts.** Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings, and charged with withdrawals and allocations of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

**Investment Options.** Upon enrollment in the Plan, a participant directs the investment of his or her contributions and Company contributions into mutual funds, a pooled separate account, or a collective trust fund.

**Vesting.** Participants are immediately 100% vested in their pre-tax, Roth, employee after-tax, safe harbor, and rollover contributions. A participant becomes 100% vested in their employer retirement contributions and matching employer contributions after completing three years of service, if they separate from service after attaining age 65, or on the account of death or disability.

**Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the loan fund. The repayment period for loans will not be longer than five years unless the loan was used to purchase a primary residence. The loans are secured by the balance in the participant's account and bear interest at the daily prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits.** Upon termination of service due to death, disability or retirement, a participant is entitled to payment of benefits as soon as a proper application is processed. For termination of service due to other reasons, a participant is entitled to payment (primarily lump-sum) on the basis of accrued balances as of the date proper applications are processed, or, if accounts are greater than \$5,000, participants may elect to leave account balances in the Plan until the later of 60 days after the close of the Plan year in which the participant attains age 65 or 60 days after the participant's 10th anniversary of participation in the Plan occurs. Participants may make withdrawals from their employee after-tax contribution accounts at any time. Participants may make withdrawals from their deferred accounts in the event of financial hardship once they have withdrawn the entire amount credited to their employee after-tax contribution accounts.

**Forfeited Accounts.** Benefit payments to terminated employees partially vested in the Plan include their vested portion of employer contributions. The nonvested portion of terminated participants' account balances is used to reduce any future employer contributions. The Plan had a forfeiture balance of \$2,359 and \$2,065 at December 31, 2024 and 2023, respectively. During the years ended December 31, 2024 and 2023, forfeitures of \$136,457 and \$214,713, respectively, were used to reduce employer contributions and administrative expenses.

**Administrative Expenses.** Administrative expenses of the Plan are paid by the Plan or Plan Sponsor, as provided by the Plan document.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

**Basis of Accounting.** The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Estimates.** The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition.** Investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits.** Benefit payments to participants are recorded when paid.

**Income Taxes.** The Internal Revenue Service ("IRS") has determined and informed the Company, by a letter dated September 25, 2017, that the Plan, related trust, and all amendments through September 12, 2017, were designed in accordance with applicable regulations of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. As such, no provision for income taxes has been included in the Plan's financial statements.

The Plan is a qualified plan as described in Section 401(a) of the IRC and is therefore exempt from federal and state income taxes. Income generated by activities that would be considered unrelated to the Plan's purpose would be subject to tax which, if incurred, would be recognized as a current expense. No such tax has been recognized as of December 31, 2024 and 2023.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan. Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain tax positions taken that required recognition of a liability (or asset) or disclosure in the financial statements. The Plan files annual returns in the U.S. federal jurisdiction. The statute of limitations for returns filed within this jurisdiction is generally three years after the return is due or filed, whichever is later. As of December 31, 2024, the Plan's annual returns for their 2021 through 2023 tax years remain subject to examination by tax authorities.

4. FAIR VALUE MEASUREMENTS:

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Fair Value Measurement:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurement:

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurement:

Fair values are based on inputs other than quoted prices included within level 1 that are unobservable and significant to the fair value measurements.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Mutual funds represent investments with various investment managers. The mutual funds are valued at the daily closing net asset value ("NAV") as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate account: Units held in pooled separate accounts are valued at the NAV based on the fair market value of the underlying investments of the account less its liabilities. The NAV is used as a practical expedient to estimate fair value.

Collective trust fund: The fair value of collective trust funds is measured at NAV as a practical expedient and represents the exit price. Collective trust funds are traded in principal-to-principal markets with little publicly released pricing information. Collective trust funds allow for daily redemptions, but may require advance notice in some circumstances.

*Fixed income:* To invest in a broad range of fixed income securities with high income yields, returns that outpace inflation, or returns that are designed to track a specified inflation index.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Fees paid using Plan assets for the years ended December 31, 2024 and 2023 for administrative record keeping, accounting, and other professional services were \$122,089 and \$107,441, respectively, and were based on customary rates for such services. The Plan Sponsor provides certain accounting and administrative services to the Plan for which no fees are charged. The Plan Sponsor directly pays any other fees related to the Plan's operations.

Certain participants of the Plan have outstanding loans (notes receivable from participants) totaling \$450,841 and \$416,496 as of December 31, 2024 and 2023, respectively. These loans are considered party-in-interest transactions.

6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
