We have performed audits of the accompanying financial statements of Community Health Systems, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Community Health Systems, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 

**Note A – Description of Plan**

The following description of the Community Health Systems, Inc. (Organization) 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all full-time employees expected to complete a year of service in their first computation period. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan.

Contributions – In the current year, the employer may contribute up to 5% of pretax annual compensation, as defined in the Plan. Employer matches 100% of employee contributions from 0% to 3% and 100% from 3% to 5%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participants Accounts - Each participant's account is credited with the allocations of (a) the Organization's contribution, (b) Employee's contributions and, (c) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Vesting in the Organization's contribution portion of their accounts plus actual earnings thereon is 100% upon entering Plan.

All other contribution source accounts are 100% vested at all times.

Notes Receivable from Participants - Participants may borrow from their fund with a minimum loan of \$1,000 and one loan at a time. The notes are secured by the balance in the participant's account and bear interest which is determined by the custodian. Principal and interest is withheld from the employee and paid to the custodian from the sponsor.

Investment Options - Upon enrollment in the Plan, a participant may direct contributions in any of the various investments offered by Principal Trust Company.

Participants may change their investment options at any time via the insurance company website.

**Note A – Description of Plan (Continued)**

Investment Valuation and Income Recognition - The Group Annuity Contract offers a wide spectrum of investment choices selected by the participant including a General Account (guaranteed return account) plus various Pooled Separate Accounts (PSA), and mutual funds from a variety of investment managers. This allows the participant to select investments that best reflect their investment style - from conservative to aggressive.

The general account is considered a fully benefit-responsive, and contract value is appropriate reported value. When participant-initiated withdrawals are made, they are made at contract value, therefore, the custodian does not believe a reasonable method exists for determining fair value at an amount that differs from contract value.

Payment of Benefits - On termination of service due to death, disability or retirement, a participant may elect to receive with a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or partial withdrawal. Additionally, In-service distributions may be made to a participant who has not separated from service but has attained the age of 59 1/2.

Forfeited Accounts - At December 31, 2024 and 2023, there were no forfeited non-vested accounts.

Reclassifications - Certain accounts in the prior-year financial statements have been reclassified for comparative purposes to conform with the presentation in the current-year financial statements.

**Note B - Summary of Significant Accounting Policies**

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits - Benefits are recorded when paid.

**Note C – Trust/Custodian Agreement**

In 2020 the Plan has entered into a trust agreement with Delaware Charter Guarantee & Trust Company d/b/a/ Principal Trust Company (Principal Trust Company). Principal Trust Company maintains the balances in Group Annuity Contract, the account is credited with earnings on the underlying investments, insurance or mutual funds are charged for Plan withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value which approximates fair value. The value of the investment at December 31, 2024 and 2023 was \$43,229,958 and \$36,624,023, respectively.

**Note D - Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note E - Tax Status**

The IRS has determined and informed the Plan sponsor by a letter dated December 31, 2018, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan's Forms 5500, Annual Return/Report of Employee Benefit Plan, are generally subject to examination by the Internal Revenue Service for three years after they are filed, however, there are currently no audits for any tax periods in progress.

**Note F - Risk and Uncertainties**

The Plan invests in Group Annuity Contract which invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note G - Subsequent Events**

Management has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

**Note H – Related Party Transactions and Party In Interest Transactions**

ERISA defines a party-in-interest generally as any fiduciary or employee of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of a person described above. Payments to parties-in-interest consisted of administrative expenses paid to custodian and professional services for investment and administrative services totaling \$78,203 and \$65,357 for each of the years ended December 31, 2024 and 2023 related to investment expenses and \$34,677 and \$26,761 for contract administration fees. The investment-related expenses are included in net appreciation in fair value of investments.

Certain administrative functions are performed by officers or employees of the plan sponsor at no cost to the Plan, additionally, all of the cost of the plan are paid by the sponsor.

**Note J - Guaranteed Investment Contract with Insurance Company**

In 2024 and 2023, the Plan participants have invested in a fully benefit-responsive investment contract with Principal Trust Company, which maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$5,180,621 and \$5,225,429, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1.90% and 2.00%, respectively. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Principal Trust Company. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the schedule maturity date.

**Note K – Fair Value Measurements**

For 2024 and 2023, the Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

**Note K – Fair Value Measurements (Continued)**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 are inputs other than quoted prices included within Level 1 that are observable for the asset or liability either directly or indirectly. Observable inputs are those that reflect the assumptions market participants would use in pricing the asset developed on market data obtained from sources outside the plan, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available, and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.
