## Independent Auditors' Report

To the Administrative Committee

### Opinion

We have audited the accompanying financial statements of Urban Land Institute Group Benefit Plan (the "Plan"), which comprise the statements of net assets available for benefits – cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits – cash basis for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Urban Land Institute Group Benefit Plan - cash basis as of December 31, 2024 and 2023, and the changes in its net assets available for benefits - cash basis for the years then ended in accordance with the cash basis of accounting described in Note 2.

### Basis for Opinion

We conducted our audits in accordance with the cash basis of accounting. Our responsibilities under the cash basis of accounting are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. The following description of the Urban Land Institute (Company or Plan Sponsor) Group Benefit Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The Plan was established on January 1, 1994 to provide, systematically, for the payment of benefits to employees and covered dependents in the event of medical expense, hospitalization and similar occurrences. The Plan is subject to the provisions of the Employee Retirement Income Securities Act of 1974 (ERISA).

**Benefits**

The Plan is sponsored and administered by the Company. The Plan provides health benefits (medical, hospital, surgical, and major medical) to full-time, active employees. The Plan covers all active/full time and full pay basis employees on the first day of the month coinciding with or following the date eligibility requirements are satisfied, and the eligible dependents of such employees.

**Contributions**

The Plan is self-funded from combined Company/employee contributions, and benefit payments are made from these contributions. In evaluating the funding levels necessary, the actual claims paid and expected claims experience, referred to as the attachment point, are considered. Benefits are funded by a combination of insurance and self-funding for payment of medical benefits. Information about the Plan is available in the Plan Documents and the Service Agreement. The Company absorbs significant costs of Plan administration. Contributions made by the Plan are deposited in a bank money market account controlled by the Company.

Full-time employees may contribute specified amounts, determined periodically by the Plan, to extend coverage to eligible dependents.

**Plan Administration**

Disbursements for claims, expenses and insurance related to health benefits are withdrawn from the bank money market account, and transferred to CareFirst Administrators, the third-party administrator.

**Stop Loss Coverage**

The Plan has entered into a stop-loss insurance agreement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, which was \$65,000 at December 31, 2024 and 2023, as well as its aggregate exposure for all claims). After acceptable proof of loss and satisfactory proof of paid plan benefits, the insurance company will then reimburse the Plan Sponsor. Stop loss refunds totaling \$353,450 and \$386,479 for the years ending December 31, 2024 and 2023, respectively, have been netted with claims paid.

**Note 2 - Summary of Significant Accounting Policies**

**Cash**

The Plan's cash is held in a segregated trust account.

**Note 2 - Summary of Significant Accounting Policies (continued)**

**Basis of Accounting**

The financial statements of the Plan are prepared on the cash basis of accounting which is a basis of accounting other than accounting principles generally accepted in the United States of America. Under the cash basis, additions to net assets are recognized when received rather than when due and deductions from net assets are recognized when paid rather than when incurred. Consequently, no liabilities for health claims incurred but unpaid are included in the financial statements. In addition, no assets related to potential insurance recoveries or under funding amounts, if any, are included in the financial statements.

**Benefit Payments**

Claim payments are recorded when the funds are transferred from the Company general assets or the Trust account to the third-party claims processor.

**Estimated Benefit Obligations**

Plan obligations at December 31, 2024 and 2023 for healthcare claims incurred by active participants but not reported at that date are estimated in accordance with accepted principles utilizing historical claims data. Such estimated amounts are reported in the accompanying footnote of the Plan's benefits obligations at present value.

**Estimates**

The preparation of financial statements in accordance with the cash basis of accounting requires estimates and assumptions that affect certain reported amounts of assets, additions to net assets, deductions from net assets, benefit obligations, and changes therein, IBNR, and claims payable. Accordingly, actual results may differ from those estimates and assumptions.

**Concentrations of Credit Risk**

The Plan maintains its cash balances in one financial institution which may, from time-to-time, exceed the FDIC limit. Management does not feel there is a risk of loss.

**Note 3 – Administrative Expenses**

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators. These expenses are reported on the statement of changes in net assets available for benefits - cash basis as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

**Note 4 – Income Tax Status**

The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, no uncertain positions are taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2021.

**Note 5 – Other Risks and Uncertainties**

The present value of benefit obligations is reported based on certain assumptions pertaining to historical claims paid and future claims, all of which are subject to change. Due to uncertainties inherent in the estimates and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**Note 6 – Party-in-Interest**

For the years ending December 31, 2024 and 2023, fees incurred by the Plan for administration and premiums for stop-loss insurance were paid to CareFirst Administrators, the third-party administrator of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for CareFirst’s administration amounted to approximately \$109,080 and \$242,314, respectively. Premiums for stop-loss insurance amounted to approximately \$1,043,278 and \$845,124, respectively.

**Note 7 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to reduce or discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination, the Plan shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of Plan management, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the Plan’s participants.
