We have performed audits of the financial statements of Identiv 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the related Statement of Changes in Net Assets Available for Benefits for the Year Ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### ***Basis for Opinion***

### ***Emphasis of Matter—Business Transaction***

As further discussed in Note 1a to the financial statements, effective September 6, 2024, the Company completed an asset sale of its physical security, access card, and identity reader operations. As a result of the transaction, employees associated with those business segments ceased to be eligible to participate in the Plan. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### 1. Plan Description

The following description of Identiv 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### a. General

The Plan, originally effective January 1, 2023, and restated April 17, 2023, is a defined contribution plan covering all employees of Identiv Inc. (the Company) who have completed one month of service and attained 18 years of age, excluding certain classes of employees as set forth in the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On September 6, 2024, the Company completed an asset sale of its physical security, access card, and identity reader operations and related assets to Vitaprotech SAS. As a result of the transaction, employees associated with those business segments ceased to be eligible to participate in the Plan and were immediately vested in their participant accounts effective as of the closing date.

#### b. Contributions

Participants may contribute up to 100 percent of annual compensation in pre-tax or Roth deferrals, as defined in the plan document and allowed by law. Participants may also roll over amounts representing distributions from other qualified plans. The Plan permits catch-up contributions for participants who have attained age 50 by the end of the plan year. Company contributions are discretionary. For the year ended December 31, 2024, the Company contributed \$212,371 to the Plan.

#### c. Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution, if applicable, and the Plan's earnings and losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their accounts into various investment options offered by the Plan.

#### d. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the company contribution portion of their accounts plus actual earnings thereon is based on years of credited service. Participants become fully vested after completing one year of credited service.

e. Notes Receivable from Participants

Participants may borrow the lesser of \$50,000 (reduced by the participant's highest outstanding loan balance during the 12-month period ending on the date of the loan) or 50 percent of their vested account balance. Loan terms range up to five years but may be extended if the proceeds are to be used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at 8.75 percent. Principal and interest are paid directly by participants.

f. Distribution of Benefits

Upon termination of employment due to termination of service, death, disability, or retirement, participants may elect to receive the value of their vested account balance in a lump-sum distribution. In-service withdrawal options are available to participants under certain circumstances.

g. Forfeited Accounts and Unallocated Funds

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$13,491 and \$29,199, respectively. Forfeitures are used to pay plan expenses and reduce future company contributions. During 2024, forfeited non-vested accounts were used to pay \$22,019 of plan expenses. In addition, excess revenue-sharing amounts from the Plan's investment options have been deposited into unallocated excess revenue-sharing accounts. At December 31, 2024 and 2023, unallocated revenue-sharing accounts totaled \$2,912 and \$1,621, respectively. These accounts may be used to pay plan expenses.

2. Summary of Significant Accounting Policies

a. Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

b. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

### c. Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are generally recorded on a trade-date basis. As permitted by Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962-325, *Plan Accounting—Defined Contribution Plans: Investments—Other*, settlement-date basis may be used when (a) the settlement date is after the financial statement date, (b) the fair value of the securities purchased or sold did not change significantly from the trade date to the financial statement date, and (c) the purchases or sales do not significantly affect the composition of the plan's net assets available for benefits.

Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### d. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. These are referred to as participant loans in the Form 5500 and related supplemental schedules. Delinquent loans are treated as distributions based upon the terms of the plan document.

### e. Payment of Benefits

Benefits are recorded when paid.

### f. Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Plan expenses include fees for certain participant-initiated transactions that are charged directly to the account of the participant who incurred them. Investment-related expenses are included in net realized and unrealized appreciation in fair value of investments.

### g. Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

## 3. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### 4. Fair Value Measurement

FASB ASC 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none"><li>• quoted prices for similar assets or liabilities in active markets;</li><li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• inputs other than quoted prices that are observable for the asset or liability;</li><li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul> If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective trusts:* Carried at fair value using NAV as a practical expedient. Valued at the NAV of units held by the Plan at year-end as posted by the fund, which is considered by plan management to be the best approximation of fair value. There are no notable restrictions on the redemption of investments held in the fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Exempt Status

The Company has adopted a pre-approved plan document that received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, and the plan administrator believes the Plan has been operated in accordance with the applicable provisions of the Internal Revenue Code (IRC). The Company routinely self-reviews the administration of the Plan and self-corrects any compliance issues in accordance with the Employee Plan Compliance Resolution System. Accordingly, the plan administrator believes that the Plan and related trust are designed in accordance with applicable sections of the IRC and, accordingly, are exempt from income taxes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Plan Termination

The Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

As a result of a reduction in the plan sponsor's workforce in 2024 due to the asset sale discussed in Note 1a, the Plan underwent a partial plan termination as defined by ERISA. All affected participants who were not fully vested at the date of the partial plan termination became 100 percent vested in their account balances.

### 9. Non-Exempt Transactions

Certain of the participant contributions were not remitted within the maximum period of time permitted by the Department of Labor's Rules and Regulations and, therefore, constitute the lending of monies from the Plan to the Company. These non-exempt transactions are detailed in the attached supplemental schedule, Schedule H, line 4a—Schedule of Delinquent Participant Contributions for the Year Ended December 31, 2024.

Professional standards require that we provide you with information related to any reportable findings that were identified during our audit of the financial statements of Identiv 401(k) Plan (the Plan) as of and for the year ended December 31, 2024. For purposes of this letter, a reportable finding is a matter that includes one or more of the following: noncompliance or suspected noncompliance with laws and regulations, a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention.

### ***Internal Control Matters***

Except as discussed in the following paragraph, in planning and performing our audit of the financials of the Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's system of internal control over financial reporting (internal controls) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our audit report on the financial statements, but not for the purpose of expressing our opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by qualified institutions that prepared and certified the statements or information

regarding the assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraph and would not necessarily identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified. However, as discussed below, we identified a deficiency in the Plan's internal control that we consider to be a significant deficiency but not a material weakness.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent or detect misstatements on a timely basis. A deficiency in design exists when (a) a control necessary to meet the control objective is missing or (b) an existing control is not properly designed so that even if the control operates as designed, the control objective is not always met. A **deficiency** in operation exists when a properly designed control does not operate as designed or when the person performing the control does not possess the necessary authority or qualifications to perform the control effectively.

A **material weakness** is a deficiency, or combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the entity's financial statements will not be prevented or detected and corrected on a timely basis.

A **significant deficiency** is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.

### ***Reportable Findings***

We consider the following to be instances of noncompliance or suspected noncompliance with applicable rules and regulations:

#### **Timeliness of Contributions**

During our audit, we noted total participant contributions of \$7,733 relating to the plan year ended December 31, 2023, were identified as delinquent and remained uncorrected. Additionally, we also noted instances in which the amount withheld from participants was not remitted to the Plan in a consistent manner. The Department of Labor (DOL) requires that participant contributions be remitted to the plan on the earliest date on which they can be reasonably segregated from the company's general assets but in no event later than the 15th business day following the end of the month in which amounts are contributed by employees or withheld from their wages. Failure to remit participant contributions to the plan in a timely and consistent manner results in a prohibited transaction that must be separately reported to the DOL and may result in penalties to the Plan Sponsor.

Furthermore, the participant contributions must be remitted timely and in a consistent manner.

We recommend the Plan Sponsor review the procedures for remitting amounts withheld from participants to the plan and determine a timeline upon which deferred amounts can be reasonably segregated from the Company's general assets and implement procedures to ensure that the remittances are made timely and consistently in accordance with such timeline. Furthermore, we recommend the Plan Sponsor to make the necessary corrective contributions to the Plan for the delinquent participant contributions identified as soon as possible.

### **Incomplete Data Used in Performing Compliance Tests**

During our audit, we noted that the employee gross compensation used to complete the compliance tests did not reconcile to the gross compensation per the payroll registers. To maintain its tax-qualified status, the plan must properly complete any annual required compliance tests with complete and accurate employee data and make any necessary corrections. A failure to do so could negatively impact the plan's tax status.

We recommend working with your service providers to ensure they have the appropriate census file to determine if compliance testing needs to be re-run. Furthermore, if any failed compliance tests result, we recommend ensuring that corrections are made as soon as administratively feasible.

We consider the following to be findings that in our professional judgment are significant and relevant to you regarding your responsibility to oversee the financial reporting process:

### **Partial Plan Termination**

During our audit, we noted a business transaction occurred during 2024 that resulted in a significant number of participants (>20%) being involuntarily terminated from employment. As a result, a partial plan termination occurred.

The IRS stipulates that all affected employees to be fully vested in their account balance as of the date of a full or partial plan termination. An affected employee in a partial termination is generally anyone who left employment for any reason during the plan year in which the partial termination occurred and who still has an account balance under the plan.

We noted full vesting was appropriately applied to affected employees and no forfeitures were improperly withheld. We recommend working with your service provider and closely reviewing future distributions and forfeitures to ensure all affected employees do not have forfeitures withheld.

### **Unallocated Forfeited Participant Accounts**

The Plan document has established guidelines for the use of forfeited participant accounts. In addition, the Internal Revenue Code (IRC) requires that these forfeited accounts be used or reallocated to Plan participants in accordance with the terms of the Plan document in the Plan year they are incurred. The Internal Revenue Service (IRS) has issued transition guidance that allows forfeitures accumulated before January 1, 2024, to be treated as if they were incurred in 2024. This means that plan sponsors have until the end of the 2025 plan year to use these forfeitures.

During our audit, we noted that as of December 31, 2024 the Plan had accumulated approximately \$16,403 of unallocated forfeited participant accounts that had not been utilized. The Plan should use or reallocate these forfeited accounts by December 31, 2025.

We consider the following to be significant deficiencies, as defined above:

### **Incomplete Data Used in Performing Compliance Tests**

As noted above, during our audit, we noted that the employee gross used to complete the compliance tests did not reconcile to the gross compensation per the payroll registers. To maintain its tax-qualified status, the plan must properly complete any annual required compliance tests with complete and accurate employee data and make any necessary corrections. A failure to do so could negatively impact the plan's tax status.

We recommend reviewing and implementing controls to ensure that census data is complete and accurate prior to providing to the service provider to ensure that compliance testing is completed using complete and accurate data.

We consider the following to be deficiencies in internal control that, while they may not be significant deficiencies or material weaknesses, are of enough significance to the plan as to be reportable to you:

### **Timeliness of Contributions**

As noted above, during our audit, we noted sufficient controls were not in place to ensure the consistent and timely remittance of participant contributions which has occurred year over year. Failure to remit participant contributions to the Plan in a timely manner results in a prohibited transaction that must be separately reported to the DOL and may result in penalties to the Plan Sponsor.

Additionally, if the Plan were ever to be audited by the DOL, typically, the investigator would note that the company has succeeded in several instances in making remittances

within three business days. Using this as a guide, any contribution remitted after that period would be presumed late.

We recommend that the Plan Sponsor review the procedures involved in remittance of participant contributions to the Plan and institute the necessary controls to ensure that participant contributions are remitted timely and in a consistent manner.

## **CLIENT ADVISORY: New IRS forfeitures rules**

*Note: The information being provided is general in nature and furnished for the purpose of raising client awareness of recent developments around plan forfeitures.*

### **New IRS forfeiture rules and transition period**

IRS forfeiture rules, along with the provisions of your plan document, determine the proper and timely use of forfeitures in defined contribution plans covered by ERISA. Forfeitures are required to be used timely and are not permitted to be held across multiple annual periods in suspense accounts. Forfeitures must be used in one or more of the following ways (consult your plan document for your plan's provisions for usage):

1. To pay plan administrative expenses.
2. To reduce employer contributions.
3. To be allocated to participants' accounts.

Prior IRS rules required the usage of forfeitures during the same plan year in which they were incurred. New IRS rules require that forfeitures be used *no later than 12 months after the close of the plan year in which they were incurred.*

Transition relief. Forfeitures incurred in any plan year that began before January 1, 2024, may be deemed incurred during the first plan year beginning on or after January 1, 2024.

- Suppose that a plan is on a calendar year and had forfeitures incurred prior to January 1, 2024. Under the transition relief, these forfeitures may be deemed incurred during 2024, which means they must be used prior to December 31, 2025.

### **Steps you can take**

- Evaluate whether you have an outstanding forfeiture balance in your plan and determine when forfeitures were incurred.
- Review your plan's provisions around the use of forfeitures.
- Determine when forfeitures must be used by and make a plan to use all forfeitures subject to the transition relief by December 31, 2025.
- Ensure that your plan has designed and implemented internal controls to ensure that forfeitures will be used on a timely basis in accordance with your plan document for all periods following the transition relief.

We completed our audits of the financial statements of Identiv 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA) as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the Statement of Changes in Net Assets Available for Benefits for the Year Ended December 31, 2024, and the related notes to the financial statements. As part of our audit, we reported on the supplemental schedules required by the Department of Labor's (DOL's) rules and regulations for reporting and disclosure under ERISA for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America (GAAS). These schedules are presented for the purpose of additional analysis and are not a required part of the financial statements, but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The financial statements and ERISA-required supplemental schedules are included in the Plan's Form 5500 filing with the Employee Benefit's Security Administration of the DOL.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Our audit of the financial statements was conducted in accordance with auditing standards generally accepted in the United States of America. Except as described above regarding ERISA 103(a)(3)(C), our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

We have previously communicated information about our responsibilities under GAAS as well as certain information related to the planned scope and timing of our audit. The following comments summarize the results and findings from our audit:

### **Significant Findings from the Audit**

#### *Qualitative Aspects of Accounting Practices*

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the plan year. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. At year-end, management reviewed its investment portfolio for declines in market value below cost which were considered to be other-than-temporary. There were no impairment losses noted during the plan year. No other material subjective accounting estimates are included in the financial statements.

We concurred with management's conclusions of use of accounting policies and estimates.

Certain financial statement disclosures are particularly sensitive because of their significance to the user of the financial statements. The following financial statement disclosures are pertinent to the aspects of the plan's significant accounting practices, including accounting policies and estimates.

Note 2 – Significant Accounting Policies

Note 3 – Risks and Uncertainties

Note 4 – Fair Value Measurement

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Disagreements with Management

There were no disagreements with management about auditing, accounting, or disclosure matters. Management has advised us there were no consultations by management with other accountants regarding any of the matters mentioned above.

Uncorrected Misstatements

Professional standards require us to accumulate all uncorrected misstatements during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. There were no individually material uncorrected misstatements or material in the aggregate from the current period that affect the opinion of our report. There were no uncorrected misstatements related to prior periods on the relevant classes of transactions, account balances or disclosures, and the financial statements as a whole.

Corrected Misstatements

There were no material, corrected misstatements brought to the attention of management by us as a result of audit procedures.

*Other Audit Findings, Issues, or Significant Difficulties Encountered During the Audit*

We expect to include an Emphasis of Matter paragraph in the Audit report with the following wording:

As further discussed in Note 1 to the financial statements, effective September 6, 2024, the Company resolved to sell its physical security, access card, and identity reader operations. As a result of the transaction, employees associated with those business segments ceased to be eligible to participate in the Plan. Our opinion is not modified with respect to this matter.

We will provide a separate letter to you communicating findings identified during the audit.

We are pleased to report that we encountered no significant difficulties with management in performing and completing our audit. Management has fully cooperated with us; the account schedules and analyses provided were appropriately and timely prepared.
