Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of PGAV Savings & Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. Description Of The Plan

The following description of PGAV Savings & Investment Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

Peckham Guyton Albers & Viets, Inc. (the Company) adopted the Plan to provide participants an opportunity to defer a portion of their earnings to provide supplementary retirement income and a measure of economic security. The Plan, which became effective September 1, 1985, is a defined contribution plan covering all employees of the Company and PGAV Planners, LLC without restriction to age or length of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may defer either pre-tax contributions, after-tax contributions (Roth) or a combination thereof, from up to 90% of eligible compensation as specified in the Plan, not to exceed the maximum allowed by Internal Revenue Code (the IRC) limitations. Participants who have reached age 50 may make catch-up contributions, as defined in the IRC. Rollovers from qualified plans are allowed under the provision of the Plan. In-Plan Roth conversions of vested balances are permitted for participants.

The Plan also provides for an Automatic Contribution Arrangement which enrolls employees upon hire at a default pre-tax deferral rate of 6% of eligible compensation unless the employee elects not to participate or elects a different deferral rate. The deferral rate is increased by one percentage point from the deferral rate effective as of the last day of the prior Plan year to a maximum of 10% of eligible compensation.

The Plan also provides for discretionary Company matching contributions, which are determined annually by the Board of Directors. In 2024 and 2023, the Board of Directors elected to match 50% of participants' contributions.

Notes To Financial Statements (*Continued*)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions and allocations of the Plan's earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting of Company contributions is based on years of service. A participant becomes 20% vested for any Plan year the participant works 1,000 hours, increasing 20% each year to 100% vested after five years of service, attainment of or upon normal retirement age (age 65), upon early retirement (age 55) or death.

Forfeitures

When certain terminations of participants in the Plan occur, the nonvested portion of the participant's account represents a forfeiture. Forfeitures may be used to pay administrative expenses or used to reduce Company contributions, with any remaining amounts reallocated to participants' accounts. Forfeitures available for future use were \$16,896 and \$12,794 as of December 31, 2024 and 2023, respectively. The Company did not use any forfeitures to reduce Company contributions during 2024 or 2023. The Company used forfeitures to pay expenses of \$22,000 during 2024. The Company did not use forfeitures to pay expenses in 2023.

Notes Receivable From Participants

Participants may borrow from their account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of the total value of the participant's vested account balance. Loans are for a period not exceeding five years, or not to exceed ten years for the purchase of a principal residence. Loans bear interest at the Federal Reserve prime rate plus 1%. Loans are repaid through payroll withholdings, including principal and interest.

Contributions Receivable And Credit Loss Policy

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions, and when appropriate, reasonable and supportable forecasts.

PGAV SAVINGS & INVESTMENT PLAN

Notes To Financial Statements (*Continued*)

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

Benefit Payments

Upon termination of service, a participant (or the beneficiary) will receive a distribution of the account through a single lump-sum. Account balances of less than \$5,000 are distributed to participants in an immediate lump sum cash distribution upon termination of service.

In-Service Withdrawals

Active participants may withdraw rollover contributions at any time. Active participants who reach age 59-1/2 may withdraw all or part of their vested accounts.

Active participants who experience a qualifying financial hardship may withdraw from the Plan a portion of their vested account resulting from elective deferral and Roth contributions. Hardship withdrawals will be approved only if they conform to Plan provisions and established safe harbors under the IRC.

Administrative Expenses

The Plan is administered by the Company. Under the terms of the Trust Agreement, Fidelity Management Trust Company (Fidelity) manages trust funds on behalf of the Plan and maintains individual participants' accounts. Administrative expenses may be paid by the Company or the Plan.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Notes To Financial Statements (*Continued*)

Investment Valuation And Income Recognition

Investments, other than the collective trust funds, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded as earned on an accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based on the terms of the Plan.

Contributions Receivable And Credit Loss Policy

Amounts due for contributions are stated at the amount management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions, and, when appropriate, reasonable and supportable forecasts. The Company has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated subsequent events through the date the financial statements were available for issue, which is the Independent Auditors' Report date.

3. Certified Investment Information

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity (the Trustee) has certified that the following investment information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net change in fair value of investments and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024 and 2023;
- Investment information included in the footnotes as of December 31, 2024 and 2023 and on the supplemental schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. Fair Value Measurements

The Plan follows accounting standards which establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standards are described below:

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts

Self-directed brokerage accounts are primarily comprised of common and preferred stocks and mutual funds. Common and preferred stocks are valued at the closing price reported on the active market on which the individual securities are traded.

Collective Trust Funds

Valued at the NAV of units of bank collective trusts. The NAV, as provided by trustees, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less liabilities. This practical expedient is not used when it is determined to be probable that a fund will sell the investment for an amount different than the reported NAV.

All the collective trust funds held by the Plan file an annual report on Form 5500 as a direct filing entity. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at fair value under all circumstances including termination of the Plan.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Income Tax Status

The Company has adopted the Fidelity Basic Plan Document No. 17. Fidelity has received an opinion letter dated June 30, 2020, in which the Internal Revenue Service (the IRS) stated that the standardized plan, as designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended subsequent to the latest opinion letter date. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan, as amended, is qualified and tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Party In Interest Transactions

The Plan held investments in mutual funds managed by Fidelity. In addition, certain employees have outstanding loans with the Plan as of December 31, 2024 and 2023. These constitute party in interest transactions that are allowable under ERISA regulations.

8. Risks And Uncertainties

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of PGAV Savings & Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. Description Of The Plan

The following description of PGAV Savings & Investment Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

Peckham Guyton Albers & Viets, Inc. (the Company) adopted the Plan to provide participants an opportunity to defer a portion of their earnings to provide supplementary retirement income and a measure of economic security. The Plan, which became effective September 1, 1985, is a defined contribution plan covering all employees of the Company and PGAV Planners, LLC without restriction to age or length of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may defer either pre-tax contributions, after-tax contributions (Roth) or a combination thereof, from up to 90% of eligible compensation as specified in the Plan, not to exceed the maximum allowed by Internal Revenue Code (the IRC) limitations. Participants who have reached age 50 may make catch-up contributions, as defined in the IRC. Rollovers from qualified plans are allowed under the provision of the Plan. In-Plan Roth conversions of vested balances are permitted for participants.

The Plan also provides for an Automatic Contribution Arrangement which enrolls employees upon hire at a default pre-tax deferral rate of 6% of eligible compensation unless the employee elects not to participate or elects a different deferral rate. The deferral rate is increased by one percentage point from the deferral rate effective as of the last day of the prior Plan year to a maximum of 10% of eligible compensation.

The Plan also provides for discretionary Company matching contributions, which are determined annually by the Board of Directors. In 2024 and 2023, the Board of Directors elected to match 50% of participants' contributions.

Notes To Financial Statements (*Continued*)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions and allocations of the Plan's earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting of Company contributions is based on years of service. A participant becomes 20% vested for any Plan year the participant works 1,000 hours, increasing 20% each year to 100% vested after five years of service, attainment of or upon normal retirement age (age 65), upon early retirement (age 55) or death.

Forfeitures

When certain terminations of participants in the Plan occur, the nonvested portion of the participant's account represents a forfeiture. Forfeitures may be used to pay administrative expenses or used to reduce Company contributions, with any remaining amounts reallocated to participants' accounts. Forfeitures available for future use were \$16,896 and \$12,794 as of December 31, 2024 and 2023, respectively. The Company did not use any forfeitures to reduce Company contributions during 2024 or 2023. The Company used forfeitures to pay expenses of \$22,000 during 2024. The Company did not use forfeitures to pay expenses in 2023.

Notes Receivable From Participants

Participants may borrow from their account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of the total value of the participant's vested account balance. Loans are for a period not exceeding five years, or not to exceed ten years for the purchase of a principal residence. Loans bear interest at the Federal Reserve prime rate plus 1%. Loans are repaid through payroll withholdings, including principal and interest.

Contributions Receivable And Credit Loss Policy

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions, and when appropriate, reasonable and supportable forecasts.

PGAV SAVINGS & INVESTMENT PLAN

Notes To Financial Statements (*Continued*)

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

Benefit Payments

Upon termination of service, a participant (or the beneficiary) will receive a distribution of the account through a single lump-sum. Account balances of less than \$5,000 are distributed to participants in an immediate lump sum cash distribution upon termination of service.

In-Service Withdrawals

Active participants may withdraw rollover contributions at any time. Active participants who reach age 59-1/2 may withdraw all or part of their vested accounts.

Active participants who experience a qualifying financial hardship may withdraw from the Plan a portion of their vested account resulting from elective deferral and Roth contributions. Hardship withdrawals will be approved only if they conform to Plan provisions and established safe harbors under the IRC.

Administrative Expenses

The Plan is administered by the Company. Under the terms of the Trust Agreement, Fidelity Management Trust Company (Fidelity) manages trust funds on behalf of the Plan and maintains individual participants' accounts. Administrative expenses may be paid by the Company or the Plan.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

Investments, other than the collective trust funds, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded as earned on an accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based on the terms of the Plan.

Contributions Receivable And Credit Loss Policy

Amounts due for contributions are stated at the amount management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions, and, when appropriate, reasonable and supportable forecasts. The Company has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated subsequent events through the date the financial statements were available for issue, which is the Independent Auditors' Report date.

3. Certified Investment Information

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity (the Trustee) has certified that the following investment information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net change in fair value of investments and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024 and 2023;
- Investment information included in the footnotes as of December 31, 2024 and 2023 and on the supplemental schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. Fair Value Measurements

The Plan follows accounting standards which establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standards are described below:

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts

Self-directed brokerage accounts are primarily comprised of common and preferred stocks and mutual funds. Common and preferred stocks are valued at the closing price reported on the active market on which the individual securities are traded.

Collective Trust Funds

Valued at the NAV of units of bank collective trusts. The NAV, as provided by trustees, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less liabilities. This practical expedient is not used when it is determined to be probable that a fund will sell the investment for an amount different than the reported NAV.

All the collective trust funds held by the Plan file an annual report on Form 5500 as a direct filing entity. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at fair value under all circumstances including termination of the Plan.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Income Tax Status

The Company has adopted the Fidelity Basic Plan Document No. 17. Fidelity has received an opinion letter dated June 30, 2020, in which the Internal Revenue Service (the IRS) stated that the standardized plan, as designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended subsequent to the latest opinion letter date. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan, as amended, is qualified and tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Party In Interest Transactions

The Plan held investments in mutual funds managed by Fidelity. In addition, certain employees have outstanding loans with the Plan as of December 31, 2024 and 2023. These constitute party in interest transactions that are allowable under ERISA regulations.

8. Risks And Uncertainties

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
