Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of PerTronix, LLC Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the PerTronix, LLC Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) for employees of PerTronix, LLC and Aeromotive, Inc. (collectively, the “Company”).

Empower Trust Company, LLC and Empower Annuity Insurance Company of America (“Empower”) serve as custodians of the Plan. Empower Retirement serves as the recordkeeper of the Plan. Employees of the Company serve as the Plan’s trustees.

Eligibility – An individual is eligible to participate in the Plan after six months of service and upon reaching the age of 21. Once the requirements have been met, the employee may enroll in the Plan on the first day of the month. A participant is eligible to receive the Company safe harbor non-elective contribution and discretionary profit-sharing contribution on the first day of month after completing six months of service. The Plan is not open to union employees and non-resident aliens.

Contributions – Participants may elect to contribute any amount of their annual compensation, subject to certain Internal Revenue Code (“IRC”) limitations. In addition, participants over age 50 are permitted to make catch-up contributions, as defined in the Plan.

The Company has elected to make a safe harbor non-elective contribution to all eligible employees at a rate of 3% of compensation, as defined by the Plan Document. Additionally, the Company may make discretionary profit-sharing contributions. There was no discretionary profit-sharing contribution made for the year ended December 31, 2024.

Participant Accounts – Each participant’s account is credited with the participant’s and Company’s contributions, an allocation of the Plan’s investment earnings (losses), and is charged with the participant’s withdrawals and distributions and an allocation of Plan expense (if applicable). The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options – The Plan offers mutual funds and a guaranteed investment contract as investment options for participants.

Vesting – Participant contributions and safe harbor non-elective contributions are fully vested at all times. Vesting in the Company’s profit-sharing contribution is based on a graded vesting schedule depending on the participant’s employment date and years of service. Participants have completed a year of service for vesting purposes if they worked at least 1,000 hours during a plan year or the twelve-month period beginning on their date of hire. Vesting occurs in 20% increments, with 20% vested after 1 year of service, 40% vested after 2 years of service. Employees become fully vested after 5 years of service.

Forfeitures – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. Forfeiture amounts are used to reduce future employer contributions or pay Plan expenses. During 2024, \$164 in forfeitures were used to reduce the employer

contributions. As of December 31, 2024 and 2023, there are approximately \$13,838 and \$3,514 in forfeitures available, respectively.

Payment of Benefits – Upon termination of service, a participant may elect to receive either a lump-sum amount equal to vested account balances, or installment payments over a fixed, reasonable period of time, as defined by the Plan document. If the account balance does not exceed \$5,000, a lump-sum payment is the only form of disbursement available. Upon termination of employment, account balances less than \$1,000 will be automatically distributed.

In-Service Withdrawals – Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan and permitted by the IRC. Participants who have obtained the age of 59 ½ are allowed to receive a distribution of all or any portion of their salary reduction contribution account in a single sum payment.

Notes Receivable from Participants – Participants in the PerTronix, Inc. Profit Sharing Plan and Trust were permitted to borrow against their individual account balances a minimum of \$1,000 up to a maximum of \$50,000 or 50% of the participant's vested account balance. Once these participants merged into this Plan, no new loans were permitted. Loans are secured by the participant's vested account balance. Interest rates on the loans are set at 1.0% over the prime rate published in the *Wall Street Journal* on the first business day of the month before the loan is originated. Loan terms are in accordance with limitations set forth by the IRS, and may not exceed five years, unless the loan was to purchase a primary residence. Loan repayments are made ratably through payroll deductions.

Administrative Expenses – The Plan pays the majority of the expenses from Plan assets. During 2024, the Plan paid \$29,659 for investment advisory and consulting services, recordkeeping and other professional services. The Company may pay other professional fees associated with the Plan.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, participants' accounts would become fully vested, and all remaining Plan assets would be allocated to the participants as described in the full text of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade date basis.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for doubtful accounts is considered necessary.

Payment of Benefits – Benefit payments are reported in the year paid.

Date of Management's Review – Subsequent events have been evaluated through October 2, 2025, which is the date the financial statements were available to be issued, and there were no material events requiring recognition or disclosure.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds – Valued at the net asset value (“NAV”) of shares held by the plan at year end based on published quoted prices.

Guaranteed Investment Contract – Fair value is equal to the contract value. This value represents contributions allocated to the guaranteed interest accounts, plus interest at the contractually guaranteed rate, less funds used to pay Plan benefits and administrative expenses.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The Plan's investments are reported at fair value as follows at December 31, 2024 and 2023:

4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

5. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan provides a Guaranteed Investment Contract, a group annuity contract by Empower as an investment option for participants and is not considered fully benefit-responsive. The objective of this investment option is to guarantee the return of principal plus compound interest earned over a defined term backed by Empower. There are no specific securities in the general account that back the liabilities of this group annuity contract. Empower is obligated to pay interest at crediting rates, which are announced in advance and guaranteed per the terms of the contract. There are no reserves against fair value for credit risk of the contract issuer or otherwise.

6. INFORMATION CERTIFIED BY THE CUSTODIANS

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the custodians of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Notes receivable from participants and related interest
- Net appreciation in fair value of investments
- Interest and dividend income
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are a mutual fund and a guaranteed investment contract managed by Empower or an affiliated company, Putnam Investments, LLC. Empower is a custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest. The Plan pays certain fees to Empower to administer the Plan. These transactions qualify as party-in-interest. Notes receivable from participants are party-in-interest transactions.

8. TAX STATUS

The Company adopted the Empower Retirement, LLC Defined Contribution Pre-Approved Plan which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. PROHIBITED TRANSACTIONS

During the year ended December 31, 2024, employee deferrals of \$54,126 were withheld from participants' payrolls and not remitted to the trust by the plan sponsor on a timely basis (as defined by the Department of Labor "DOL"). The Plan Sponsor subsequently remitted all such deferrals to the trust. The Plan will file and pay the appropriate excise tax, and contribute lost earnings to the affected participants for the late contributions. These transactions are prohibited according to the provisions of the DOL.

During the year ended December 31, 2023, employee deferrals of \$17,226 were withheld from participants' payrolls and not remitted to the trust by the plan sponsor on a timely basis (as defined by the Department of Labor "DOL"). The Plan Sponsor subsequently remitted all such deferrals to the trust. The Plan filed and paid the appropriate excise tax and contributed lost earnings to the affected participants for the late contributions. These transactions are prohibited according to the provisions of the DOL.
