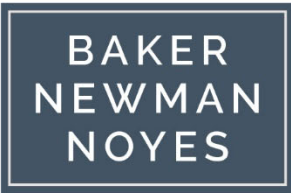

INDEPENDENT AUDITORS' REPORT

To the Trustees
Team EJP 401(k) Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Team EJP 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

1. Description of Plan

The following description of the Team EJP 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which became effective on January 1, 1992. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

John Hancock Life Insurance Company (U.S.A.) (John Hancock) is serving as custodian for the Plan.

On December 29, 2022, the *Setting Every Community Up for Retirement Enhancement Act of 2022* (SECURE 2.0 Act) was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Applicable provisions outlined in the SECURE 2.0 Act will be adopted if elected and/or required. Plan amendments for these changes are not yet required.

Participant Contributions

Each participant may contribute up to 100% of their compensation, subject to Internal Revenue Service (IRS) limitations, on a pre- or post-tax basis through salary reductions.

At the participant's option, contributions may be invested in any or all of the investment options.

Participant contributions vest immediately. Employees who are over the age of 21, and have been employed for 30 days, are eligible to participate in the Plan. Plan entrance dates are the first day of the month coinciding with meeting the eligibility requirements.

The Plan automatically withholds 3% of compensation from employees who have not completed a salary deferral agreement by the time they become eligible to make salary deferrals. Participants may execute a salary deferral agreement at any time to select an alternative deferral amount or elect not to defer under the Plan. The Plan also includes an automatic escalation feature whereby participant deferral elections increase by 1% annually (up to a maximum salary deferral of 10%). Participants may elect to opt out of the automatic deferral escalation at any time.

Employer Contributions

The Plan has an employer match, which provides for a matching contribution of 25% of employee contributions up to 3% of compensation and 50% of employee contributions in excess of 3% of compensation up to 6% of compensation. Participants become eligible for an employer matching contribution after one year of service.

The employer can make a discretionary profit sharing contribution to the Plan for each Plan year as determined by resolution of the Board of Directors. No such contributions were made in 2024 and 2023.

Vesting in employer matching and profit sharing contributions is based on years of service. A participant is 100% vested after six years of service; vesting is gradual and begins after the second year of service.

1. Description of Plan (Continued)

Rollovers

The Plan allows for direct rollovers from other qualified plans. Any rollovers are maintained in a separate account for each participant and are invested in accordance with the investment strategy selected by each individual participant. All amounts credited to an employee's rollover account are 100% vested and non-forfeitable at all times.

Forfeitures

Forfeited nonvested accounts may be used to pay administrative expenses under the Plan at any time. Any forfeitures not used to pay administrative expenses under the Plan may be allocated as additional employer contributions or applied to reduce other employer contributions under the Plan. Forfeitures shall be used in the Plan year in which such forfeitures arise or in the following Plan year. Forfeitures used to reduce employer contributions and to pay administrative expenses were not material for the years ending December 31, 2024 and 2023. At December 31, 2024 and 2023, forfeited nonvested accounts included in net assets available for benefits were not material.

Distribution of Benefits

Any benefits payable under the Plan to a participant who has retired or terminated employment for any reason other than death, or who has reached the age of 59 ½ and obtained five years of service, shall be distributed to the participant as follows: vested account balances shall be distributed to the participant in a lump sum payment, and distribution of vested account balances that exceed \$5,000 require spousal consent, where applicable.

Participant Notes Receivable

Loans to participants are permitted under the Plan for hardship or financial necessity in an amount not to exceed the lesser of (1) one-half of the participant's nonforfeitable interest under the Plan or (2) \$50,000. Effective February 1, 2024, the Plan was amended to allow participants to obtain a loan for any reason.

New participant loans are issued at the Prime interest rate plus 1%. At December 31, 2024, interest rates on outstanding participant loans ranged from 4.25% to 9.50%, with various maturities through July 2044. Loan terms generally range from 1 to 5 years, with longer terms allowed for the purchase of a primary residence.

Participant Accounts

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts as investment options for participants.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options which in turn invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemics or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Investments

The Plan's investments are reported at fair value. See note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest.

Interest income is recorded when it is earned on the accrual basis. Loan related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are treated as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Contributions

Contributions from participants are recorded in the period in which payroll deductions are made. Employer matching contributions are recorded in the same period as the corresponding participant contributions. Employer discretionary contributions are recorded in the year of related eligible participant service.

Administrative Expenses

Plan administrative costs are paid by the Plan to the extent that they are not paid by Everett J. Prescott, Inc. (the Company). For the years ended December 31, 2024 and 2023, participants' accounts were assessed contract charges on a pro rata basis. Contract charges are based on the Plan's net assets and other administrative fees, such as loan processing fees, are charged directly to the participant accounts.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

For the purposes of recognition and disclosure in these financial statements, management of the Plan has evaluated subsequent events through September 30, 2025, which is the date these financial statements were available to be issued.

3. Information Certified by the Custodian

The Plan Administrator has elected the method of compliance as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted by such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by John Hancock, the custodian, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedule. The Plan Administrator has determined that the custodian meets the requirements of a qualified institution as defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

As of December 31, 2024 and 2023, and for the years then ended, John Hancock, custodian, has certified as complete and accurate the fair value of investments and the related investment income, participant notes receivable and the related interest income on participant notes receivable and the information contained in the supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024.

4. Fair Value Measurements

The Plan has adopted a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation method include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at net asset value, which is based on the quoted market prices of the underlying assets of the fund.

In accordance with Financial Accounting Standards Board Accounting Standards Codification Topic 820, *Fair Value Measurements*, certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. Therefore, there is no hierarchy required for the pooled separate accounts held by the Plan at December 31, 2024 and 2023.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The significant investment strategies of the pooled separate accounts measured at net asset value using the net asset value per share practical expedient are as follows:

Asset Allocation – Target Date: These funds are model portfolios that seek to provide a high total return through the balance of growth, income and capital conservatism through a mix of equity and fixed income exposures through the target retirement date, with a greater focus on income beyond the target date.

Stable Value: These funds seek to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term.

Income: These funds seek current income with capital appreciation and growth of income, primarily by investing in fixed income securities through broad sectors of the bond market and gaining exposure to various types of credit and interest rate risk.

Growth: These funds seek capital appreciation foremost by investing in equity securities across domestic and international markets. The secondary focus on these funds is current income.

Aggressive Growth: These funds seek rapid growth and capital appreciation through investing in domestic, international or emerging country equity markets, with a heavier concentration on riskier techniques than core growth strategies.

There are no unfunded commitments associated with the pooled separate accounts. Redemption is allowed on a daily basis with these investments.

5. Tax Status

A qualifying plan is one for which the employer may currently deduct contributions on its income tax return, the employee is not currently taxed on the contribution, and the plan income is not taxable. The Plan is a volume submitter profit sharing plan sponsored by Downeast Pension Services, Inc. The IRS has determined that the volume submitter plan is acceptable under Section 401 of the Internal Revenue Code (IRC) and has issued a favorable opinion letter dated June 30, 2020. The Plan has been amended subsequent to this date and the Plan Administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code (the Code).

5. **Tax Status (Continued)**

Management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

6. **Related Party Transactions**

The Plan's investments are managed by John Hancock. John Hancock serves as the Plan's custodian and recordkeeper. Therefore, transactions involving the Plan's investments qualify as party-in-interest transactions; however, they are exempt from prohibited transaction rules under ERISA.

Administrative fees paid to John Hancock, the custodian and recordkeeper, were approximately \$38,300 and \$30,800 in 2024 and 2023, respectively. Administration fees paid to Merrill Lynch, the Plan's current advisor, were approximately \$77,200 and \$60,900 in 2024 and 2023, respectively. In addition, participants notes receivable qualify as party-in-interest transactions.

7. **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA, as amended. In the event of Plan termination, participants will become 100% vested in their accounts.

8. **Reconciliation to Form 5500**

Participant notes receivable are reflected as a receivable on the financial statements, which is different from the Form 5500 presentations for 2024 and 2023. On Form 5500, notes receivable are classified as investments under the caption "participant loans."
