## Independent Auditor's Report

To the Plan Administrator  
Lincoln Park Zoological Society Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Lincoln Park Zoological Society Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

### Note 1 - Plan Description

The following description of Lincoln Park Zoological Society Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established by Lincoln Park Zoological Society (the "Plan Sponsor") under the provisions of Section 403(b) of the Internal Revenue Code. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was adopted by the Plan Sponsor as of April 10, 1985. The Plan was most recently amended as of September 1, 2021 to allow loans to be made available to all participants effective October 1, 2021.

#### **Coverage and Eligibility**

Employees are eligible to participate (elective deferrals only) in the Plan on the first day of the month following their hire date. Eligible employees must be expected to work 1,000 hours or more in their first full year of employment. Seasonal employees, such as summer workers, are not eligible to participate.

To be eligible to receive discretionary and nondiscretionary employer contributions, an employee must complete two years of service (as defined in the plan document). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended.

#### **Employee Contributions**

Eligible employees who do not elect otherwise are automatically enrolled in the Plan with a deferral contribution rate of 6 percent. Employees who do not elect otherwise will have their deferral contribution rate increased by 1 percent on each April 1 thereafter. The participant's deferral contribution rate will not be increased to an amount that exceeds 10 percent of the participant's compensation. Participants who take no action will have their deferrals placed in a target retirement date fund based on the participant's normal retirement date. Participants may contribute 100 percent of their gross compensation up to Internal Revenue Service (IRS) annual contribution limits. Deferrals may be made in whole percentages only. Each eligible active participant over the age of 50 may elect to contribute catch-up deferrals up to IRS annual deferral limits. Participants can change their deferral rate at any time during the year. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

All or a portion of elective deferral contributions can be Roth (post-tax) rather than pretax if desired by the individual participant.

#### **Employer Contributions**

The Plan Sponsor, as required, matches 100 percent of each eligible active participant's elective deferrals, limited to 3 percent of their compensation, as defined by the Plan. Discretionary contributions may be made for each plan year in an amount determined by the employer. An additional discretionary match was made by the employer during the period from January 1, 2024 to December 31, 2024. The discretionary match was 3 percent of the participants' compensation, as defined by the Plan, during this time frame.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Plan Sponsor's contributions and plan earnings (or losses) and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

### Note 1 - Plan Description (Continued)

#### ***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at a market rate. Principal and interest are paid ratably through monthly payroll deductions.

#### ***Benefit Payments***

Upon termination of service, death, disability, or retirement, a participant (or a participant's spouse or designated beneficiary, in the case of death) may receive 100 percent of the value of the participant's account. Distributions may be in the form of a lump-sum payment or installment payments. Participants may also request distributions upon attainment of age 59½.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

#### ***Vesting***

Participants are 100 percent vested in their account balances, including all contributions and earnings thereon. No contributions are subject to a vesting schedule.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal) or its affiliates. Principal is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. Additionally, the Plan Sponsor pays certain expenses on behalf of the Plan and does not seek reimbursement.

#### ***Termination***

While it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation***

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive unallocated contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

All other investments are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### *Administrative Expenses*

Various administrative costs are paid by the Plan Sponsor.

#### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### *Subsequent Events*

The financial statements and related disclosures include evaluation of events up through and including October 10, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Principal holds the Plan's investments and participant notes receivable and executes all investment transactions. The investment and participant notes receivable balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Principal.

### Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

### Note 4 - Fair Value Measurements (Continued)

The Plan measures mutual funds at fair value on a recurring basis. The fair value of mutual funds is based primarily on Level 1 inputs, as described above.

### Note 5 - Unallocated Investment Contract

#### ***Objectives***

The key objectives of the Principal Fixed Income Guaranteed Option (PFIGO) are to provide preservation of principal, maintain a stable interest rate, and provide daily liquidity at contract value for participant withdrawals and transfers in accordance with the provisions of the Plan.

#### ***Nature of Investment***

PFIGO is a single-group, fixed, unallocated annuity contract supported by the Principal general account and offers guaranteed crediting rates based on the following:

- The totality of investments previously made by participants
- Their anticipated payout timing requirements
- The current investment climate
- Contractual minimum interest rate guarantees
- Competitive requirements
- Required return on invested capital supporting the product

The interest crediting rate is based on a formula agreed upon with the issuer, but it may not be less than 0.00 percent. Such rates are declared monthly.

#### ***Events that Limit the Ability of PFIGO to Transact at Contract Value***

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) material adverse change to the provisions of the Plan, or (iii) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is not probable. There are no events that allow the issuer to terminate the contract and that require the Plan Sponsor to settle an amount different than contract value paid either within 90 days or over time.

#### ***Issuer-initiated Contract Termination***

The issuer may not terminate the contract before its maturity date unless the balance of the contract is zero and no current deposit arrangements have been made.

As described in Note 2, because the contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets attributable to the investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

### Note 6 - Tax Status

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service. The volume submitter plan has received a favorable notification letter from the IRS dated March 31, 2017. The Plan has not individually sought its own determination letter.
