We have performed audits of the financial statements of the HealthComp, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). NOTES TO FINANCIAL STATEMENTS

Note A. Description of Plan

The following is a summary of certain provisions of the HealthComp, Inc. 401(k) Plan (the "Plan"). Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan that covers substantially all employees of HealthComp, Inc. (the "Company") as described by the Plan. There is a minimum age requirement of 18. The Plan became effective January 1, 1998. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions – Participants may elect to contribute on a pre-tax or Roth basis from 1% up to 100% of their compensation subject to certain limitations of the Plan and the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). The Company has elected to make annual "safe harbor" contributions to the Plan equal to 3% of each participant's compensation for the Plan year. All new employees will be automatically enrolled in the plan at 2% with an automatic increase of 2% per Plan year not to exceed 10%.

The Plan also allows the Company to make annual discretionary profit sharing contributions using a formula as defined by the Plan. The profit sharing contribution was \$-0- for 2024 and 2023.

Participant Accounts/Vesting – Participant and employer contributions are invested in various investment funds in proportions selected by each participant. Dividends, interest, and other income earned are reinvested by the fund managers in the fund for which such income was received. Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of Plan earnings and expenses based on account balances maintained or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants are at all times 100% vested in their accounts.

Notes Receivable From Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants may have no more than two loans outstanding at any time. The loans are secured by the balance in the participant's account and the loan interest rate, determined yearly, is set generally at 1% above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits – A participant or beneficiary upon severance of employment due to death, disability, termination, or retirement may elect to receive the current value of his/her account balance in the form of a lump-sum cash payment. The Plan also allows for in-service distributions upon attaining age 59½, disability, deemed severance distributions, and hardship withdrawals, subject to certain limitations. Additionally, the Plan stipulates that if a participant is terminated and has a vested balance below \$5,000, he/she will receive an involuntary distribution.

Note A. Description of Plan (Continued)

Termination Provisions – Although it has not expressed any intent to do so, the Company has the right, by action of the Board of Directors, to discontinue its contributions at any time and to terminate the Plan at any time, subject to provisions set forth in ERISA. In the event of termination of the Plan, any unallocated assets of the Plan should be allocated to participant accounts and distributed in accordance with the Plan document.

Note B. Summary of Significant Accounting Policies

Basis of Accounting – The Plan uses the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Investment assets are presented at fair value. All other transactions are recorded using the cash method of accounting.

Benefit Payments – Benefit payments are recorded when paid.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Empower Trust Company LLC ("Empower") (the "Trustee" and "Custodian"). See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest and dividends are recorded when received.

Use of Estimates – The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Administrative Expenses – Fees of the Plan are paid by the Company or the Plan at the discretion of the Company. In addition, certain transactions and account maintenance fees are charged to the affected participants. Commission credit payments are made from excess revenue generated by the Plan through fund revenue or fees that are made available to the Plan. Revenue sharing payments in the amount of \$20,163 and \$18,351 were received by the Plan during 2024 and 2023, respectively, which were utilized for fees and are recorded net with administrative expenses in the statements of changes in net assets available for benefits (modified cash basis) for the years ended December 31, 2024 and 2023. The Company monitors the payments received by the Plan service providers to ensure that they are used properly for qualifying Plan administrative and operating expenses.

Note B. Summary of Significant Accounting Policies (Continued)

Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Subsequent Events – The Plan has evaluated subsequent events and transactions for potential recognition and presentation through the date the financial statements were available to be issued, October 3, 2025.

Note C. Unaudited Information

The Plan's management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, management received a certification from Empower Trust Company LLC, the Trustee of the Plan, acknowledging the completeness and accuracy of all investments and notes receivable reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment and loan interest activity reflected in the statements of changes in net assets available for benefits for the years then ended, the supplemental schedule as of December 31, 2024, and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

Note D. Fair Value Measurements

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

Level 1 – Quoted market prices in active markets for identical assets and liabilities.

Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data.

Level 3 – Unobservable inputs in which little or no market data exists.

The following is a description of the valuation methodologies used for assets of the Plan measured at fair value at December 31, 2024 and 2023:

- The investment in the common/collective trust funds is valued at their closing net asset value ("NAV"). The NAV is based primarily on observable inputs, the market value of the underlying investments, and is classified as Level 2.
- Registered investment companies: Valued at quoted closing market price reported in active markets for identical investments, and are classified as Level 1.

Note D. Fair Value Measurements (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the report date.

Note F. Tax Status

The volume submitter document on which the Plan is based obtained its latest opinion letter on November 14, 2022, in which the Internal Revenue Service stated that the document, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since adopting this document. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.
