Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Salary Thrift Savings Plan for Employees of Lapham-Hickey Steel Corp. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 DESCRIPTION OF PLAN

The following description of The Salary Thrift Savings Plan for Employees of Lapham-Hickey Steel Corp. (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, originally effective July 1, 1984, established to provide deferred compensation benefits to eligible employees of Lapham-Hickey Steel Corp. (the Employer). The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective July 1, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees who have reached age 18 are eligible to participate in employee deferrals and Employer matching contributions on the first day of the month following the completion of three months of service. Employees covered by a collective bargaining agreement that have not bargained for retirement benefits and leased employees, as well as individuals employed pursuant to a work and study release program maintained by a state, are not eligible to participate.

Subsequent to December 31, 2024, the Employer acquired Alkar Steel. The Plan was amended to credit prior service with Alkar Steel for purposes of determining eligibility and vesting for those employees who have commenced employment with the Employer as of January 1, 2025, and remained employed as of February 1, 2025.

Contributions

Participants may make pre-tax and/or after-tax voluntary contributions up to 75% of his/her compensation, subject to limitations imposed by the Internal Revenue Code (IRC). Eligible participants may elect to have a percentage of their compensation contributed as Roth contributions to the Plan and also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants direct the investment of contributions into various options offered by the Plan. Participants that attain age 50 before the end of the Plan year are eligible to make catch-up contributions. For the year-ended December 31, 2024, the Company matching contribution was 100% of the first 4% of eligible compensation deferred that a participant contributes to the Plan. Employee catch-up contributions are not eligible for the Employer match.

Participant Accounts

Each participant's account is credited or charged with the participant's contributions, the Employer's contributions, and investment earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in his/her voluntary contributions plus actual earnings thereon. Vesting in the Employer's matching contributions and earnings thereon is based on years of continuous service. A participant becomes fully vested after three years of service, with no vesting prior to three years of service. The nonvested balance is forfeited upon termination of service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Benefit Payments

Upon termination of service due to death, disability, retirement on or after the normal retirement age, or termination of service due to other reasons, a participant may receive the value of the vested interest in his/her account as a lump-sum distribution. The Plan's provisions also provide for in-service withdrawals if a participant reaches age 59½ and withdrawals in the event of financial hardship, as defined by the Plan. Terminated participants with an account balance of less than \$7,000 are subject to involuntary cash-outs.

Forfeited Accounts

Forfeited nonvested accounts are used to reduce Employer contributions. Forfeited nonvested accounts totaled \$18,880 and \$54,300 as of December 31, 2024 and 2023, respectively. Forfeitures in the amount of \$106,080 were used to reduce Employer contributions for the year ended December 31, 2024.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses are paid by the participants out of the assets of the Plan and by the Employer. Although the Employer has elected to pay some administrative costs, it is not obligated to do so. If the Employer ceases to pay all or part of these costs in the future, they will be paid out of the assets of the Plan. Expenses paid directly by the Company are excluded from these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through September 26, 2025 **September 26, 2025**, the date the financial statements were available to be issued.

NOTE 3 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 3 FAIR VALUE OF INVESTMENTS (CONTINUED)

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Collective Trust Fund – Valued at the net asset value (NAV) of units of the trust company collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 CERTIFICATION OF INVESTMENT INFORMATION

Empower Trust Company, LLC and Empower Annuity Insurance Company of America, (collectively referred to as Empower), the qualified institutions of the Plan, have supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information presented on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer reserves the right to alter, amend, or terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in his/her accounts. Any unallocated assets of the Plan would be allocated to participant accounts and distributed in such a manner as the Employer may determine.

NOTE 6 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and a collective trust fund managed by Empower Trust Company, the insurance company as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees paid to the insurance company, as reflected in the statements of changes in net assets available for benefits, are also party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter dated November 14, 2022, received from the Internal Revenue Service (IRS) indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
