## INDEPENDENT AUDITOR'S REPORT

To the Plan Participants and Plan Administrator  
Novvia Group 401(k) Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Novvia Group 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Novvia Group 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Novvia Group 401(k) Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Novvia Group 401(k) Profit Sharing Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

1. DESCRIPTION OF THE PLAN

The following description of Novvia Group 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, which is available from the Plan Administrator.

General

Effective January 1, 2023, the Plan changed its name to Novvia Group 401(k) Profit Sharing Plan and added Container Supply, LLC, Fox Valley, LLC, Rhino Container, LLC, Silver Spur, LLC, Ampac, LLC, Southern Container, LLC, and Inmark Container, LLC, as participating employers. During 2023, the Plan added Drum Acquisition, LLC, and Northern Container as participating employers. As a result of this transaction, the assets of the employees of Container Supply, LLC, and Inmark Container, LLC, were transferred into the Plan.

The Plan is a defined contribution plan for employees of C.L. Smith Company, Container Supply, LLC, Fox Valley, LLC, Rhino Container, LLC, Silver Spur, LLC, Ampac, LLC, Southern Container, LLC, Inmark Container, LLC, N2it Containers, LLC, Drum Acquisition, LLC, and Northern Container that have attained the age of 19 and have completed three months of service. The Plan is a salary reduction plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0.

Contributions

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined by the Plan, not to exceed certain dollar limits established by the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company will make a safe harbor matching contribution equal to 100% of employee salary deferrals not to exceed 3% of compensation plus 50% of salary deferrals between 4% and 5% of compensation for participants that have completed one year of service. Additionally, the Company may make a discretionary nonelective contribution and additional matching contributions to the Plan.

Participant accounts

Each participant's account is credited with the participant's deferral and rollover contributions, and allocations of (a) the Company's matching and profit-sharing contributions, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined.

Vesting

Participants shall at all times be one hundred percent (100%) vested in salary deferral, rollover, and the Company's safe harbor matching contributions plus actual earnings thereon.

The vesting percentage on nonelective contributions and additional matching contributions is determined under the following schedule:

Notes receivable from participants

Participants may borrow from their investment accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates. Loan terms range from one to five years, or longer for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions. Interest rates ranged from 4.25% to 9.50% and mature through August 2029 as of December 31, 2024.

Payment of benefits

The Plan provides that a participant's vested interest in the Plan will be distributed to the participant upon retirement, total disability or death. Employees terminating employment with the Company for other reasons are entitled to their vested interest in the Plan. Participants with elective deferral contributions in excess of \$5,000 may elect to defer distribution to a future date as more fully described in the Plan. Participants may elect to (a) receive a single lump sum amount equal to their vested account balance, or (b) have all of his or her distributions paid in the form of a direct trustee-to-trustee transfer to another eligible retirement plan designated by the participant.

Payment of benefits (continued)

Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service ("IRS").

Forfeitures

Upon termination of employment, participants forfeit their non-vested balances in nonelective contributions and additional employer matching contributions. All forfeitures in the Plan are used to either pay expenses of the Plan or allocated to reduce contributions made by the Plan Sponsor. The Company did not use any forfeitures to reduce expenses or contributions for the years ended December 31, 2024 and 2023. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,221 and \$1,190, respectively.

Plan Mergers

Effective January 1, 2023, the assets of the Container Supply, Inc. Safe Harbor Plan were merged into the Plan. Net assets available for benefits of \$449,665 attributable to employees of Container Supply, Inc. were transferred into the Plan in March 2023.

Effective January 1, 2023, the assets of the Adams Keegan Retirement Savings Plan were merged into the Plan. Net assets available for benefits of \$3,749,119 attributable to employees of Inmark Container, LLC, were transferred into the Plan in July 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Use of estimates in financial statement presentation

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect reported amounts of net assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor, and the Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of benefits

Benefit payments to participants are recorded upon distribution.

Administrative expenses

Administrative expenses are paid primarily from participant accounts. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events

The Plan has evaluated all subsequent events through October 10, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan amended to allow for the participation of the employees from Liquid Bottles. These employees were granted their vesting period from Liquid Bottles.

3. CERTIFICATION BY PLAN TRUSTEE

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained a certification from Alerus Financial, N.A. ("Alerus"), the Trustee stating that all of the information provided by the Trustee as of December 31, 2024 and 2023, is complete and accurate. Information as to the investments in the accounts of the Trustee, investment income, notes receivable from participants, interest on notes receivable from participants, and all information in the accompanying supplemental Schedule of Assets (Held at End of Year) are presented in reliance solely upon this certification.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

4. FAIR VALUE MEASUREMENTS (continued)

*Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds* – Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

*Brokerage account* – Common stock, mutual funds and money market accounts in the self-directed brokerage accounts are at fair value based on published market quotations from individual investments composing the brokerage accounts. Such assets are classified as Level 1.

6. PLAN TERMINATION

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

7. TAX STATUS

The Plan Agreement is based on an Alerus Financial, N.A. prototype plan. The prototype plan agreement received an opinion letter dated June 30, 2020, from the Internal Revenue Service ("IRS") stating that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since its adoption, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defined parties-in-interest similarly to the definition of a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Management did not identify any related parties to the Plan that were not also considered to be parties-in-interest.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan expenses may be paid by the Company. Fees paid by the Plan to the Trustee and plan advisor during 2024 and 2023 were \$75,220 and \$58,099, respectively.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. DELINQUENT PARTICIPANT CONTRIBUTIONS

As of December 31, 2024 and 2023, the Company had uncorrected, late contributions totaling \$430,969 and \$230,412, respectively from the Plan years ended December 31, 2024, 2023 and 2022. The Company will utilize the Department of Labor Voluntary Fiduciary Correction Program calculator to determine lost earnings to self-correct these delinquent contributions during 2025.
