We have performed audits of the financial statements of Axia Women's Health 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## 1. Description of Plan

The following description of the Axia Women's Health 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan established effective January 1, 2012, as restated November 1, 2023. The Plan covers all employees, excluding leased employees, employees governed by a collective bargaining agreement unless such agreement expressly provides for participation in the Plan, nonresident aliens and independent contractors, of WHCG Holdco, LLC d/b/a Axia Women's Health (the Company). Participants are eligible for the employer matching and nonelective contributions after one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Company is responsible for oversight of the Plan. The Axia Women's Health 401(k) Profit Sharing Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective April 24, 2023, the Seven Hills OB-GYN Associates, Inc. Profit Sharing Plan and the Obstetrics & Gynecology of Indiana, P.C. 401(k) Profit Sharing Plan and Trust merged into the Plan.

### Contributions

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants will have their deferral rate increase by 1% on the anniversary of their enrollment date until their deferral rate reaches 5%. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### Discretionary Matching Contributions

Discretionary matching contributions equal to a percentage of each participant's deferred contribution may be made by the Company. The exact amount is determined each year by the Company. No such contributions were made during 2024 and 2023.

### Other Discretionary Contributions

Additional discretionary qualified nonelective contributions may be made by the Company. No such contributions were made during 2024 and 2023.

### **Discretionary Safe Harbor Contributions**

Each plan year the Company may contribute a safe harbor nonelective contribution, a safe harbor basic matching contribution or a safe harbor enhanced matching contribution to each qualifying participant, as defined. In 2024 and 2023, the Company contributed a dollar-for-dollar safe harbor basic matching contribution on up to 3% of compensation and then a fifty cents on the dollar safe harbor basic matching contribution from 3% to 5% of compensation to each qualified participant, as defined. The Company's safe harbor contributions were \$6,657,212 and \$6,904,654 net of forfeitures, for 2024 and 2023, respectively, of which \$6,646,957 and \$6,891,195 is included in employer contribution receivable at December 31, 2024 and 2023, respectively.

### **Discretionary Profit Sharing Contributions**

Discretionary profit sharing contributions may be contributed at the option of the Company. The Company's profit sharing contributions were \$5,788,089 and \$6,217,660 for 2024 and 2023, respectively, of which \$5,788,055 and \$6,217,404 is included in employer contribution receivable at December 31, 2024 and 2023, respectively.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their contributions and the Company's discretionary safe harbor contribution, plus actual earnings thereon. Participant vesting in the Company's discretionary matching contribution, other discretionary contribution, and discretionary profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of service. Participants are fully vested after three years of credited service.

### **Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by 50% of participant's vested account and bear interest at rates which are commensurate with local prevailing rates. Principal and interest is paid ratably through payroll deductions. Terms range from one to five years or greater for the purchase of a primary residence.

### **Payment of Benefits**

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or a roll over payment to another qualified account or a combination of both, as elected by the participant. If the participant does not make an election prior to the designated time period and the present value of the participant's vested account balance is less than \$7,000, the account will be rolled over to an individual retirement plan designated by the plan administrator. Hardship distributions are permitted under certain circumstances as outlined in the plan document.

## Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$63,958 and \$35,156, respectively. These accounts will be used to first restore account balances where restoration contributions have been made and then may be used to pay plan expenses and reduce Company contributions. During 2024 and 2023, \$119,692 and \$180,466 of forfeitures were used to reduce Company contributions to the Plan, respectively. During 2024 and 2023, \$1,208 and \$25,103 of forfeitures were used to pay plan expenses, respectively.

## 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Axia Women's Health 401(k) Profit Sharing Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

### Payment of Benefits

Benefits are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

## Recent Regulatory Update

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

## Subsequent Events

Subsequent events were evaluated through October 10, 2025, the date the financial statements were available to be issued.

## 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage account:* The self-directed brokerage account consists of exchange traded funds, common stock and preferred stock. Exchange traded funds, common stock and preferred stock are valued at the closing price reported on the active market on which the investment securities are traded.

*Collective trust funds:* The collective trust funds are valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### 4. Concentrations

## **6. Related-Party and Party in Interest Transactions**

Certain plan investments are managed by Fidelity, the trustee of the Plan, and therefore, these transactions qualify as party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

## **7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

## **8. Tax Status**

The Plan adopted a pre-approved plan offered by Sponsel CPA Group LLC. The pre-approved plan received an advisory letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
