#### 1. DESCRIPTION OF THE PLAN

The following description of Southeast Mortgage of Georgia, Inc. 401(k) Plan (the “Plan”), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- A. *General.* The Plan is a defined contribution plan covering all eligible employees of the Company. Employees must be 18 years of age to be eligible; there are no service eligibility requirements other than 3 months is required to receive matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).
- B. *Contributions.* Each year, participants may contribute up to 100% of pretax annual compensation as defined by the Plan, except that no employee may make annual tax-deferred contributions in excess of amounts provided by the Internal Revenue Code. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Company may match a percentage of each participant’s current pre-tax contribution at its discretion.
- C. *Participant Accounts.* Each participant’s account is credited with the participant’s deferral contribution and allocations of (a) the Company’s contribution (if any) and (b) plan earnings including administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- D. *Vesting.* Participants are immediately vested in their salary deferral contribution plus actual earnings thereon. Vesting in the Company’s contribution portion, if any, of their account plus actual earnings thereon is based on years of continuous service; a participant is 100% vested after six years of credited service with the vesting percentage accruing ratably each year after year 2.
- E. *Payment of Benefits.* Distributions from the Plan are made in the form of a lump sum of a Participant’s entire vested account balance or a single sum distribution of a portion of the Participant’s vested account balance. Optional forms of payment available upon termination of employment include lump sum distribution of entire vested account balance or single sum distribution of a portion of the vested account balance.

#### 1. DESCRIPTION OF THE PLAN (Continued)

F. *Forfeited Accounts.* Forfeitures may be used to reduce plan expenses. No forfeitures were used to reduce plan expenses in 2024.

#### 2. SUMMARY OF ACCOUNTING POLICIES

A. *Basis of Accounting.* The financial statements of the Plan are prepared under the accrual method of accounting.

B. *Payment of Benefits.* Benefit payments are recorded when paid.

C. *Investment Valuation and Income Recognition.* Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. *Use of Estimates.* The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

E. *Participant loans.* Participants may borrow from their fund accounts up to fifty percent (50%) of their vested account balance, not to exceed \$50,000. The loans are secured by the balance in the participant's account and bear interest based on a fair rate as determined by Plan administration based on prevailing interest rates. Principal and interest is paid ratably through payroll deductions.

#### 3. INVESTMENT CONTRACT WITH TRUSTEE

The Plan has entered into an investment contract with Ascensus Trust Company. Funds are participant-directed into investment funds. The investment funds are managed either by external mutual fund companies or by Ascensus Trust Company, and the accounts are included in these financial statements at fair market value as reported by Ascensus Trust Company.

### 5. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy under FASB ASC 820 are described below:

Basis of Fair Value Measurement:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability; Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following describes the valuation methodologies used for assets measured at fair value on a recurring basis. The techniques utilized in estimating the fair values of financial instruments are reliant on the assumptions used. Care should be exercised in deriving conclusions based on the fair value information of financial instruments presented below. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Fair value estimates are made as of a specific point in time, based on available market information and judgments about the financial instrument. Such estimates do not consider the tax impact of the realization of unrealized gains or losses. In addition, the disclosed fair values may not be realized in the immediate settlement of the financial instrument.

*Mutual Funds* – The mutual funds are held as individual plan assets. The mutual funds have publicly available prices that are quoted daily in active markets. Lifecycle funds are managed based on a target date. Due to similar valuation techniques, they are classified as mutual funds.

*Money Market Fund* – The money market fund is held as an individual plan asset, has a principal value of \$1 per unit and has an available price quoted daily in an active market.

The preceding described methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
