Opinion

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of the Buehler's Fresh Foods Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Styx Holding Corp. initially established the Plan, effective October 1, 2017, as Buehler's Fresh Foods Employee Stock Ownership Plan. The Plan provides employees of Styx Holding Corp. and its subsidiary, Styx Acquisition LLC (together, the "Company"), who meet certain requirements as to length of service, with a method of acquiring a stock ownership interest in the Company and accumulating their stock until retirement or as otherwise described in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Administration

The Plan is administered by an administrative committee ("ESOP Committee") whose members are designated by the Board of Directors of the Company.

Eligibility and Participation

Employees of the Company are generally able to participate in the Plan upon the later of the employee's date of hire or attainment of age 21.

Contributions

Contributions to the Plan are at the discretion of the Board of Directors of the Company, are determined annually and may be made in cash or shares of Company stock. During 2024, the Company made a cash contribution of \$606,724. In addition, the Company made a stock contribution of 996 shares with a fair market value of \$200,000, which was recorded as a receivable at December 31, 2023. The per share value of the stock contribution was determined based on the value of the outstanding stock excluding the stock contribution at the end of the year.

Participant Accounts

Separate accounts are maintained for each participant. These accounts are credited with such participant's pro-rata share of the Company's contributions and investment earnings. Allocations are based on relative compensation or account balances as defined. Only those participants who are eligible employees of the Company on the last day of the Plan year will receive an allocation of the contribution. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. At December 31, 2024 and 2023, all assets of the Plan were fully allocated.

Diversification

Participants who are at least age 55 with at least ten years of participation in the Plan may elect to diversify a portion of the shares allocated to their account. Diversification is offered to participants over a 6-year period. Participants may diversify up to 25% of the shares during the first five years and up to 50% in the sixth year, less any previous shares diversified. Participants who elect to diversify may directly rollover to another qualified plan or take a cash distribution.

Note 1. Description of the Plan (Continued)

Vesting

The vesting schedule under the Plan with respect to participants' accounts is as follows:

Generally, an employee will be credited with a "year of service" for each Plan year in which the employee completes 1,000 hours of service. Participants become fully-vested upon reaching normal retirement age or in the event of death or disability.

Payment of Benefits

The Plan provides that a participant's vested account balance is to be distributed upon termination of employment, at the time and in the manner determined by the ESOP Committee in accordance with the plan document. A participant with an account balance greater than \$5,000 may not receive the accumulated account balance without the participant's consent. Distribution of a participant's vested account balance may begin no later than December 31 of the year following the year of normal retirement (age 65), disability or death. If a participant terminates for any other reason, distribution may commence no later than December 31 of the sixth year after termination. The participant's account balance may be paid either in a lump-sum or in installments over a period generally not to exceed five years. Distributions are to be made in cash.

Forfeitures

Forfeitures of nonvested account balances are allocated to the accounts of the remaining eligible participants. During 2024, 1,238.9438 of forfeited shares and \$1,055 were allocated in accordance with the Plan provisions.

Plan Termination

The Company has no intention of terminating the Plan; however, the Company reserves the right to terminate the Plan at any time. If the Plan is terminated, all participants will automatically become fully vested and entitled to their total account balances under the Plan.

Voting Rights

Except under certain circumstances as specifically outlined in the Plan agreement, the shares of Company common stock held by the Plan shall be voted by Great Banc Trust Company, the Trustee of the Plan, in such manner as directed by the ESOP Committee.

Note 2. Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Note 2. Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan's investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market and credit risks, as well as assumptions based on earnings, cash flows and other such techniques. Due to the level of risk associated with the investment in the Company's common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the Company's common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. The common stock of the Company is not publicly traded. The investment in common stock of the Company is reported at the fair value of the stock as determined annually by an independent appraisal from Pendo Advisors as of the last business day of the year. See Note 4 for a discussion of fair value measurements.

The change in the difference between current value and the cost of investments is reflected in the statement of changes in net assets available for benefits as net depreciation in fair value of investments. The cost of securities sold is based on the average cost of the securities. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

All expenses of maintaining the Plan are paid by the Company.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

Note 3. Trustee of the Plan

The Plan's assets, which consist primarily of Styx Holding Corp. common stock, are held by Great Banc Trust Company as Trustee of the Plan.

Any Company contributions are held and managed by the Trustee, which is responsible for investing the cash received along with any interest and dividend income earned and for making distributions to participants.

Note 4. Fair Value Measurements

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

- Level 1 – Quoted market prices in active markets for identical assets and liabilities
- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data
- Level 3 – Unobservable inputs for which little or no market data exists

The following is a description of the valuation methodologies used for plan assets measured at fair value:

- *Styx Holding Corp. common stock*: Valued at the share price determined annually by an independent appraisal as of each Plan year end. The appraisal was based upon a combination of the market and income valuation techniques. The appraiser took into account historical and projected cash flow and net income, market comparables and the fair value of assets and liabilities. Plan management has concluded that a market participant would also recognize a discount for lack of marketability.

The valuation process involves the selection of an independent appraiser each year by the ESOP Committee and the Plan's Trustee. The Plan's management accumulates the data for the appraiser from the audited financial statements of the Company and other financial and operational reports. The appraiser prepares a preliminary report, which Plan management and the Plan's Trustee review in detail. After review, discussion and revisions as deemed necessary, the Plan's Trustee approves the independent appraisal. The Company's common stock is classified as Level 3.

- *Money market fund*: Valued based on the quoted closing market prices in active markets for identical instruments and is classified as Level 1.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related Party Transactions

The Plan invests in Company common stock which is a related party transaction. As described in Note 2, the Company pays all administrative expenses of the Plan.

Note 6. Administration of Plan Assets

The Plan's assets, which consist primarily of Company common stock, are held by the Trustee of the Plan.

Company contributions are held and managed by the Trustee, which invests cash received and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note 7. Income Tax Status

The Plan has adopted a pre-approved plan document. This document has obtained an opinion letter dated June 30, 2020 from the Internal Revenue Service ("IRS") in which the IRS stated that the document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since the adoption of the pre-approved plan document. However, the plan administrator and the Plan's tax counsel believe that the Plan is being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

The plan administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.
