### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

The Plan is a defined contribution plan, effective October 1, 1990, covering all eligible employees of employers considered part of the control group of Sage Hospitality Resources, LLC (the "Company"). All employees who have attained the age of 20 and have completed at least two months of service are eligible to participate in the Plan, excluding leased employees and employees covered by a collective bargaining agreement that provides retirement benefits under a program different from the Plan. Participation is voluntary and effective the first day of each month following the date the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Administration**

The board of directors of Sage Hospitality Resources, LLC administers the Plan. Through April 2024, Minnesota Life Insurance Company (Minnesota) served as the custodian and investment manager. Effective May 1, 2024, the Company changed plan trustees and the Plan was amended and restated. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal) now functions as trustee and investment manager. Investment management fees and custodian/trustee fees are paid by the Plan in accordance with the plan agreement.

#### **Benefit Payments**

On termination of service due to termination of employment, death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

The Plan allows in-service distributions and partial distributions to participants age 60 or older who have not terminated employment with the plan sponsor. Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrators must approve any such hardship withdrawals. Furthermore, the Plan will make mandatory distributions for participants who incur severance of employment with an account balance of \$5,000 or less.

#### **Contributions**

The Plan provides pretax and post-tax (Roth) employee salary deferral contributions up to a maximum of 90 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan allows for discretionary matching contributions determined at the beginning of the plan year. During 2024, the Company matched 75 percent of the participant's contribution up to 3 percent of the employee's deferred compensation. Additionally, there is a supplemental company contribution for certain collectively bargained employees who have completed 1,000 hours during the plan year and are still employed on December 31 of up to \$1.00 per hour worked, up to a maximum of 40 hours per week.

### Note 1 - Plan Description (Continued)

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. A participant is 100 percent vested in the employer match portion of their account after five years of credited service. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service beginning at 20 percent after one year of service and increasing 20 percent for each year of continuous service thereafter.

#### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$278,678 and \$206,626, respectively. Forfeitures of approximately \$278,000 for the year ended December 31, 2024 were used by the Plan to pay administrative expenses.

#### ***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. Participants may not have more than one loan outstanding, and loans may not exceed a five-year term unless used for the purchase of a primary residence. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 4.25 percent to 9.50 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest are paid ratably through payroll deductions or monthly ACH (Automated Clearing House) payments. The notes receivable mature at various dates through May 2033.

#### ***Party-in-interest Transactions***

Certain plan assets are investment funds and participant notes receivable managed by Minnesota and Principal or their affiliates. Principal is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

### Note 2 - Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The Plan's financial statements are prepared under the accrual basis of accounting.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### ***Investment Income***

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible and recorded as a deemed distribution.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### Note 3 - Certified Information

In 2024, the Plan changed its trustee from Minnesota to Principal (collectively, the "Trustee"). The Trustee of the Plan held the Plan's investments and participant notes receivable and executed all related transactions during the period under audit. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

### Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

### Note 6 - Fair Value Measurements

Accounting standards require certain assets and liabilities to be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### **Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### **Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### **Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

#### **Mutual Funds**

Mutual funds are valued at quoted prices reported in active markets.

**Note 6 - Fair Value Measurements (Continued)**

***Common Collective Trust***

The common collective trust funds are valued at net asset value per share or its equivalent of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

***Pooled Separate Accounts***

The pooled separate accounts are valued at net asset value per share or its equivalent of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments.
