## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
**Southwest Airlines Federal Credit Union Pension Plan**

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Southwest Airlines Federal Credit Union Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the statement of accumulated plan benefits as of December 31, 2023, and the related statement of changes in accumulated plan benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Southwest Airlines Federal Credit Union Pension Plan and to meet our ethical responsibilities in accordance with the ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Southwest Airlines Federal Credit Union Pension Plan's ability to continue as a going concern for one year after the date the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## Auditor's Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing audits in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

### Other Matters - Supplemental Schedules Required by ERISA

The supplemental schedules of assets (held at end of year) and reportable transactions are presented for purposes of additional analysis and is not a required part of the financial statements, but is supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Note 1 – Description of the Plan

#### General

The Plan was established by Southwest Airlines Federal Credit Union. The Plan provides for retirement, disability, and survivor death benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description of the Southwest Airlines Federal Credit Union Pension Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### Administration

The Plan Sponsor is Southwest Airlines Federal Credit Union (Plan Administrator). The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator has formed a committee made up of Credit Union officers and members of the human resources department that determines the appropriateness of the Plan's investment offerings and monitors investment performance and fees. The Plan's Investment Custodian is Standard Insurance Company. The Investment Custodian holds all of the Plan's assets and executes all of the Plan's transactions. Standard Retirement Services, Inc. provides actuarial services to the Plan. Standard Insurance Company also performs participant recordkeeping services. The Plan's Trustees are also officers of the Credit Union.

#### Eligibility

The Plan covers any eligible employee of Southwest Airlines Federal Credit Union (the Credit Union) who has completed 6 consecutive months of service. Participants enter the Plan on the first day of the plan year.

#### Pension Benefits and Vesting

Plan participants are subject to five-year cliff vesting. Employees with five or more years of service and who are at least the normal retirement age (65 with 5 years of participation or 60 with 30 years of vesting service) are entitled to a retirement benefit determined based on a benefit formula equal to 50% of the employee's average monthly compensation. For participants who have earned less than 25 years of service as of the end of the plan year in which they attain normal retirement age, the percentage above shall be reduced by 1/25<sup>th</sup> for each such year of service less than 25. The Plan provides that if a participant terminates employment with 5 years of vested service and the participant's vested interest in the Plan does not exceed \$5,000, the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Plan Administrator will pay the distribution in a direct rollover to an individual retirement plan designated by the Plan Administrator.

Participants who terminate for reasons other than death or disability without five years of vested service will forfeit their benefits. Benefits are paid in the form of an annuity. Participants are 100% vested upon completion of five years of credited service. The Plan permits early retirement for participants after age 55 and ten or more years of service. A reduced retirement benefit will result from early retirement. The early retirement is equal to the employee's vested accrued benefit payable in the normal form but reduced by 0.25% for each month which the participant's annuity starting date precedes the participant's attainment of normal retirement age. Employees will receive their pension benefits in the form of a qualified joint and survivor annuity, or in any other form as agreed upon between the employee, the employer, and Standard Insurance Company.

### Death and Disability Benefits

If a vested participant dies, a death benefit equal to the present value of the participant's accumulated pension benefits is paid to the employee's beneficiary. Disability benefits are payable in the same manner as an early retirement benefit.

### **Note 2 – Summary of Significant Accounting Policies**

#### Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting. Income from investments is recorded when it is earned. Contributions are recorded when authorized and in the period to which they pertain. Expenses are recorded in the accounting period in which they are incurred.

#### Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Investment Custodian and Investment Advisers. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Fees and Expenses

Professional fees incurred to operate the Plan, such as attorney and audit fees are paid directly by the Plan Sponsor. Other fees and expenses relating to the day-to-day plan operations are paid by the Plan. These fees are recorded when paid. Direct fees for custodian and actuarial services are paid by the Plan and are also included in administration expenses. Investment related expenses are included in the net appreciation or depreciation in fair value of investments.

### Payment of Benefits

Benefit payments to participants and beneficiaries are recorded at the time of distribution.

### Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those estimated future periodic payments that are attributable under the Plan's provisions to services rendered by the employees to the valuation date. Accumulated plan benefits include benefits to be paid to retired or terminated employees or their beneficiaries, and current employees or their beneficiaries.

Actuaries from Standard Retirement Services, Inc. estimated the actuarial present value of accumulated plan benefits, which is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits earned by the participants to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment. The significant actuarial assumptions used in the valuations as of January 1, 2024 and 2023 were: (a) life expectancy of participants (IRS 2024 and 2023 Small Plan Combined Static Mortality Tables for January 1, 2024 and 2023, respectively), (b) retirement age assumptions (the assumed average age was age 65) and (c) the interest rate assumptions (a discount rate of 6.5% was used for both years). The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

Interest rates used for actuarial calculations to measure the funding target are based on a modified yield curve. Benefit obligations expected to be paid in the next 5 years are discounted with a short-term corporate bond rate. Obligations expected to be paid more than 5 years but less than 20 years from now are discounted using an intermediate corporate bond rate. Obligations expected to be paid more than 20 years from now are discounted with a long-term bond rate. For the years ended January 1, 2024 and 2023, the three interest rates for short-term, intermediate-term and long-term were 4.75%, 4.87%, and 5.59% and 4.75%, 5.00%, and 5.74% respectively.

### Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 25, 2025, which is the date the financial statements were available to be issued.

Effective May 1, 2025, participation in the pension plan is closed for employees hired or rehired on or after May 1, 2025. A window for lump-sum distributions will be opened from May 5, 2025 through June 20, 2025 but are limited to those participants who were terminated on or before December 31, 2024 with an accumulated benefit of \$100,000 or less as of July 1, 2025.

### Note 3 – Unaudited Investment Information Certified by the Custodian

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information has been certified by Standard Insurance Company as to its completeness and accuracy and was not subjected to any auditing procedures performed by the Plan's independent auditors:

1. All investment balances reflected in the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023;
2. All investment activity reflected in the statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023; and
3. All investment-related information included in the Supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 and Supplemental Schedule H, Line 4j - Schedule of Reportable Transactions for the year ended December 31, 2024.

### Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* The Plan's investments in pooled separate accounts are valued at fair value based on the fair value of the underlying assets of the pooled separate accounts, using net asset value as the practical expedient.

### Level 3 Fair Value Measurements

The Stable Asset Fund is an insurance contract whose fair value represents contributions made plus accrued interest income less amounts withdrawn to pay benefits and expenses. The Plan's Stable Asset Fund is a general liability against Standard Insurance Company. The Stable Asset Fund is classified as Level 3. The use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5 – Investment Contract With Standard

The Plan has entered into an investment contract with Standard Retirement Services, Inc. (Standard) with regard to the Stable Asset Fund. Standard maintains the contributions in a general account. The issuer is contractually obligated to repay the principal less charges for withdrawals and administrative expenses plus a specified interest rate that is guaranteed to the Plan.

Because the Stable Asset Fund is an investment contract, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The Stable Asset Fund is presented on the face of the statements of net assets available for benefits at fair value (which approximates its contract value). The Stable Asset Fund value as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administration expenses.

There are no reserves against the Stable Asset Fund for credit risk of the contract issuer or otherwise. The fair value of the investment contract at December 31, 2024 and 2023 was \$6,810,802 and \$5,632,463, respectively. The fair value is the amount which is payable on demand on the reporting date. The investment contract is a general liability of Standard Insurance Company and there are no separate identifiable assets.

Certain events may limit the ability of the Plan to transact at contract value with Standard. Such events include termination of the contract, spinoffs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value are remote. No events are probable of occurring that might limit the ability of the Plan and participants to transact at contract value with the issuer.

In the event that the full value of the account could not be paid upon demand, such as amounts subject to the Stable Asset Fund market value adjustment, the "fair value" estimates are based upon "demand value" for the contract. The "demand value" is the amount due to the contract holder under the surrender provisions of the contract. The Plan Administrator has determined that the occurrence of circumstances resulting in a fair value adjustment are remote.

The average yield credited to the Plan was approximately 1.61% and 1.30% for 2024 and 2023, respectively.

Certain plan investments are managed by Standard Insurance Company, who is the Plan's Custodian. Transactions involving these investments are considered party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA Regulations. During the years ended December 31, 2024 and 2023, the Plan paid fees to the Custodian totaling \$100,243 and \$96,786, respectively, which include investment related expenses which have been netted with investment appreciation or added to investment depreciation on the statements of changes in net assets available for benefits.

### **Note 7 – Funding Policy**

The Plan Administrator's funding policy is to make annual contributions to the Plan that meet the minimum funding requirement. Pursuant to actuarial computations, there was no contribution required to be remitted to the Plan for both of the years ended December 31, 2024 and 2023.

### **Note 8 – Income Tax Status**

The Plan is utilizing a non-standardized prototype plan, which has been filed with the IRS and has received a favorable opinion dated March 30, 2018 from the IRS. The Plan Sponsor has not elected to apply for an individual IRS Determination Letter upon adoption of the Plan nor on any subsequent amendments. However, the Plan Sponsor believes that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code and, therefore, that the Plan is qualified under Section 401(a) and that the related Trust is tax-exempt as of December 31, 2024.

The Plan was restated effective June 1, 2020. There were no substantial changes to the operation or terms of the Plan.

The Plan permitted provisions of SECURE Act 2.0 during the years ended December 31, 2024 and 2023. Written amendments to the plan document to reflect these operational changes will be adopted at a later date in accordance with the deadlines pursuant to applicable laws and IRS guidance.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024, the Plan Administrator believes that the Plan has no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, the Plan is currently not being examined.

### Note 9 – Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. Upon termination of the Plan, the rights of all participants in the amount of their benefits accrued to the date of termination, to the extent then funded become nonforfeitable.

- a. To provide benefits to former participants who have retired under the Plan prior to its termination without reference to the order of retirement.
- b. Equally among:
  - Retired participants and their beneficiaries to whom payment commenced at least 3 years prior to the date of termination.
  - Participants who could have retired and received payment of their benefits at least 3 years prior to the date of termination.
  - To provide benefits to participants who have reached their normal retirement date but have not retired on the date of termination without reference to the order in which they will have reached their normal retirement date.
  - To any benefits guaranteed and insured by the Pension Benefit Guaranty Corporation.
  - To provide benefits to participants who have not reached their normal retirement date on the date of termination, without reference to the order that each participant will attain normal retirement date. The benefit will be based on their accrued benefit at the time of termination.
  - To all other vested accrued benefits not insured by the Pension Benefit Guaranty Corporation.
  - To all other accrued benefits provided under the Plan.

Certain benefits under the Plan are insured by the Pension Benefit Guaranty Corporation (PBGC) if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor benefits. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date the Plan is terminated. There is a statutory ceiling, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees.

The Pension Protection Act of 2006 (PPA) and Section 436 of the Internal Revenue Code require the calculation of a funding ratio called the Adjusted Funding Target Attainment Percentage (AFTAP) in order to determine whether the Plan is subject to limits on certain transactions. The Plan's AFTAP is 200.98% and 201.72% at January 1, 2024 and 2023, respectively, which indicates significant overfunding. As the Plan Sponsor is a tax-exempt entity, there are no limits on prefunding the Plan and the Plan Sponsor has elected to prefund the Plan for the purpose of generating earnings to offset plan expenses and benefit payments. Should the Plan terminate, the amount of assets in excess of those required to pay accumulated benefits will revert to the Plan Sponsor. Reversion excise taxes under Section 4980 of the Internal Revenue Code would not be imposed as the Plan Sponsor is a tax-exempt entity. Alternatively, in the event of Plan termination, the Plan Sponsor may elect to amend the Plan to provide additional benefits rather than reverting the excess to the Plan Sponsor.

### **Note 10 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption processes, it is at least reasonably possible that changes in these estimates and assumptions in the near term could materially affect the amounts reported and disclosed in the financial statements.


