Opinion

We have audited the financial statements of San Antonio Regional Hospital, Inc. Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Note 1 Description of Plan

The following description of San Antonio Regional Hospital, Inc. Welfare Benefits Plan (the “Plan”), provides only general information. Participants should refer to the plan agreement for a complete description of the Plan’s provisions and list of component plans covered by the Plan.

General - The Plan provides health and other benefits for substantially all active and eligible retired employees (For retired employees, only medical and dental) of San Antonio Regional Hospital, Inc. (the “Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Benefits - The Plan provides benefits (medical, dental, vision, accidental death and dismemberment, life insurance, long-term disability and a section 125 cafeteria plan) to employees and their eligible dependents. Participants should refer to separate plan documents describing the specific benefits provided by each component plan. Employees retiring before the age of 65, and their eligible dependents, are entitled to medical and dental benefits. To be eligible, they must have a minimum of ten (10) years of current service in a benefit eligible status, must retire between the ages of 62 and 65; and must be enrolled in the medical and dental plan at the time of retirement.

Participants have a choice between three medical plan options; Core Advantage EPO Open Access Select Choice (“EPO”), Choice POS II (“POS”), or Health Maintenance Organization Plan (“HMO”). EPO and POS medical claims are self-funded which requires contributions from both the Sponsor and EPO/POS participants. HMO medical claims are provided under a group insurance contract with Aetna Health of California Inc. (“Aetna”). The Plan also provides continuation of certain medical benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (“COBRA”).

All other plan benefits, except the medical HMO, are self-insured and claims are processed by the Plan’s third-party claims processors under an Administrative Services Only (“ASO”) arrangement. The claims processors pay claims directly to, or on behalf of, participants and are then reimbursed from the general assets of the Sponsor. Despite the Plan’s utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Insurance Contracts - Insurance contracts held with the various service providers for medical HMO, vision, life insurance and disability are allocated contracts and therefore, excluded from plan assets.

Contributions - The Sponsor contributes to the medical and dental self-funded plans an amount equivalent to the claims incurred less participant contributions. Participant medical self-funded plans and HMO premium contribution payments are made bi-weekly from payroll for employees. Retirees pay the sponsor monthly. The medical self-funded plan contributions and medical HMO premium payments are based on age and years of service, claim payment experience, and comparable health coverage rates of other plans.

The Sponsor's policy is to contribute to the self-funded dental plan claims incurred less participant contributions on a bi-weekly basis.

Contributions for the vision, long-term disability, life insurance and 125 cafeteria plans are made from funds provided by the participants.

Stop Loss Coverage - The Plan has entered into a stop-loss insurance arrangement to limit its exposure for self-insured medical benefits (individual participant claims over a specific dollar amount).

Note 2 Significant Accounting Policies

Basis of Accounting - The financial statements have been prepared on the accrual method of accounting and include assets, liabilities, and changes in net assets available for benefits and benefit obligations of the Plan in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates - The preparation of financial statements in conformity with U.S. GAAP, requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Certain accounting estimates are particularly sensitive due to their significant impact on the financial statements. The most sensitive estimates affecting the financial statements are the Management's estimate of the post-retirement benefit obligations and Management's estimate of the claims incurred but not reported (IBNR).

Note 2 Significant Accounting Policies (continued)

Medical Vouchers - The Sponsor issues medical vouchers to employees, retirees and their dependents to be used for medical services provided by the Sponsor. These vouchers are recorded at the cost of the service provided using rates from similar medical plans. The Sponsor simultaneously records a contribution to the Plan, as well as a benefit payment for each medical voucher claimed.

Payment of Benefits - Claim payments are recorded when paid by the third-party claim's processor for the medical and dental plans. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as accrued benefit claims in the accompanying statements of net assets available for benefits. These payments are recorded as benefits paid in the accompanying statements of changes in net assets available for benefits.

Stop-Loss Arrangement - The Sponsor, in addition to the Plan, purchased a premium insurance arrangement with an insurance company to cover all individual claim medical expenses in excess of \$350,000 for 2024 and \$350,000 for 2023. This arrangement covered the Sponsor and therefore, was not expensed by the Plan.

Flexible Spending Account - Included in the accompanying statements of net assets are amounts available to reimburse participants for eligible adoption, dependent care and/or medical expenses as of December 31, 2024 and 2023, totaling \$197,205 and \$139,430, respectively. Forfeited amounts can be used by the Sponsor to offset Sponsor contributions in the year forfeited.

Administrative Cost - Plan administrative costs are recorded as expenses when incurred.

Date of Management's Review - Subsequent events have been evaluated through October 8, 2025, the date the financial statements were available to be issued.

Note 3 Postretirement Benefit Obligations

The postretirement medical and dental benefit obligation represents the actuarial present value of those estimated future medical and dental benefits that are attributed to medical and dental benefits earned at December 31, 2023. Postretirement benefits include future medical and dental benefits expected to be paid to either, or both of the following:

- (1) Currently retired employees and their dependents,
- (2) Active employees and their dependents after retirement from service with the Sponsor.

Prior to an active employee's full eligibility date, the postretirement medical benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's services rendered to the valuation date.

The actuarial present value of the expected postretirement medical and dental benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims-costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment, to the retired participants and other providers.

At December 31, 2023, for medical coverage a 6.00% annual rate of increase per capita cost of covered benefits was assumed that would decrease gradually to 5.00% through 2028 and remain at that level thereafter. For dental coverage a 4.50% annual rate of increase per capita cost of covered benefits was assumed.

The weighted-average medical cost trend rate assumption has a significant effect on amounts reported as postretirement benefit obligations. If the assumed rates increased by 1 percentage point each year, it would significantly increase the obligation as of December 31, 2023.

The following were other significant assumptions used in the valuations as of December 31, 2023:

Weighted-average discount rate	5.41%
Average retirement age	63.78
Mortality	Pri-2012 Mortality Tables, with MP-2021 improvement scale
Medicare	No Medicare subsidy is assumed to be received

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Plan obligations at December 31, 2023 for claims incurred by active participants but not reported at that date are estimated by management. Such estimated amounts are reported in the accompanying statement of the Plan's benefit obligations at present value, based on a 5.41% discount rate. Claims incurred by retired participants but not reported are included in the postretirement benefit obligation.

Note 4 Postemployment Benefit Obligations

The Sponsor provides a continuation of medical benefits for terminated and disabled employees through a self-funded COBRA program. The liability recognized in the accompanying statements of net assets available for benefits and benefit obligations is based on an estimate of claims outstanding. Postemployment benefit costs charged to plan assets for the year ended December 31, 2024 were \$142,724.

Note 5 Claims Incurred but Not Reported

Plan obligations at December 31, 2023 for claims incurred but not reported are estimated by the Plan. These amounts are paid only if claims are submitted and approved for payment.

Note 6 Administrative Expenses

The Sponsor pays administrative expenses that consist primarily of fees paid to third-party claims processors, actuary and professional fees. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses.

Note 7 Tax Status

The Plan's net assets are qualified pursuant to Section 501(c)9 of the Internal Revenue Code, and, accordingly, the Plan's net income is exempt from income taxes. The Sponsor has obtained a favorable tax determination letter from the Internal Revenue Service ("IRS") and the Sponsor believes that the Plan, as amended, continues to qualify and to operate as designed.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 Transactions with Parties in Interest

The Sponsor provides medical services to active, retired and terminated employees and their dependents. The Sponsor also provides to the Plan certain accounting and administrative services for which no fees are charged.

Note 9 Termination of the Plan

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to, and contributions required of, participants and to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
