As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

1. Description of Plan

The following description of the Easter Seals UCP North Carolina & Virginia, Inc. 403(b) Retirement Plan ("the Plan") provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established January 1, 1988 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers employees of Easter Seals UCP North Carolina & Virginia, Inc. ("Plan Sponsor"). An employee is considered eligible for participation on such employee's first day of employment. An employee becomes eligible for the discretionary employer match on January 1 or July 1 following completion of six months of service. The 403(b) Fiduciary Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan Sponsor.

Effective July 1, 2024, Easter Seals UCP North Carolina & Virginia, Inc. and PORT Health Services entered into an Asset Contribution Agreement. Under this Agreement, PORT Health Services contributed substantially all of its assets to Easter Seals UCP, which assumed substantially all of PORT Health Services' liabilities. PORT Health Services' employees terminated employment on June 30, 2024 and on July 1, 2024 became employees of Easter Seals UCP. At that time, Port Health Services' employees became eligible for this Plan.

Contributions

Each year, participants may elect to contribute up to 100% of their pretax annual compensation, as defined by the Plan, subject to Internal Revenue Service limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows for special catch-up contributions for those participants meeting 15 year service requirements. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions invested in the qualified default investment account until changed by the participant. The Plan Sponsor determines in its sole discretion each payroll period how much, if any, it will make as matching contributions. No matching contributions were made during the 2024 plan year.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) plan earnings and (b) the Plan Sponsor's contributions, if any. Allocations are based upon participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct employee and employer contributions into selected investment options as made available and determined by the Plan Administrator. The Plan currently offers various mutual funds and a guaranteed interest account as investment options for participants.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon as well as employer contributions.

Payment of Benefits

Upon termination of service due to death, disability, termination of employment or retirement, a participant generally may elect to receive a lump-sum payment equal to the value of the vested portion of his or her account, by rolling over their account into another qualified plan, or annuity benefit or annual installments. In service withdrawals are allowed at age 59 ½. Early retirement is at attainment of age 55. Hardship distributions from a participant's elective contribution accounts are permitted if certain criteria are met.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully-benefit responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Investment advisor fees are charged to the participant's accounts pro-rata and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Fund expenses, if any, are paid by the Plan, and are included in administrative expenses. The Plan obtained \$33,660 in revenue sharing refunds which are included in investment income and were utilized to offset Plan administrative expenses. Participants pay for individual expenses such as distribution and hardship fees.

Payment of Benefits

Benefits are recorded when paid.

3. Unaudited Information

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company ("Matrix") and CMFG Life Insurance Company ("CMFG") have certified that the following data included in the accompanying financial statements is complete and accurate.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to related information in the financial statements and supplemental schedules.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

5. Guaranteed Interest Contract

In 2016, the Plan entered into a traditional fully-benefit responsive deposit administration guaranteed investment contract with CMFG. CMFG maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement under normal circumstances. At December 31, 2024, the value of the contract was \$319,000.

The contract meets the fully-benefit responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by CMFG, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Tax Status

The Plan Administrator and the Plan's management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code ("IRC") and therefore believe the Plan is qualified and the related trust is tax-exempt. In June 2019, the Plan was restated to the CMFG Life Insurance Company Plan Document, and that document received an opinion letter from the IRS dated March 31, 2017 that the form of the plan document was acceptable under section 403(b) of the IRC. The restatement was effective as of January 1, 2010.

8. Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit volatility. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Related Party and Party-in-Interest Transactions

The Plan Sponsor is the employer and absorbs certain administrative expenses, such as legal and plan administration, relating to the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services of \$33,205 are included in plan administrative expenses. Certain plan investments are shares of mutual funds held in custody by Matrix Trust Company and a guaranteed investment contract by CMFG, a party affiliated with TruStage, the recordkeeper; therefore, these transactions also qualify as party-in-interest transactions. The Plan paid TruStage \$22,750 for member requested services during 2024.

10. Subsequent Events

The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued. During this period, no material recognizable subsequent events were identified.
