Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## NOTES TO FINANCIAL STATEMENTS

### Note 1 – Description of Plan

The following description of the MMM Cash or Deferred Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General and eligibility

The Plan was established on January 1, 2002, as a defined contribution plan available to the eligible employees of Mega Contracting Group, LLC (the Plan Sponsor or Employer). The Plan is a defined contribution plan covering all employees in a controlled group of entities, other than members of a collective bargaining agreement or a non-resident alien. The entities in this controlled group include Makro General Contractors, Inc., Metro York Electrical, Inc., and M25 Properties, LLC. Eligible employees of the Plan Sponsor who participate must be 21 years of age or older; and prior to the January 1, 2019 restatement, had to also complete at least 500 hours in a 6-month period. The Plan Sponsor controls and manages the operation and administration of the Plan. Eligible employees may enter the Plan on the first day of the calendar month coinciding with or next following the date they reach age 18 and after completing three months of credited service, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan contracted with Nationwide Life Insurance Company and Nationwide Trust Company, FSB (collectively, the Custodian or Nationwide) and their affiliate, Nationwide Financial Services, Inc., provides recordkeeping services to the Plan.

#### Plan merger

On December 31, 2024, the Plan Sponsor executed an adoption agreement with Choice Pooled Employer Plan III (successor plan), a pooled employer plan, and transferred the participant accounts and all of the Plan's investment assets to Transamerica Financial Life Insurance Company (Transamerica), in order to complete the merger into the successor plan effective January 1, 2025. The 2024 financial statements reflect the activity in the Plan through the date of transfer, December 31, 2024. The Plan's investment assets are held in the Transamerica Diversified Cash Reserve Fund – interest bearing cash account as of December 31, 2024.

#### Contributions

Each year, participants may contribute up to 90% of eligible pre-tax compensation, as defined, up to the maximum allowed by law, within the limits prescribed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Roth contributions are not permitted under the Plan's provisions.

The Plan Sponsor is the Plan Administrator and may make discretionary matching contributions as a percentage of eligible compensation deferred by participants. Participants must be twenty-one (21) years of age and complete six (6) months of service in order to be eligible for discretionary matching contributions. Employer contributions are invested in funds in accordance with the participant's direction and the Plan's provisions. The Employer made discretionary matching contributions in the amount of \$515,412 for the year ended December 31, 2024.

Contributions are subject to certain IRS limitations.

#### Participant accounts

Each participant's account is credited with the participant's contributions and an allocation of (a) the Employer's contributions (if any), and (b) Plan earnings or losses thereon. Participants are charged with his or her withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined.

**Note 1 – Description of Plan, Continued**

Participant accounts, continued

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All participant contributions are participant-directed and may be invested into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their individual contributions, plus actual earnings or losses thereon. Vesting in the Employer's contributions, if any, plus any earnings or losses thereon, is based on years of credited service. Participants who become eligible and are enrolled in the Plan will receive vesting credit for years of service based only on the elapsed time method, as defined. A participant is fully vested after six (6) years of credited service, based on a graded vesting schedule. Participant accounts become fully vested upon reaching normal retirement age of sixty-five (65), death, disability, or upon termination of the Plan.

Forfeitures

Forfeited nonvested accounts may be used to offset Plan administrative expenses or reduce the Employer contributions. Forfeitures totaling \$8,417, were used to reduce Employer contributions for the year ended December 31, 2024. Forfeitures available to be utilized at December 31, 2024 and 2023, amounted to \$12,133 and \$5,859, respectively.

Notes receivable from participants

Plan participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loans are secured by the vested account balance in the participant's account and bear interest at the Prime Rate plus 1% per year and is fixed for the term of the loan. Principal and interest are paid ratably through regular payroll deductions. All loans are required to be repaid within a period of five years, except loans to acquire the participant's principal residence which must be repaid in a reasonable period of time, not to exceed thirty years. Any delinquent notes receivable from participants are recorded as distributions under the Plan's provisions.

Payment of benefits

On termination of service due to death, disability, or normal retirement age (65), a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum distribution, or in monthly installments. For termination of service due to other reasons, a participant may choose to leave the vested interest in the Plan if such amounts exceed \$5,000, or elect a lump-sum distribution. Participants with vested amounts less than \$1,000 must elect a lump-sum distribution. Participants may take in-service withdrawals upon attainment of age 59½ or for immediate and heavy financial hardship needs, as defined.

Administrative expenses

The Plan allows certain administrative expenses to be paid from Plan investment assets. Certain administrative expenses are paid directly by the Plan Sponsor and are not reflected in the financial statements.

**Note 2 – Summary of Significant Accounting Policies**

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Interest-bearing cash

The Plan's short-term investments consist of interest-bearing cash held by Transamerica and is recorded at cost, which approximates fair value.

Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts which are valued at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Plan management and its advisor determine the Plan's valuation policies utilizing information provided by the investment advisor and Nationwide. Interest income is recognized when earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from such estimates, and those differences could be material.

Risks and uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the high level of risk associated with certain investment securities, including the uncertainty related to changes in the values of investment securities, it is at least reasonably possible that changes in such risks in the near-term would materially affect participant account balances and the amounts reported in the financial statements.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual method. Related fees are recorded as administrative expenses and expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make scheduled repayments and the Plan Administrator deems the participant note receivable to be in default, the note receivable balance is reduced, and a benefit payment recorded.

Payment of benefits

The Plan records benefits when paid.

Refunds payable for excess contributions

During 2024 and 2023, the Plan received contributions from participants in excess of Plan and IRS limitations. Such excess contributions were refunded to participants in the subsequent year with a liability and corresponding reduction to contributions recorded in the year the excess contribution was received.

Plan administration

The Plan contracted with Nationwide trust services the Plan's investment assets. Nationwide Financial Services, Inc. provides recordkeeping services to the Plan. Long Island Employee Benefits Group, Ltd. (LIEBG) serves as the third-party administrator to the Plan for compliance and reporting services.

Uncertain tax positions

U.S. GAAP requires Plan management to assess its uncertain tax positions for the likelihood they would be overturned upon examination by the IRS. In accordance with this guidance, the Plan management has determined it does not have any positions at December 31, 2024, that it would be unable to substantiate.

Plan expenses

The Plan allows certain administrative expenses to be paid directly from Plan investment assets. Certain administrative expenses of maintaining the Plan are paid directly by the Plan Sponsor and are not reflected in these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

**Note 3 – Certified Investment Information**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide Life Insurance Company and Nationwide Trust Company, FSB, qualified institutions, have certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investment information included in the Schedule H, line 4i – schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental information.

At the request of the Plan's Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and disclosures related to the investments to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP, and in the ERISA-required supplemental schedule, including assessing whether the supplemental schedule, is in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 4 – Fair Value Measurements**

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodology used at December 31, 2024 and 2023. During the year ended December 31, 2024, there were no transfers of financial instruments into or out of Level 3.

*Mutual funds* – valued at quoted market prices, which represent their daily net asset value (NAV) reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are traded on national exchanges (active markets).

The preceding method described may produce a fair value calculation that may not be indicative of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5 – Group Annuity Contract with Nationwide Life Insurance Company**

The Plan has a group annuity contract, issued by Nationwide Life Insurance Company (Nationwide Life) with a contract value, as reported by Nationwide Life of \$0 and \$83,344, at December 31, 2024 and 2023, respectively. Nationwide Life maintains contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Nationwide Life is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by Nationwide Life. The crediting rate is reset annually. The contract does not have a maturity date. The annual crediting rate for the contract at December 31, 2024 and 2023 was 2.66% and 3.02%, respectively.

Contract value, which approximates fair value, as reported to the Plan by Nationwide Life, represents contributions made under the terms of the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on Nationwide Life's ability to meet its financial obligations. Nationwide Life's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with Nationwide Life. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Nationwide Life and that also would limit the ability of the Plan to transact at contract value with the participants.

Based on ongoing credit evaluations of its guaranteed investment contract investments, Plan management does not expect payment defaults or delinquencies and has not recorded an allowance for credit losses for the investment as of December 31, 2024 and 2023.

**Note 6 – Party-In-Interest and Related Party Transactions**

The Plan's investments include shares of mutual funds managed and administered by Nationwide and a group annuity contract issued by Nationwide Life. Recordkeeping services are provided by Nationwide's affiliate, Nationwide Financial. Therefore, transactions with Nationwide, Nationwide Life, and their affiliate qualify as party-in-interest transactions. Such transactions are permitted under provisions of the Plan and are exempt from the prohibition of related party transactions under ERISA.

Under the Plan's service agreement, Nationwide receives revenue from service providers for services Nationwide provides to the funds held within its mutual funds. This revenue is used to offset certain amounts owed to Nationwide for its custodian and recordkeeping services to the Plan. If the revenue received by Nationwide from such fund service providers exceeds the amount owed under the service agreement, Nationwide remits the excess to the Plan's account on a quarterly basis. Such amounts may be applied to the Plan's administrative expenses or allocated to the accounts of the participants. For the year ended December 31, 2024, no excess revenue sharing was applied to administrative expenses. The Plan or Plan Sponsor may make a payment to Nationwide for administrative expenses not covered by revenue sharing.

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or a Plan Sponsor whose employees are covered by the Plan. Certain administrative functions are performed by officers and employees of the Plan Sponsor. No officer or employee receives compensation from the Plan for these services.

**Note 7 – Plan Merger**

As of December 31, 2024, the Plan's investment assets were transferred to Transamerica. Effective January 1, 2025, the Plan merged into Choice Pooled Employer Plan III (successor plan). Participant account balances along with all Plan assets and Plan liabilities were transferred to the successor plan as of January 1, 2025. The Plan's investment assets are held in the Transamerica Diversified Cash Reserve Fund – interest-bearing cash account as of December 31, 2024.

**Note 8 – Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Plan Sponsor may determine.

**Note 9 – Tax Status**

The Plan adopted a non-standardized pre-approved profit-sharing plan, which received a determination letter date June 30, 2020, in which the IRS stated that the non-standardized pre-approved profit-sharing plan was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

**Note 10 – Delinquent Participant Contributions**

As required by ERISA Section 2510.3-102, the Plan Sponsor is required to segregate participant contributions from its general assets and remit to the Plan as soon as is practicable. During the year ended December 31, 2024, the Plan Sponsor failed to timely remit certain participant contributions and loan repayments totaling \$209,393 within the timeframe required by the DOL's regulations. During 2024, approximately \$97,000 late contributions were corrected.
