## INDEPENDENT AUDITOR'S REPORT

#### **Note 1 – Description of Plan**

The following description of the Carswell Group 401(k) Profit Sharing Plan (the “Company” and the “Plan”, respectively) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### *General*

The Plan was originally effective on January 1, 1993. The amended and restated provisions of the Plan became effective on January 1, 2022. However, this restatement was made to conform the Plan to new tax laws, and some provisions may be retroactively effective. The Plan is a defined contribution plan covering eligible employees of the Company as described by the plan. Employees are eligible to participate in the Plan once they meet the requirements of one year of service and 21 years of age.

#### *Contributions*

The Plan is contributory, and participants may contribute any percentage of their pre-tax or after-tax (as a Roth deferral) annual compensation, up to the limit in effect for the year (\$23,000 in 2024 and \$22,500 in 2023) as defined by the Internal Revenue Code (“IRC”). Participants aged 50 or older may make an additional “catch-up” contribution (\$7,500 for 2024 and \$7,500 for 2023).

The Company makes a safe harbor matching contribution equal to 100% of salary deferrals up to the first 3% of eligible plan compensation plus 50% of salary deferrals between 3% and 5% of eligible compensation. Additional profit-sharing amounts may be contributed at the option of the Company’s Board of directors. During the year ended December 31, 2024, the Company did not make any additional discretionary contributions to the Plan.

#### *Party-In Interest Transactions*

Certain plan assets are in investment funds managed John Hancock Life Insurance Company (“John Hancock”), or their affiliates and are custodians of the Plan’s investments. Therefore, these transactions qualify as party-in-interest transactions as permitted party-in-interest transactions.

#### *Participant Accounts*

Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contribution and an allocation of Company discretionary contributions and Plan earnings and charged with withdrawals and allocation of Plan losses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### *Investment Options*

Participants direct the investment of their contributions into mutual fund investment options offered by the Plan. Company contributions are invested in each participant’s account according to participant’s selected allocation. Participants may change or transfer their investment options at any time via telephone to a call center or through a designated on-line system.

#### Note 1 – Description of Plan (continued)

##### *Plan Amendment*

On May 15, 2023, the Plan was amended to add a Roth deferral option and allow for in-plan Roth Conversions. No amendments were made to the Plan during the year ended December 31, 2024.

##### *Vesting*

Participants are 100% vested in their voluntary and Company safe harbor matching contribution immediately upon their effective date of participation, plus actual earnings thereon. Vesting in the Company discretionary non-elective contribution portion of their accounts, plus actual earnings thereon, is based on the participant's years of service. Participants are credited with a year of service for vesting purposes upon completion of 1,000 hours of service during the plan year. The vesting schedule is as follows:

Participant accounts are fully vested upon death, disability or attainment of normal retirement age. The Company may authorize a percentage of the Company's annual contribution to be transferred to the pre-tax account of non-highly compensated participants, and the participants then become immediately vested in those contributions.

##### *Payment of Benefits*

The Plan provides for payment of 100% of the account balance to participants upon normal retirement age of 65. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installment. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Participant account balances between \$1,000 and \$5,000 will automatically be rolled over into an individual retirement plan determined by the Company. Participant account balances of less than \$5,000 will receive a cash distribution. A participant may be entitled to receive an in-service distribution from their vested account balance if they have reached the age of 59½. Participants may also request financial hardship distributions from elective deferral accounts if they meet certain conditions defined in the plan agreements. Benefits are recorded when paid.

##### *Forfeited Accounts*

Forfeited non-vested accounts are used first to pay plan expenses, and any remaining balance will be used to offset future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$0, respectively.

#### **Note 2 – Summary of Significant Accounting Policies**

##### *Basis of Accounting*

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with generally accepted accounting principles in the United States of America.

##### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of plan assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period from January 1, 2024 through December 31, 2024.

##### *Benefits*

Benefits to participants are recorded when paid.

##### *Administrative Expenses*

The Company absorbs most costs of the Plan (legal fees, audit fees, third party administration fees); however, the remaining costs are not deemed material to the financial statements presented. Investment fees and charges are paid by the participant. Fees for these services are also included in investment income and paid through revenue sharing.

##### *Contributions Receivable*

Contributions receivable consists of participant and employer contributions receivable. No allowance was recorded as the full balance is deemed collectible.

##### *Excess Contributions Payable*

Excess contributions payable consists of employer over-funded safe harbor matching contributions that were made to the Plan during the year.

#### Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2 Inputs to the valuation methodology are quoted market prices for similar assets and liabilities in active markets, quoted prices in markets that are not active or inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the instrument.
- Level 3 Inputs to the valuation methodology are unobservable inputs based upon management's best estimates of inputs market participants could use in pricing the asset or liability at the measurement date, including the assumption of risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

While the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the net asset value ("NAV") of units held by the Plan at period end. The NAV, as provided by John Hancock Life Insurance Company, is used as a practical expedient to estimate the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

Investments include (1) index funds that seek to reproduce the returns achieved by a specific index. (2) income funds that seek to provide current income and some capital appreciation. (3) target retirement funds that provide an asset allocation based on an investor's targeted retirement date. The asset allocation becomes more conservative as the fund approaches its target retirement date. (4) growth funds that seek to provide growth of capital by primarily investing in common stocks of small and large companies (5) target risk funds that provide an asset allocation based on an investor's targeted risk (conservative, moderate, aggressive, etc.). The Plan's investments invest directly in underlying mutual funds.

#### Note 4 – Risks and Uncertainties

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that change in the values of investments will occur in the near term and that such changes could materially affect amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

#### Note 5 – Federal Income Tax Status

The Plan files as part of a prototype plan that received its latest determination letter on November 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The IRS has determined and informed the Plan sponsor by a letter dated November 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

### Note 5 – Federal Income Tax Status (continued)

Accounting principles generally accepted in the United States of America require that plan management evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 6 – Information Certified by John Hancock Life Insurance Company

### Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants will become one hundred (100) percent vested in their accounts.

### Note 8 – Related-Party Transactions

Certain Plan investments are shares of investment fund accounts that are managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company performs services for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to John Hancock Life Insurance Company were approximately \$20,592 for the year ended December 31, 2024.

The Plan made payments to The Benefit Advantage, Inc., third party administrator, pertaining to participant withdrawals and general plan administration. Direct fees incurred by the Plan for these services totaled \$3,778 for the year ended December 31, 2024.

The Plan made payments to Cambridge Investment Research Advisors and RHL Group for investment advisory services. Direct fees incurred by the Plan for these services totaled \$16,464 for the year ended December 31, 2024.

### Note 9 – Subsequent Events
