We have performed audits of the financial statements of the Shared Operating Services 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. Description of the Plan

The following is a brief description of the Shared Operating Services 401(k) Plan (the Plan) and is provided for general information only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### *General*

The Plan is a defined-contribution plan covering employees of six related entities: Midtown South Associates, L.L.C.; Financial District Associates, L.P.; Hill Building Associates, L.P.; Devonshire Arch Associates, L.P.; MSA New York L.L.C.; and Midtown WTC Associates, L.L.C. and their subsidiaries, collectively, the Club Quarters Group (the Company or Plan Administrator or Employer), who have completed six months of full-time service and have attained 21 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### *Trustee (Custodian) and Administration of the Plan*

The trustee and recordkeeper of the Plan is Fidelity Management Trust Company (Fidelity or Trustee). The administrator of the Plan is the Company. The Trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

Participant must be 21 years of age to participate in the Plan. Additionally, the participant must complete six months of service to participate in the Plan. All employees are eligible to participate. An eligible participant can enter the Plan immediately upon meeting the eligibility requirements the first day of each month.

#### *Contributions*

Each year participants may contribute up to 30% of pre-tax annual compensation, except highly compensated employees who may contribute up to 4% of pre-tax annual compensation, as defined in the Plan. Salary deferral agreements shall be made, terminated, or changed according to procedures and limitations set up by the Plan Administrator and the Plan document.

The Company may allow participants, upon proper notice and approval, to enter into a special salary-deferral agreement to make employee deferral contributions of up to 100% of any employer-paid cash bonus designated by the Company.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make a discretionary employer matching contribution. During 2024, the Company matched 50% of participant contributions up to 6% of eligible compensation (maximum match amount of \$1,500) for New York participants, 100% of participant contributions up to 3% of eligible

compensation (maximum match amount of \$2,000) for Illinois, Michigan and Connecticut participants and 100% of participant contributions up to 4% of eligible compensation (maximum match amount of \$2,000) for Pennsylvania participants. During 2023, the Company matched 50% of participant contributions up to 6% of eligible compensation (maximum match amount of \$1,500) for New York participants, 100% of participant contributions up to 3% of eligible compensation (maximum match amount of \$2,000) for Illinois participants, and 100% of participant contributions up to 4% of eligible compensation (maximum match amount of \$2,000) for Pennsylvania participants.

The Company may also make a non-elective discretionary contribution (profit-sharing contribution) to the Plan as a supplemental contribution for participants who are employed by the Company at the end of the year for which the contribution is made, or experienced one of the following events during the Plan year: death, disability, or normal retirement age (60). No non-elective discretionary contribution was made for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### ***Participant Accounts***

Each participant's account is credited with the participant's and employer's contributions and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are 100% vested in their individual deferral and rollover contributions and the allocated earnings thereon. A participant's vested interest in the discretionary employer matching contributions is based upon the participant's years of continuous service. A participant is 100% vested after five years of credited service. Employer non-elective discretionary contributions (profit-sharing contributions) and earnings thereon vest according to a three-year cliff vesting schedule.

Participants become fully vested in the event of retirement, death, total disability, or Plan termination.

### ***Notes Receivable from Participants***

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Participants may not have more than one loan outstanding at any time. Loans are secured by the participant's account and bear an interest rate at prime rate plus 1% or at local prevailing rates as determined by the Plan Administrator, which would be made under similar circumstances and are fixed for the term of the loan. The notes are repaid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence. These loans are subject to certain restrictions as defined by the Plan document and applicable restrictions under the Internal Revenue Code (IRC). As of December 31, 2024 and 2023, the notes receivable from participants bear interest at rates that range between 4.25% and 9.50%.

### ***Payment of Benefits***

A participant's entire interest in the Plan is payable upon death; attainment of normal retirement age; becoming disabled, as defined; or termination of service. A participant may elect to receive a lump-sum amount, leave the account in the Plan, or roll over the vested balance to another qualified retirement plan or individual retirement account (IRA). For terminated participants with vested balances greater than \$1,000, but less than \$7,000, their vested balance will be rolled into an IRA with Fidelity unless otherwise elected. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan document. Participants may also withdraw an amount at age 59½ if certain criteria are met.

### ***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$19,944 and \$12,555, respectively. These accounts may be used to pay administrative expenses and reduce future employer contributions. None of the forfeited funds were used to pay administrative expenses or fund employer contributions in 2024.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisor and Trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance. Any accrued but unpaid interest is de minimis. If a participant ceases to make loan repayments and the Plan

Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### ***Contributions Receivable***

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/Profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan. At December 31, 2024 and 2023, contributions receivable totaled \$0 and \$47,975, respectively.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses***

Administrative expenses of the Plan are paid by the Company, except for certain expenses that are charged to participant accounts, including loans, withdrawal fees, Plan administrative fees, investment management fees, and audit fees. Certain investment expenses which are charged within investments are presented net of the appreciation in fair value of investments. All other expenses of the Plan for the year ended December 31, 2024 were paid by the Company and are excluded from these financial statements.

## **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

## **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* - This level consists of inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - This level consists of inputs to the valuation methodology that include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - This level consists of inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Investment Trust (CIT)* - The CIT is valued at the NAV of units of a collective trust fund. The NAV, as provided by the trustee of the CIT, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no redemption fees or notice periods and no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Fidelity or its subsidiaries and affiliates. Participant loan and distribution processing fees are paid to Fidelity by participants. The Plan paid for third-party administrator fees, investment advisory fees, and Plan audit fees that qualify as party-in-interest transactions. The Plan also issues loans to participants that are secured by the vested balance of the participants' accounts. Certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

## 6. Tax Status

The IRS has determined, by a letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit-Sharing Plan (the Defined Contribution Pre-Approved Plan and Trust Operations of the third-party administrator and recordkeeper, upon which the Plan is based) qualifies under Section 401(a) of the IRC and is, therefore, not subject to tax under present federal income tax laws. The Plan is required to operate in conformity with the IRC to maintain its qualification. While the Plan has been amended since the date of the letter, the Plan Administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified

status. The Plan Administrator believes the Plan continues to meet the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **7. Risks and Uncertainties**

The Plan holds various investment instruments. Investments, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

### **8. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to amend and terminate the Plan, subject to the provisions set forth in ERISA. In the event of termination, all participants will become or remain 100% vested in their accounts.

### **9. Subsequent Events**

Plan management evaluated the accompanying financial statements for subsequent events through October 6, 2025, and transactions on the date these financial statements were available for issue, and has determined that no material subsequent events have occurred that would affect the information presented in the accompanying financial statements or require additional disclosure.
