### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Mosaic Group, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from the qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### Note 1—Description of the Plan

*General* – The following brief description of the Mosaic Group, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a more complete explanation of the Plan’s provisions.

The Plan, which is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended, covers all employees of the Mosaic Group, LLC and its participating affiliated employers (the “Company” or “Employer”) who meet the eligibility requirements of the Plan. The Plan was established effective January 1, 2019, and was most recently amended effective June 11, 2024. The most recent amendment was executed due to a change in the definition of excluded compensation.

*Administration* – The Plan is administered by the Company, which serves without compensation. The Plan administrator is responsible for the oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance. The Company outsourced the recordkeeping function of the Plan. Reliance Trust Company (“Reliance”) and Standard Insurance Company (“The Standard”) holds the assets of the Plan. See Note 3 for more information.

*Eligibility and Participation* – Participation in the Plan is voluntary. All employees who are 21 years of age and who have completed six months of service are eligible to participate. Under the Plan, those eligible to participate are all employees of the Company who are not members of a collective bargaining unit and who are not non-resident aliens, leased employees, or part-time employees with less than 1,000 hours of service during the Plan year.

*Contributions* – Contribution amounts are limited in order to comply with Internal Revenue Service (“IRS”) regulations. The participants’ basic annual contributions cannot exceed \$23,000, and an additional \$7,500 for catch-up contributions for participants who are 50 or older. The Plan provides for catch-up contributions by participants who have attained age 50 before the close of the Plan year, to satisfy the alternative methods of meeting nondiscrimination requirements. Participants may also rollover amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants may designate certain contributions into the Plan as Roth elective contributions. Designated Roth contributions will be included in the gross taxable income of the participant, while distributions of designated Roth elective contributions and earnings thereon are generally excludable from the participant’s taxable income.

The Company provides safe harbor matching contributions and discretionary-matching contributions. Safe harbor matching contributions are equal to 100% of a participant’s first 3% of contributions and 50% of participant’s contributions from 3% to 5%, capped at a total of 4%. Discretionary-matching contributions may be made equal to up to 6% of participant’s eligible compensation. There were no discretionary-matching contributions during the year ended December 31, 2024.

*Participant Accounts* – Each participant’s account is credited with the participant’s contribution and allocation of: (a) the Company’s contributions and (b) investment earnings or losses (including net appreciation and depreciation in fair value of investments) and charged with benefit payments and transaction fees related to distributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Note 1—Description of the Plan (continued)**

*Vesting* – Participants are fully vested in their elective contributions, Employer safe harbor matching contributions, and any rollover contributions, plus or minus any earnings or losses thereon. Vesting in the discretionary matching, plus or minus actual earnings or losses thereon, is based on years of continuous service as defined by the Plan. Vesting is determined according to the following schedule:

<u>Years of Service</u>	<u>Percent Vested</u>
1 year	0%
2 years	50%
3 years	100%

*Investment Options* – Upon enrollment in the Plan, a participant may direct 100% of their allocation of contributions with the Plan. Within the Plan, participants may select between several investment options including mutual funds, common collective trust funds, and fixed guaranteed investment contracts. Participants may transfer balances periodically based on the applicable funds as defined in the custodial service agreement.

*Benefit Payments* – Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments. For termination of service for other reasons, distribution of the value of the participant's vested interest in his or her account will begin as soon as possible after the participant's request. Withdrawals prior to attaining age 59½ are not permitted, except in the event of retirement, disability, or as a hardship distribution. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½.

*Hardship Distributions* – Hardship distributions are permitted if the distribution is due to expenses incurred or necessary for medical care described in the Internal Revenue Code ("IRC") Section 213(d), purchase of a principal residence, payment of tuition, to prevent eviction from or foreclosure of the principal residence, payments for burial or funeral expenses, payment of expenses arising from federal declared disasters, or any other condition which the Commissioner of the IRS determines is deemed an immediate and financial need of the participant. Any distributions will be taken first from the participant's pre-tax deferral account and then from the participant's Roth deferral account.

*Forfeited Accounts* – At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$724 and \$-0-, respectively. The accounts will be used to reduce future matching contributions or pay administrative expenses. During 2024, \$2,988 was used to reduce Employer-matching contributions.

**Note 2—Summary of significant accounting policies**

*Basis of Accounting* – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

*Benefit Payments* – Benefit payments to participants are recorded upon distribution.

*Administrative Expenses* – Certain expenses of maintaining the Plan are paid by the Company and are, therefore, excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

### Note 2—Summary of significant accounting policies (continued)

*Investment Valuation and Income Recognition* – Investments in the Plan are reported at fair value, except for fully benefit-responsive investments, which are reported at contract value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

*Fair Value Measurements* – U.S. GAAP describes three levels of inputs that may be used to measure fair value as follows:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

*Mutual Funds* – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

*Common Collective Funds* – These investments are public investment vehicles valued at NAV of units of a trust. NAV, as provided by the administrator of the fund, is used as a practical expedient to estimate fair value and is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. This practical expedient is not used when it is determined to be probable the funds will sell the investment for an amount different than the reported NAV. Transactions (purchases and sales) may occur daily. Investments measured at fair value based on NAV as a practical expedient are excluded from the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. While the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 5—Fully benefit-responsive investment contract**

The Plan has invested in investment contracts at December 31, 2024 and 2023, which includes a guaranteed investment account, which was determined to be fully benefit-responsive. As a result of the contract being fully benefit-responsive, the contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by The Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The general investment account does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### **Note 6—Risk and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 7—Income tax status**

The IRS has determined and informed the Plan prototype sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Company has chosen to rely on the determination letter issued to the plan prototype sponsor. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax and, therefore, the Plan and related trust continue to be tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and have concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8—Parties-in-interest transactions**

Certain Plan investments are managed by the qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, which qualify as party-in-interest transactions. The Plan also uses Gallagher Fiduciary Advisors (“Gallagher”) for investment advisory services and The Standard as a third party administrator. Expenses paid to the qualified institutions, Gallagher and The Standard for the year ended December 31, 2024 totaled \$40,263. While these transactions qualify as party-in-interest activity, they are expressly exempted from prohibited transaction rules (ERISA, Title I, Section 408(b)).

**Note 9—Plan termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Employer contributions in their accounts.

**Note 10—Subsequent events**

Effective January 1, 2025, the Plan was amended to change the determination period for safe harbor matching contributions from each payroll period to the Plan year.

The Plan administrator has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued.
