The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.



Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules that agreed to or is derived from the certified investment information, was presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

Notes To The Financial Statements

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the F&W Forestry Services, Inc. 401(k) Savings and Retirement Plan & Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Eligibility for Participation

The F&W Forestry Services, Inc. 401(k) Savings and Retirement Plan & Trust is a defined contribution plan covering all permanent employees of F&W Forestry Services, Inc. and FWS California, LLC (the "Company"), who have attained the age of 21, with no minimum service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute a portion of their pre-tax or post-tax annual compensation, as determined and defined by the Plan. The Plan Sponsors contributes 100% of the first 4% of compensation that an employee contributes to the Plan. Additional amounts may be contributed at the option of the Plan Sponsors' Board of Directors. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan records employer and employee contributions receivable when compensation is paid and deferrals are withheld. In accordance with ASC 326, *Financial Instruments - Credit Losses*, no allowance for credit losses has been recorded at December 31, 2024 and 2023, as employer and employee contributions receivable have never historically incurred losses and current conditions and supportable forecasts show zero risk of nonpayment.

Participant Accounts

Each participant's account is credited with the participant's contributions and company matching contributions, and earnings in their account. The participant directs the investments of his or her account by allocating amounts among the investment choices provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. The loans are secured by the balance in the participant's account.

The participant will be charged a commercially reasonable rate of interest for any notes receivable from participants received from the Plan. The Plan Administrator will determine a reasonable rate of interest by reviewing the interest rates charged for similar types of loans by other lenders. The interest rate will be fixed for the duration of the notes receivable from participants.

NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Notes Receivable From Participants (Continued)

If approved, notes receivable from participants will provide for level amortization with payments to be made not less frequently than quarterly. Generally, the term of the notes receivable from participants may not exceed five (5) years. However, if the notes receivable from participants is for the purchase of a principal residence, the Plan Administrator may permit a longer repayment term. Generally, the Administrator will require that the participant repay the notes receivable from participants by agreeing to payroll deduction. If the participant has an unpaid leave of absence or goes on military leave while they have an outstanding notes receivable from participants, certain other repayment options are available.

All notes receivable from participants will be considered a direct investment into the participant's account under the Plan. All payments of principal and interest by the participant will be credited to their account.

If the participant fails to make payments when they are due under the terms of the note receivable from participants, the participant will be considered "in default." The Plan Administrator will consider the note receivable from participants to be in default if any scheduled note receivable from participants repayment is not made by the end of the calendar quarter following the calendar quarter in which the missed payment was due. The Plan would then have authority to take all reasonable actions to collect the balance owed on the note receivable from participants. This could include filing a lawsuit or foreclosing on the security for the loan. Under certain circumstances, a note receivable from participants that is in default may be considered a distribution from the Plan and could be considered taxable income to the participant. In any event, the participant's failure to repay the note receivable from participants will reduce the benefit the participant would otherwise be entitled to from the Plan.

Vesting

100% vested contributions. Participants are immediately 100% vested in their accounts attributable to the following contributions:

- Salary deferrals.
- Rollover contributions.
- Matching contributions.

Profit-Sharing Contributions

Participant's "vested percentage" in their accounts attributable to profit-sharing contributions is determined under a six (6)-year vesting schedule. No profit-sharing contributions have been provided currently, or in the past.

NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Investment Options

Upon enrollment in the Plan, participants may direct the investment of their accounts into various investment options offered by the Plan. They may change their investment options among those investments provided at any time during the Plan year.

Payment of Benefits

On termination of service due to death, disability, retirement, or termination of employment, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan also permits withdrawals to be made by participants who have incurred a "hardship" as defined in the Plan.

Forfeiture

Forfeiture is that portion of a participant's account that is not vested and becomes a forfeiture on the earlier of: the distribution of the entire vested portion of the participant's account of a participant who has severed employment with the Company, or; the last day of the plan year in which a participant who has severed employment with the Company incurs five (5) consecutive one-year breaks in service. There were no forfeitures during the year.

Subsequent Events

Subsequent events were evaluated through October 3, 2025, which is the date the financial statements were available to be issued.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

NOTE 2.**SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)****Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Substantially all of the expenses of maintaining the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value investments. They are all participant-direct charges for loans, distributions, etc. These expenses are charged to participant accounts.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments, and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

NOTE 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820-10-50, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under FASB ASC 820-10-50 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level or any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Group Annuity Accounts: Fair Value for Group Annuity Accounts is determined by prices published daily by the account manager, which is the net asset value (“NAV”) of the account (Level 1). Net asset value is determined by the fair value of the mutual funds, stocks, debt instruments, and other securities in the accounts. Participants can trade the group annuity accounts daily at the published NAV.

NOTE 5. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are units of mutual funds managed by John Hancock Life Insurance. John Hancock is the custodian of the Plan's assets and therefore qualifies as party-in-interest. Fees paid by the Plan for the investment management services amounted to \$62,949 for the year ended December 31, 2024. This party-in-interest transaction is exempt from the Prohibited Transaction Rules of ERISA. There are no other related-party or party-in-interest transactions.

NOTE 6. PLAN TERMINATION

Although the participating employers have not expressed any intent to do so, they have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE 7. INCOME TAX STATUS

The Internal Revenue Service (“IRS”) ruled on June 30, 2020, that the pre-approved plan of John Hancock Life Insurance Company upon which the Plan is based, is designed in accordance with applicable sections of the IRC. The Plan has been amended since receipt of the determination letter. However, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participant account balances and the amounts reported in the financial statements.
