December 31, 2024

1. Description of the Plan

The following description of the CommonSpirit Health ERISA 403(b) Plan, formerly Catholic Health Initiatives (ERISA) Employee Savings Plan (the Plan), provides only general information. Participants should refer to the summary plan description and plan document for a more complete description of the Plan's provisions.

General

The Plan is an Internal Revenue Code (the Code) Section 403(b) defined contribution plan with an effective date of January 1, 2011. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Except for employees of the Sierra Nevada Memorial Hospital (SNMH), Virginia Mason Medical Center, and CHI Franciscan Health (Highline Medical Center and Highline Community Health Services), the Plan is currently frozen to both participation and contributions (except for rollover contributions). Employees of CommonSpirit Health (CommonSpirit) and its affiliated employers are currently eligible to participate in the CommonSpirit Health 401(k) Retirement Savings Plan.

Employees of SNMH began participating in the Plan on April 1, 2022, at which time the Plan was unfrozen only for these employees.

Employees of Virginia Mason Medical Center began participating in the plan on January 1, 2024.

Employees of CHI Franciscan Health (Highline Medical Center and Highline Community Health Services) began participating in the plan on September 1, 2024.

The Advent Health Employees' Disaffiliation Agreement occurred on July 31, 2023. The employee's funds transferred out of the plan on February 7, 2024.

Fidelity Management Trust Company (Fidelity), Voya Retirement Insurance and Annuity Company (Voya), American United Life Insurance Company (AUL), American Century Investments (American Century), and Lincoln National Insurance Company (Lincoln) are custodians of the Plan. Fidelity Investments is record-keeper for the Plan.

CommonSpirit Health ERISA 403(b) Plan

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

The Plan is administered by the CommonSpirit Health Retirement Plans Sub-committee (the Committee). The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to CommonSpirit Health's Human Resources and Compensation Committee of the Board of Stewardship Trustees.

Contributions

Participants may contribute up to 80% of pretax annual compensation as defined in the Plan. Contributions are limited by the Code's annual limit or by plan limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. All contributions are subject to certain limitations of the Code. Participants may also make Roth contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants are eligible to start making deferral contributions on the first day of employment.

Matching contributions are made to the Plan for employees of SNMH on a pay-period basis. To become eligible for matching contributions, an employee must work 1,000 hours during the period beginning with the employee's commencement date. Matching contribution amounts are based on employment status. The amount of matching contribution is based on the employee's years of service with CommonSpirit. For employees with years of service greater than one but less than six, the matching contribution is 100% of deferrals up to 5% with increasing deferral limits for six up to ten or more years of service in increments of 1% per year, for a maximum match of 100% of deferrals up to 10% of pay. The Plan provides for a "true-up" contribution to be made each payroll period to ensure that participants have received their full match as calculated on an annual basis.

Matching contributions are made for employees of CHI Franciscan Health equal to 100% of employee contributions, up to 2% of eligible compensation deferred to the Plan. To become eligible, employees must be 18 years old and have completed two years of service without an intervening break in service. CHI Franciscan Health further contributes a discretionary contribution equal to 5% of eligible compensation for each employee who is eligible for the discretionary contribution. Participants eligible to receive the CHI Franciscan Health's matching contribution are also eligible for the discretionary contribution.

Virginia Mason Medical Center employees are not eligible for matching contributions.

All investments in participant accounts are participant directed.

CommonSpirit Health ERISA 403(b) Plan

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Participant Accounts

Each participant's account is credited with allocations of plan earnings and is charged a fixed per annum rate of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of his or her respective elected investment options. Administrative expenses are based on a fixed per annum rate. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The fixed administrative fee is charged only one time (on a quarterly basis) for each participant who has an account in the Plan and any other CommonSpirit plan administered by Fidelity.

Participants direct the balances of their accounts into various investment options offered by the Plan and can change their investment options on a daily basis.

Vesting

Mergers and acquisitions have resulted in a variety of vesting schedules, ranging from 100% fully vested immediately to a three- to six-year graded schedule.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,637,143 and \$1,279,653, respectively. These accounts will be used first to pay administrative expenses and then to reduce employer contributions. During 2024, the Plan used \$1,098,624 to reduce employer contributions.

Participant Loans

Notes receivable from participants represent participant loans. Participants are allowed two loans to be outstanding at any time. Participants may not borrow less than \$1,000 in any single loan. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate, as determined by the plan administrator. Principal and interest payments are made through payroll deduction. Loans for the purchase of a principal residence have a term of 15 years.

1. Description of the Plan (continued)

Payment of Benefits

Participants are entitled to distributions from the Plan upon death, disability, normal or early retirement, or other termination of employment. Upon termination of service, a participant will receive his or her vested benefits under the Plan. The forms of distribution include a lump-sum distribution, installments, or a partial lump-sum distribution, with the remainder taken as a lump-sum distribution or installments at a later date.

Additionally, participants may request distribution of certain portions of their accounts due to financial hardship, as defined, with a minimum of \$500.

Administrative Expenses

Substantially all administrative and trustee fees are paid by the participants through a fixed per annum fee, charged on a quarterly basis, and investment fees are deducted directly from investment returns.

Plan Termination

Although it has not expressed any intent to do so, CommonSpirit has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Transfers From (to) Other Plans

Due to the mergers of the CHI Franciscan Health Retirement Savings Plan, the 403(b) Thrift Plan of St. Alexius Medical Center and Garrison Memorial Hospital, and the Virginia Mason Medical Center 403(b) Plan, amounts transferred into the Plan were \$122,688,251, \$162,000,721, and \$547,431,452, respectively. Due to the Advent Health Employees' Disaffiliation Agreement, \$53,645,260 was transferred out of the Plan.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Benefits Paid to Participants

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan (except for fully benefit-responsive investment contracts) are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for further discussion and disclosures related to fair value measurements.

In accordance with Accounting Standards Codification 820, *Fair Value Measurement*, assets and liabilities measured at fair value are categorized into the following fair value hierarchy:

- Level 1: Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for assets or liabilities. The fair value hierarchy gives the highest priority to Level 1 inputs.
- Level 2: Inputs other than quoted prices in active markets for identical assets and liabilities that are observable, either directly or indirectly, for substantially the full term of the asset or liability.

CommonSpirit Health ERISA 403(b) Plan

Notes to Financial Statements (continued)

2. Summary of Accounting Policies (continued)

- Level 3: Unobservable inputs are used when little or no market data is available. Therefore, fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and observable. These inputs reflect management's judgments about the assumptions that a market participant would use in pricing the investment and are based on the best available information, some of which may be internally developed. The fair value hierarchy gives the lowest priority to Level 3 inputs.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought, sold, and held during the year.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 or 2023.

Mutual Funds: Mutual funds, including mutual funds invested in self-directed brokerage accounts, are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest from notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity, Voya, AUL, American Century, and Lincoln, the custodians of the Plan.

5. Fully Benefit-Responsive Investment Contracts

The Plan provides participants with three fixed annuity contract investment options that are fully benefit responsive – one through the Variable Annuity Life Insurance Company, one through the Voya Retirement Insurance and Annuity Company, and one through the Lincoln National Life Insurance Company. These contracts meet the fully benefit-responsive investment contract criteria and are, therefore, reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under contract, plus earnings, less participant withdrawals and administrative expenses, if any.

The funds are supported by the Variable Annuity Life Insurance Company general account, the Voya Retirement Insurance and Annuity Company general account, and the Lincoln National Life Insurance Company general account and have no maturity date. If all participants were eligible for a distribution of their full accounts from the Plan on the reporting date, the amount payable on demand on the reporting date would be the contract value. There were no reserves against contracts' value for credit risk on the contract issuers or otherwise.

The crediting interest rate is based on a formula established by the contract issuer and is reviewed on an annual basis for resetting. The crediting interest rate contractually guaranteed is credited to participant account balances. There are no unfunded commitments from the Plan.

5. Fully Benefit-Responsive Investment Contracts (continued)

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The Variable Annuity Life Insurance Company, the Voya Retirement Insurance and Annuity Company, and the Lincoln National Life Insurance Company do not specify any events that would limit the ability of the Plan to transact at contract value with the issuer or any events that would allow the issuer to terminate the contracts and settle for an amount different from contract value.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

7. Related-Party and Party-in-Interest Transactions

The Plan invests in certain funds managed by Fidelity, Voya, Lincoln, AUL, and American Century, the custodians of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

8. Income Tax Status

The underlying prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated August 7, 2017, stating that the written form of the underlying prototype document is qualified under Section 403(b) of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 403(b) of the Code, and, therefore, the related custodial accounts are tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related custodial accounts are tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
