As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

December 31, 2024

1. Description of the Plan

The following description of CommonSpirit Health 401(k) Retirement Savings Plan, formerly Catholic Health Initiatives 401(k) Retirement Savings Plan (the Plan), provides general information. Participants should refer to the plan document for a complete description of the Plan's provisions.

General

The Plan, effective as of July 1, 1998, is a participant-directed, defined contribution plan covering employees of adopting employers (the Employers) of CommonSpirit Health (the plan sponsor or CommonSpirit). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Fidelity Management Trust Company (Fidelity) is trustee, and Fidelity Investments is the record-keeper for the Plan.

The Plan is administered by the CommonSpirit Health Retirement Plans Sub-committee (the Committee). The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to CommonSpirit Health's Human Resources and Compensation Committee of the Board of Stewardship Trustees.

Employees of Virginia Mason Medical Center began participating in the plan on January 1, 2024, receiving employer nonelective contributions only.

Employees of St. Alexius Medical Center and Garrison Memorial Hospital began participating in the plan on January 1, 2024.

The Advent Health Employees' Disaffiliation Agreement occurred on July 31, 2023. The employees' balances transferred out of the plan on February 7, 2024.

Contributions

Participants may contribute up to 80% of pretax annual compensation as defined in the Plan. Contributions are limited by the Internal Revenue Code (the Code) annual limit or by plan limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make Roth contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants are eligible to start making deferral contributions on the

first day of employment. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated fund (T. Rowe Price Retirement Fund) until changed by the participant. The automatic enrollment feature takes effect 60 days following the participant's date of hire. The automatic percentage increases 1% annually until the percentage reaches 10%.

Matching contributions are made to the Plan by substantially all participating employers on a pay-period basis. To become eligible for matching contributions, an employee must work 1,000 hours during the period beginning with the employee's commencement date. Matching contribution amounts are based on employment status. Certain participating employers provide a match of 100% up to 1% of compensation, plus 50% in excess of 1% up to 6% of compensation. Other participating employers provide a match of 50% up to 6% of compensation. Certain employees at Consolidated Health Services, Inc. (CHS) (PRN (i.e., on-call or necessary employees) and temporary) are excluded from the matching provisions of the Plan. The Plan provides for a "true-up" contribution to be made subsequent to December 31 to ensure that participants have received their full match as calculated on an annual basis. To be eligible for the true-up contribution, the participant must have been paid 1,000 hours and be employed on December 31. Nonelective contributions can be made based on the discretion of the participating employer. Such amounts equal 2.5% of compensation (\$1,000 minimum) or 1.0% of compensation dependent upon the employment status of the participant. CHS employees receive 1.0% compensation with no annual minimum nonelective contribution. To become eligible, an employee must complete one year of service.

Employees of Virginia Mason Medical Center are not eligible for employee deferrals or employer matching contributions. Employees of Virginia Mason Medical Center to become eligible for the nonelective contributions, employees must have one year of service with 1,000 hours and have attained age 21. An Additional allocation requirement is to be employed on December 31. The nonelective contribution formula is service-based with social security wage base integration. Employees with 1–5 years of service: 3.5% of compensation up to the social security wage base for the plan year, plus 9.2% of excess compensation, up to \$180,000. Employees with 6 years of service or more: 6.3% of compensation up to the social security wage base for the plan year, plus 12% of excess compensation, up to \$180,000.

All investments in participant accounts are participant directed.

1. Description of the Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and with allocations of (i) employer contributions and (ii) plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The fixed administrative fee is charged only one time (on a quarterly basis) even if a participant has multiple CommonSpirit plan accounts administered at Fidelity.

Vesting

Participants are immediately vested in all employee contributions plus actual earnings thereon. Employer contributions made to the Plan prior to January 1, 2014, plus actual earnings thereon, are also 100% vested. Matching and nonelective contributions made to the Plan after January 1, 2014, are subject to a three-year cliff vesting schedule.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$27,055,216 and \$17,958,697, respectively. These accounts will be used first to pay administrative expenses and then to reduce employer contributions. During 2024, the Plan used \$15,327,432 to reduce employer contributions.

Participant Loans

Notes receivable from participants represent participant loans. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years or up to 15 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest in an amount equal to the prime rate published in *The Wall Street Journal* as of the first day of the month preceding the date the loan was initiated, plus 1%. Principal and interest are paid ratably through payroll deductions. Any participant who has defaulted on a prior loan is not allowed to take a new loan unless the first loan has been repaid.

Payment of Benefits

Upon termination of service, retirement, disability, or death, participants (or their beneficiaries) may receive a lump-sum amount equal to the vested value of their accounts.

Administrative Expenses

Certain administrative expenses necessary to administer the Plan are paid by CommonSpirit. Participants are charged an \$8.50 per quarter administrative fee. The fee for this plan is waived for participants who also actively participate in another CommonSpirit plan.

Plan Termination

Although it has not expressed any intent to do so, CommonSpirit has the right to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their employer contributions made to the Plan.

Transfers From (to) Other Plans

Effective January 1, 2024, Virginia Mason Medical Center Retirement Plan merged into the Plan and \$547,225,719 of participants' balances transferred into the Plan in connection with this merger. Due to the Advent Health Employees' Disaffiliation Agreement, \$322,146,733 of participants' balances transferred out of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Benefits Paid to Participants

Benefits are recorded when paid.

2. Summary of Significant Accounting Policies (continued)

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan (except for fully benefit-responsive investment contracts) are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for further discussion and disclosures related to fair value measurements.

In accordance with Accounting Standards Codification 820, *Fair Value Measurement*, assets and liabilities measured at fair value are categorized into the following fair value hierarchy:

- Level 1: Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for assets or liabilities. The fair value hierarchy gives the highest priority to Level 1 inputs.
- Level 2: Inputs other than quoted prices in active markets for identical assets and liabilities that are observable, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Unobservable inputs are used when little or no market data is available. Therefore, fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable. These inputs reflect management's judgments about the assumptions that a market participant would use in pricing the investment and are based on the best available information, some of which may be internally developed. The fair value hierarchy gives the lowest priority to Level 3 inputs.

Notes to Financial Statements (continued)

2. Summary of Significant Accounting Policies (continued)

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value includes the Plan's gains and losses on investments bought, sold, and held during the year.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 or 2023.

Mutual Funds and Collective Investment Trusts: Mutual funds, including mutual funds invested in self-directed brokerage accounts, and collective investment trusts are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

Self-Directed Brokerage Accounts: Self-directed brokerage accounts include mutual funds (valued as noted above) and common stock, preferred stock, and government and corporate bonds, all of which are primarily valued at quoted market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

3. Investments

All investment information disclosed in the accompanying financial statements, footnotes, and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest from notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity.

5. Fully Benefit-Responsive Investment Contract

The Plan has a balance in the VALIC Fixed Account, which is a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under contract, plus earnings, less participant withdrawals and administrative expenses.

Notes to Financial Statements (continued)

5. Fully Benefit-Responsive Investment Contract (continued)

The VALIC Fixed Account is maintained in a general account with VALIC. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.25%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Code or the failure of the trust to be tax-exempt under Section 501(a) of the Code
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

5. Fully Benefit-Responsive Investment Contract (continued)

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

7. Related-Party and Party-in-Interest Transactions

The Plan invests in certain Fidelity funds managed by Fidelity, the custodian of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

8. Income Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated January 23, 2012, stating that the Plan is qualified under Section 401(a) of the Code, and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended and restated. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the Code.

8. Income Tax Status (continued)

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
