Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Fenwal International, Inc. Savings & Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Fenwal International, Inc. Note 1 - Description of plan

The following brief description of Fenwal International, Inc. Savings & Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan, covering substantially all employees of Fenwal International, Inc. (the Company) or its affiliate, Fresenius Kabi USA, LLC. The Plan was established on April 24, 1998 and has been subsequently amended as described below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the designated administrator of the Plan and Great-West Life and Annuity Insurance Company. (“Empower Retirement”) is the custodian of the Plan responsible for the management and control of the Plan’s assets which are held in individual participant investment accounts.

Eligibility

Each employee is eligible to participate on the first entry date (first day of each Plan calendar month) after the completion of 30 days of continuous service.

Contributions

Each year participants may elect to contribute up to 100 percent of their eligible pay subject to certain limits as defined in the Plan. Contributions are limited by the Puerto Rico Internal Revenue Code (PRIRC), which established a maximum contribution of \$15,000 for the year ended December 31, 2024. Participants may only contribute in a tax deferred basis (before-tax). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Eligible employees who have not made an affirmative election to defer or not defer will have elective deferrals withheld in the amount of one percent of their compensation, which the employee can alter or revoke at any time, to be invested in the appropriate target date retirement fund.

The Company makes a matching contribution for the participant in an amount equal to 100 percent of the participant’s first 3 percent of eligible pay contributed to the Plan. Additional profit sharing amounts may be contributed at the option of the Company’s board of directors. Participants who are employed on the last day of the Plan year share in any discretionary profit sharing contributions.

Catch-up contributions

Plan participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions to the Plan up to \$1,500 in excess of the annual \$15,000 of the eligible compensation limitation. However, these catch-up contributions will not be eligible for matching contributions by the Plan Sponsor.

Note 1 - Description of plan (continued)

Participant accounts

Participant recordkeeping is performed by Empower Retirement. Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of investment earnings, and is charged with withdrawals, an allocation of investment losses and its share of any expenses of the Plan. Transaction fees charged for participant loans and distributions are allocated directly to that participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in all of their contributions, employer match contributions and actual earnings thereon and are not subject to forfeitures for any reasons.

Benefit payments

Participant accounts are distributable upon termination of service retirement, death, disability or separation of service, a participant (or participant's beneficiary in the event of death) may elect to receive the participant's vested account balance in a lump-sum distribution or elect an installment form of payment (monthly, quarterly, semi-annual or annual) for a payment period of up to ten years. In addition, participant accounts can be rolled over into an individual retirement account ("IRA") or another qualified plan.

Hardship Withdrawals

Participants may withdraw all or part of their vested account balances, upon demonstration of a financial hardship subject to the requirements of the Plan. Hardship withdrawals are permitted based on the safe harbor rules. In-service withdrawals also are permitted with respect to a participant's rollover contributions.

Notes receivable from participants

Participants may borrow up to 50% of their vested account balances, not to exceed \$50,000. The interest rate charged on participant loans will be fixed throughout the term of the loan and will equal one plus the prime rate, as published in the Wall Street Journal, in effect on the first day of the month in which the loan request was received by the administrative committee. All loans will be evidenced by a promissory note and security agreement and will be secured by up to 50% of a participant's nonforfeitable account balance determined immediately after the origination of the loan. The loan repayment period may not exceed five years unless the loan is for the purpose of acquiring a principal residence, in which case repayment might be for a period longer than five years without being treated as a taxable distribution.

In the event of a default by a participant on a loan repayment, all remaining principal payments on the loan will be immediately due and payable.

Administrative expenses

Investment management fees and other fees related to investments of the Plan are paid from the earnings of the Plan's investments. Audit fees, legal fees, and other fees related to the administration of the Plan may be paid directly from the Plan. Other administrative expenses and some professional fees are paid by the Company and are not reflected within these financial statements. Expenses related to participant loans are paid by the Plan and charged to the respective participants account.

Note 2 - Summary of significant accounting policies

Basis of accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affected the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the Plan document.

Payment of benefits

Benefits are recorded when paid.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Investments in pooled separate accounts are valued on a per unit market value basis as determined by Empower Retirement, which reflects the fair value of the investments comprising the separate pooled funds. See Note 5 for a discussion of fair value measurements.

Net appreciation in fair value of investments consists of realized gains and losses and the change in unrealized gains and losses in the Plan's investments. Realized gains and losses from the sale of investments are computed using the participant's cost basis in the investment aggregated at the Plan level. Net changes in unrealized appreciation/depreciation in investments represents the difference between the fair value of investments held at year-end and the cost of investments purchased in the current fiscal year or the fair value of investments held at the end of the preceding year.

Note 3 - Information certified by custodian

For 2024 and 2023, the financial information included in the Plan's financial statements, except for contributions receivable, contributions, and distributions for withdrawals and terminations, has been derived from information certified as complete and accurate by the custodian, in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under the Employee Retirement Income Security Act of 1974

Note 4 - Investment contract with Insurance Company

The Plan maintains a fully benefit-responsive investment contract with Empower Retirement. Empower Retirement maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

As described in the basis of accounting disclosure, because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Great-West, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract approximates contract value. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 5 - Fair value measurements

UASC Topic 820, *Fair Value Measurements*, defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Topic 820 also specifies a fair value hierarchy which requires a plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

- *Level 1* — Quoted prices in active markets for identical assets or liabilities.
- *Level 2* — Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- *Level 3* — Unobservable inputs (i.e. projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Valued at the net asset value ("NAV") of shares held by the Plan at year end. The NAV is a quoted price in an active market.

Fixed Annuities: Valued based on based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly.

Collective Trust Funds: Share prices/NAV's reported are generally obtained directly from the fund house or other investment provider.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 6 – Transactions with Parties-in-Interest

The Key Guaranteed Portfolio (Portfolio) is managed by Great-West, who is recordkeeper of the Plan. Transactions in the Portfolio are considered to be party-in-interest investments any purchases and sales of these investments are open market transactions at fair market value. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. Fees paid by the Plan to the custodian for the investment management and recordkeeping services amounted to \$93,579 and \$77,998 for the years ended December 31, 2024 and 2023, respectively.

The Plan has notes receivables from certain of its participants. These transactions qualify as party-in-interest transactions, as defined by ERISA. However, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

Note 7 - Tax status

The Puerto Rico Treasury Department issued a favorable determination on the Plan through a letter dated June 27, 2023 stating that the Plan, as adopted effective January 1, 2017, is qualified under section 1081.01 of the Puerto Rico Internal Revenue Code (PRIRC) and that the trust established under the Plan is tax-exempt. The Plan is required to operate in conformity with the PRIRC to maintain its qualified status. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the PRIRC and no provision for income taxes has been included in the Plan's financial statements.

Effective on January 1, 2017 the Plan is subscribed under the TPA's Pension Administrators Group, Inc. Prototype Defined Contribution Retirement Plan Program which has been qualified under the appropriate sections of the Code. The Pension Administrators Group, Inc. Prototype Defined Contribution Retirement Plan Program obtained its latest determination letter on December 14, 2012, in which the Commonwealth of Puerto Rico tax authorities stated that the TPA's prototype plan, as then designed, was in compliance with the applicable requirements of Section 1081.01 of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Puerto Rico taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by the Puerto Rico taxing authorities; however, there are currently no audits for any tax periods in progress.

Note 8 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their employer contributions.
