### **Note 1. Description of the Plan**

#### General

The Plan is a defined contribution plan that covers substantially all employees of Peerless Technologies Corporation (the Company and Plan sponsor) who have attained 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Participants may voluntarily contribute amounts up to certain limitations as stipulated by applicable IRS Code Sections. Pre-tax elective deferrals and after-tax Roth contributions are available. Participants who have attained age 50 by the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans or accounts. The Plan allows automatic enrollment (with a 3% salary deferral) for newly hired employees until they elect otherwise and beginning after the second year, automatic 1% annual increases in the deferral percentages until the 6% level is attained. If a participant does not wish to participate in this automatic incremental increase or wishes to change the amount of future annual increases in his or her contribution percentages, he or she can do so by contacting the Plan's third-party administrator. The Company makes safe harbor contributions equal to 3% of compensation to eligible participants' accounts. The Company may also provide discretionary nonelective contribution amounts.

#### Participant accounts

Each participant's account is credited with the participant's contributions, Company contributions, and actual earnings thereon. Each participant's account is charged with his or her withdrawals and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions and additional matching contributions, plus earnings thereon. Vesting in the Employer's safe harbor and nonelective contributions is provided over 2 years, 50% per year, or at the attainment of the normal retirement age of 65. Earlier vesting may occur upon death or disability.

Participants who were terminated prior to January 1, 2010 vested using the 5-year cliff for Company discretionary match. Safe harbor contributions made prior to January 1, 2017 are 100% vested. Participants whose employment commencement date is prior to January 1, 2017 will be 100% vested at all times in nonelective and safe harbor contributions.

#### Forfeitures

Forfeited, non-vested accounts totaled \$48,231 and \$31,961 at December 31, 2024 and 2023, respectively. Forfeited amounts can be used to pay administrative expenses or to offset future employer contributions. During 2024 forfeited, non-vested accounts were used to reduce employer contributions by \$395, and \$438 were used to pay administrative expenses.

#### Payment of benefits

The Plan provides for payment of normal retirement benefits of accumulated vested amounts upon reaching age 65 and has provisions for early withdrawals of vested benefits in instances of early retirement, disability, death, termination of employment, and financial hardship. A participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or regular installment payments.

### **Note 1. Description of the Plan (Continued)**

#### Notes receivable from participants

Participants may borrow from their fund accounts. Loans must be a minimum of \$1,000 and may not exceed the lesser of \$50,000 or 50% of a participant's vested account balance. The repayment period is generally not exceed five years unless the loan is used for the purchase of a primary residence. Each loan is collateralized by the remaining balance in the participant's account and bear interest at prevailing market rates as set by the Plan. Interest rates on participant loans ranged from 4.25% to 9.5% as of December 31, 2024. Principal and interest are paid ratably through payroll deductions.

#### Investment options

Participants may direct the investment of their accounts into various investment options offered under the Plan. Participants may change their investment choices on a daily basis.

### **Note 2. Significant Accounting Policies**

#### Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Accounting Standards Codification (ASC) as produced by the Financial Accounting Standards Board (FASB) is the sole source of authoritative U.S. GAAP.

#### Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments held by the Plan are reported at fair value, with the exception of certain investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value reflects the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan and is the relevant measure for the portion of assets attributable to fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

#### Notes receivable from participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

#### Payment of benefits

Benefits are recorded when paid.

### **Note 2. Significant Accounting Policies (Continued)**

#### Administrative expenses

Administrative expenses of the Plan are paid by the Company or Plan participants, as defined in the Plan agreement.

#### Investment management fees and operating expenses

Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation (depreciation) in fair values of investments.

#### Date of management's review

Subsequent events have been evaluated by management through October 08, 2025, the date the statements were available to be issued.

### **Note 3. Information Certified by the Plan's Trustee**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America, the trustee of the Plan, has certified to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the Schedule of Assets (Held at End of Year) at December 31, 2024, and the related interest and dividends and net (depreciation) appreciation in fair value of investments information reflected in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

### **Note 4. Investment Contract**

The Plan has a fully benefit responsive group annuity contract with Empower Annuity Insurance Company of America ("EAICA"), which is called the EI Fixed Account . EAICA maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses.

Since the group annuity contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$1,389,168 and \$1,711,024, respectively.

Certain events limit the Plan's ability to transact at contract value with EAICA. Such events include the following: (1) premature termination of the contracts by the Plan, (2) plant closings, (3) layoffs, (4) Plan termination, (5) bankruptcy, (6) and early retirement incentives. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. EAICA may not terminate the contract at any amount less than the contract value.

EAICA is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with EAICA. Such interest rates are reviewed quarterly for resetting. The crediting rate of the product will be established based on the earnings of the underlying assets in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The average yield earned by the Plan for the group annuity contract is derived by averaging the quarterly gross interest rates for the fund over the year.

### Note 5. Fair Value Measurement

FASB ASC 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Quoted prices in active markets for identical assets or liabilities.
Level 2	Observable inputs other than quoted prices included in Level 1, such as quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
Level 3	Unobservable inputs, where there is little or no market activity for the asset or liability. These inputs reflect the reporting entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability, based on the best information available.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 6. Income taxes

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Company's management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 7. Party-in-Interest transactions

Certain administrative services are provided by the Company at no cost to the Plan and certain administrative costs incurred by the Plan are paid by the Company.

The Plan's administrative fees result from services rendered by parties-in-interest.

Plan investments include a fully benefit-responsive contract issued by Empower Annuity Insurance Company of America, which is the Plan's trustee, and therefore, this investment qualifies as a party-in-interest transaction.

### Note 8. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participants will become 100% vested in their accounts.

### Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note 10. Nonexempt Transactions

The Company failed to remit employee deferral contributions totaling \$72,760 and \$89,096 in 2024 and 2023, respectively, for certain payroll periods within the timeframe prescribed by the Department of Labor. These are deemed prohibited transactions in accordance with ERISA and IRC.
