

**NOTE A – DESCRIPTION OF PLAN**

The following information about the Crosby Marketing Communications, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

Crosby Marketing Communications, Inc. (the "Company") is the plan sponsor and serves as plan administrator. The Plan is a 401(k) defined contribution plan covering employees of the Company who are 21 years or older, and have completed three consecutive months of employment with a minimum of 500 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute up to 100 percent of annual compensation, as defined in the Plan. Contributions may be pre-tax 401(k) deferrals or Roth 401(k) deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Each year, the Company may make discretionary matching and profit sharing contributions to the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately 100% vested in their voluntary contributions and rollover contributions. Employer contributions are vested on 6-year graded vesting schedule below:

- 0 to 1 year – 0%
- 2 years – 20%
- 3 years – 40%
- 4 years – 60%
- 5 years – 80%
- 6 years – 100%

**Notes Receivable from Participants**

Participants may borrow from their fund accounts provided the outstanding balance of their loan does not exceed 50% of the vested interest in the Plan. Participants may have one outstanding loan at a time, and the minimum loan amount is \$1,000. Loans are secured by the balance in the participant's account and bear interest at 1% above prime. The interest rate will be fixed for the duration of the loan which cannot exceed 5 years. If the loan is used to purchase a principal residence, the term may be extended. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service for any reason, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. The Plan also permits in-service distributions for participants 59 ½ years and older.

**Forfeitures**

Forfeitures occur when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures of non-vested Company contributions are used to reduce future Company contributions. Applied forfeitures for the year ended December 31, 2024 were \$170,000. Unapplied forfeitures as of December 31, 2024 and 2023 were \$31,153 and \$111,208, respectively.

**NOTE B – SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are maintained and the accompanying financial statements have been prepared using the accrual method of accounting.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investments Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Excess Contributions Payable**

Amounts payable to participants for contribution in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**NOTE C – CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Alerus Financial, N.A., custodian of the Plan.

**NOTE D – FAIR VALUE MEASUREMENTS**

FASB *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Plan investments are comprised of mutual funds. The Plan offers a stable value fund investment option – a type of mutual fund that provides fixed income. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE E – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE F – TAX STATUS**

The Internal Revenue Service has determined, in a letter dated November 30, 2020, that the form of the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G – PARTIES-IN-INTEREST TRANSACTIONS**

The Plan has a number of service providers. Such parties are parties-in-interest under ERISA. The Plan pays Alerus Financial, N.A. for custodian services and Blue Ridge Associates for record-keeping services; these transactions qualify as party-in-interest transactions.

**NOTE H – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.


