Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the POET 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

Note 1. Description of the Plan

The following is a brief description of the POET 401(k) Plan (the Plan) and is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan sponsored by POET Holding Company, LLC (adopting employer) and the following participating employers: Ethanol Products, LLC, POET Biorefining, LLC and all of its subsidiaries, POET DSM Advanced Biofuels, LLC and its subsidiary POET-DSM Project Liberty, LLC, POET, LLC, POET Plant Management, LLC, POET Design & Construction, Inc., POET Research, Inc., POET Nutrition, Inc., POET Nutrition Marketing, LLC, POET Research Center, Inc., POET Biomass, LLC and POET Leasing, LLC (collectively referred to as the participating employers). All aforementioned participating employers will collectively be referred to as the Company or Employer. The purpose of the Plan is to provide retirement benefits for employees of the Company and their beneficiaries.

The Plan is available to all employees who are employed by the Company and have completed one hour of service within one month of employment and have attained the age of 18. Employees are able to enter the Plan on the first day of the month coinciding with or following the date the eligibility requirements are satisfied. Once the eligibility requirements are met, employees are automatically enrolled in the Plan at a 6% deferral rate, which shall increase 1% per year on the first day of the plan year up to a maximum of 10%, unless the employee elects a different deferral percentage or opts out of the Plan. Employees contributing to the Plan are eligible for employer matching contributions upon completion of one month of employment and participating employer profit sharing contributions upon completion of one year of employment. Participants must be employed on the last day of the plan year to receive the profit sharing contribution.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company's Board of Directors is responsible for oversight of the Plan. The Plan's 401(k) Investment Advisory Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Directors.

Contributions: Participants are permitted to contribute up to 100% of their pretax or after-tax annual compensation, as defined in the Plan document, up to the maximum allowed by the Internal Revenue Code (IRC). Participants are also permitted to make rollover contributions from other qualified plans. Additional employer matching and profit sharing amounts may be contributed at the option of the Board of Directors. Prior to March 2024, participants, excluding Ethanol Products, LLC participants, received an employer matching contribution equal to 50% of the first 6% of employee compensation contributed. Ethanol Products, LLC participants received an employer matching contribution equal to 100% of the first 6% of employee compensation contributed. Effective March 2024, a new uniform matching structure was implemented for all participants, providing an employer match equal to 100% of the first 4% of employee contributions. There were no profit sharing contributions for the year ended December 31, 2024.

Participant accounts: Each participant's account is credited with the participant's contributions and discretionary employer matching and profit sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan (if not paid with forfeitures). Allocations are based on participant earnings, account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1. Description of the Plan (Continued)

Investment options: Upon enrollment in the Plan, a participant may direct contributions in a variety of investment options. All funds vary in types of investments, rates of return, and investment risk and are described in more detail in the Plan's literature. Participants may elect on a daily basis to have all or part of their account balances and future contributions transferred from one fund to another or in any combination.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on a graded scale over six years of continuous service at any recognized POET-managed facility. A participant becomes 100% vested upon death or permanent disability. Participants who had a more liberal vesting schedule prior to being merged into the Plan continue to use their prior vesting schedules.

Notes receivable from participants: Participants can borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding note balance during the prior 12-month period or 50% of their account balance. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. The notes are secured by the balance in the participant's account and bear interest at prevailing interest rates charged by persons in the business of lending money for notes which would be made under similar circumstances. The interest rates on outstanding notes at December 31, 2024, range from 4.25% to 9.50%. The outstanding notes mature through July 2054. Principal and interest are paid through payroll deductions. The repayment period is no more than five years unless such note is for the purchase of the participant's primary residence, in which case the repayment period is 30 years. Participants are able to have up to two loans outstanding at a time as long as one loan is for participant's primary residence. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan payments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Notes receivable from participants have been classified as an investment for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Benefit payments: Upon death, permanent disability, retirement or other termination of employment, participants or their beneficiaries, are entitled to receive the vested balance of their account. Vested benefits are distributed in the form of a lump-sum amount, installment payments, an annuity contract or any combination of these options. The Plan includes an early retirement option for participants age 55 or older with at least five years of service. The Plan allows in-service distributions without a minimum service period after the age of 59½. The Plan also allows hardship distributions subject to certain restrictions. Distribution of benefits upon termination is automatic if the participant's account balance is less than \$7,000. Participants with an account balance less than \$7,000 will have their account balance rolled over into an individual retirement account unless they elect to receive a lump-sum payment.

Forfeitures: Forfeited nonvested accounts are used to restore previously forfeited balances, pay Plan administrative expenses or fund employer contributions. Approximately \$158,000 and \$113,000 of forfeitures were used during 2024 to pay Plan administrative expenses and fund employer matching contributions, respectively. The available amount of forfeited nonvested accounts to be applied toward future employer contributions or pay Plan administrative expenses was approximately \$798,000 and \$220,000 as of December 31, 2024 and 2023, respectively.

Plan termination: Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of termination, all participant accounts become fully vested.

Note 2. Summary of Significant Accounting Policies

Basis of presentation: The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Investment Advisory Committee determines the Plan's valuation policies, utilizing information provided by the Plan's investment advisors and custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions: Contributions from Plan participants and employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation.

Risks and uncertainties: The Plan provides for investment in a variety of investment securities. In general, investment securities are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments have occurred since December 31, 2024, or will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

The Standard Insurance Company also certified to the completeness and accuracy of \$34,737,447 of net appreciation in fair value of investments and \$145,730 of interest income on notes receivable from participants for the year ended December 31, 2024.

Note 4. Fair Value Measurements

Accounting standards establish the framework for measuring fair value. The following is a description of the valuation methodology used for assets measured at fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted, quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Pooled separate accounts are primarily valued at net asset value (NAV) per share used as a practical expedient, based on quoted market prices for the underlying securities or similar instruments.

In accordance with Accounting Standards Codification 820-10, the pooled separate accounts held by the Plan are not classified in the fair value hierarchy table that prioritizes the inputs to valuation techniques used to measure fair value because they are measured at NAV per share as a practical expedient.

Note 4. Fair Value Measurements (Continued)

The method described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes its valuation methodology is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related-Party Transactions and Party-in-Interest Transactions

The Standard Retirement Services, Inc. provides certain administrative and asset management services to the Plan. Certain Plan investments as of December 31, 2024 and 2023, are pooled separate accounts managed by The Standard Insurance Company, the custodian, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions.

Note 6. Tax Status

The Plan has adopted a preapproved plan that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with the applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes that the Plan is designed, and being operated, in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Prohibited Transactions

During 2024, the Plan Sponsor inadvertently failed to deposit \$113 of contributions within the required time frame as stated by the Department of Labor's regulations. The Plan Sponsor has deposited lost earnings to correct this failure in 2025 and has filed Form 5330 and paid applicable excise tax to the IRS. The correction and excise taxes were made from the Plan Sponsor's assets and not from the assets of the Plan.
