- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). **Note 1. Description of the Plan**

The following description of the (the Plan) provides only general information. Participants should refer to the plan document and the *Summary Plan Description* for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan sponsored by Confidence Plumbing Company, Inc. (the Company) for the benefit of its employees who have at least one year of service (1,000 hours per year), and are age 21 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Michael Welch, plan sponsor CEO, is the trustee of the Plan and Transamerica Financial Life Insurance Company Inc. (Transamerica) serves as the Plan's insurance company.

***Contributions***

Company profit sharing contributions are discretionary as determined by the Company. Contributions are subject to certain limitations. In order to receive a contribution, the employee is required to be employed by the Company on the last day of the plan year. Employee rollover contributions are also permitted.

***Participant Investment Account Options***

Each participant has the option of directing the Company's contributions into any of the various investment options offered by the Plan and may change the allocation daily. If no election is made, the contributions are invested in age-based funds based on employee's age.

***Participant Accounts***

Each participant's account is credited with the Company's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earning or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are vested in their profit sharing contribution based on years of continuous service at 20% per year beginning at the end of year two and fully vested at the end of year six. In addition, a participant becomes 100% vested in the Company's contributions in the event of a participant's death, disability, or attainment of normal retirement age of 59-1/2.

***Notes Receivable from Participants***

Participants are not permitted to borrow from their fund accounts.

***Payment of Benefits***

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

***Forfeited Accounts***

If a participant terminated service prior to being fully vested in their account under the Plan, they will forfeit the amount in which they are not vested. Forfeitures of the Plan may be used to reduce any employer profit sharing contributions or pay for plan expenses. For the years ended December 31, 2024 and 2023, forfeitures and earnings on forfeitures totaled \$9,672 and \$9,863, respectively. Also, during the years ended December 31, 2024 and 2023, \$14,729 and \$6,666, respectively, were used to reduce employer profit sharing contributions or pay for plan expenses.

As of December 31, 2024 and 2023 amounts in the forfeiture account totaled \$762 and \$5,819, respectively. Forfeitures are invested in the Transamerica Stable Value Core Account.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results may differ from those estimates.

***Investment Valuation Income Recognition***

Investments are reported at fair value except for fully benefit-responsive insurance contracts, which are reported at contract value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Pooled separate accounts are valued at the NAV of shares held by the Plan as provided by Transamerica.

Fully benefit-responsive insurance contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

***Subsequent Events***

Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.

**Note 3. Certification of Plan Insurance Company**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Transamerica, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate to the best of its knowledge and belief:

- Investments as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information, included in the accompanying schedule of assets (held at year-end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan incurs expenses related to general administration and record keeping. The Company pays these expenses and certain accounting and auditing fees relating to the Plan and provides administrative services at no cost to the Plan.

Individually nonmaterial expenses paid to parties in interest aggregated \$3,950 and \$7,098 during 2024 and 2023, respectively.

(A) In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. This category of investments primarily consists of pooled separate accounts that seek investment returns consistent with the underlying mutual funds. There are no unfunded commitments or redemption restrictions.

There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**Note 6. Insurance Contract with Insurance Company**

The Plan entered into a fully benefit-responsive traditional insurance contract with Transamerica. Transamerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed insurance contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed insurance contract is fully benefit-responsive; thus, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed insurance contract. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants can ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

**Note 7. Plan Termination**

Although they have expressed no intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

**Note 8. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust document sponsored by CCH Incorporated d/b/a ftwilliam.com. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
