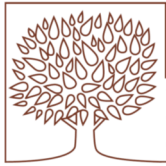

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Heritage Village Master Association, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Heritage Village Master Association, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

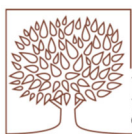

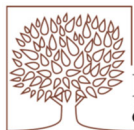

Note 1: DESCRIPTION OF PLAN

The following description of the Heritage Village Master Association, Inc. 401(k) Plan (the "Plan") is provided for general information purposes. Participants should refer to the Plan document for more complete information.

General — The Plan is a defined contribution plan covering all full-time and part-time employees of Heritage Village Master Association, Inc. (the "Association") who are citizens of the United States of America. Employees are eligible to become participants and begin making pretax contributions after completing one hour of service. All eligible employees hired after January 1, 2021 who have not made a deferral election will be deemed to have made an elective deferral contribution election in the amount of 2%.

All maintenance employees, including full-time, part-time and seasonal maintenance employees, are represented by the International Brotherhood of Teamsters, Chauffeurs, Warehousemen and Helpers of America, Local 677 (the "Union"), and are subject to the terms of a collective bargaining agreement between Heritage Village Master Association, Inc. and the Union. Based on their job classification under the collective bargaining agreement, these employees are excluded from participation in the Plan unless the collective bargaining agreement provides for participation in the Plan.

Charles Schwab Bank, serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions — Contributions for the Plan are as follows:

Pretax contributions - Participants can elect to make pretax contributions not to exceed Internal Revenue Code ("IRC") limitations, as defined in the Plan document. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch up contributions.

Roth contributions - Participants can elect to make roth contributions not to exceed Internal Revenue Code ("IRC") limitations, as defined in the Plan document.

Employer match contributions - The Association provides matching contributions to participants in an amount equal to 100% of the first 4% of eligible employee contributions. Company match contributions are offered to all eligible employees who are age 21 and over and have completed one year of service.

Non elective safe harbor contribution - The Association provides a non elective contribution to each eligible participant an amount equal to 3% of each participant's compensation. Eligible employees receive safe harbor contributions after reaching age 21 and completing one year of service.

Participant Accounts — Each participant's account is credited with the participant's contribution and allocations of the Association's contribution and plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

Note 1: DESCRIPTION OF PLAN (continued)

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds and a collective trust as investment options for participants.

Administrative charges related to participant loans and distributions are deducted directly from the respective participant's account. Investment expenses charged by the investments in which the Plan invests are paid directly from the underlying assets of the respective investment and are included in the net appreciation in fair market value of each type of investment in the statements of changes in net assets available for benefits. All other charges related to the administration of the Plan are paid by the Association.

Vesting — Participants are vested immediately in their contributions and non elective safe harbor contributions plus actual earnings thereon. Vesting in any employer match contribution is based on years of continuous service, as defined in the Plan, according to the following schedule:

Notes Receivable from Participants — Participants may borrow from their fund accounts up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear interest at rates that range from 4.25% to 9.50% as of December 31, 2024, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits — Upon termination of service due to health, disability or retirement, the participants' benefits may be paid either as a lump sum distribution or in installments over a period not to exceed the participants' expected future lifetime. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts — Forfeitures of employer matching and profit-sharing contributions are used to offset administrative expenses or to reduce future employer matching or non-elective contributions. For the years ended December 31, 2024 and 2023, forfeitures totaled \$10,235 and \$2,995, respectively. At December 31, 2024 and 2023, there was a forfeitures balance of \$9,083 and \$466, respectively that had not yet been applied.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting — The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Use of Estimates — The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make certain estimates and assumptions that affect the reported amount of net assets available for benefits and contingent assets and liabilities at the date of the financial statements, and the stated amount of additions and deductions during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition — Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation in fair value for each type of investment held by the Plan, which includes gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants — Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2024 and 2023.

Risk and Uncertainties — The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Excess Contributions Payable — The Plan is required to return contributions received during the Plan year in excess of IRC limits. As of December 31, 2024 and 2023, there were no excess contributions payable on the accompanying statements of net assets available for benefits. Excess contributions payable are reported as a reduction to employee contributions.

Benefit Payments — Benefit payments to participants are recorded upon distribution. There are no amounts allocated to accounts of persons who have elected to withdraw from the Plan but had not yet been paid as of December 31, 2024 and 2023.

NOTES TO FINANCIAL STATEMENTSDECEMBER 31, 2024Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Expenses — Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Association. Expenses that are paid by the Association are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment management expenses are paid directly by the Plan and are also included in administrative expenses, while other investment related expenses are included in the net appreciation in fair value of investments.

Subsequent Events — The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

Note 3: FAIR VALUE MEASUREMENTS

The Plan values its assets and liabilities based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value into three broad levels as follows:

Level 1 — Quoted prices in active markets that are accessible at the measurement date for identical assets or liabilities. The fair value hierarchy gives the highest priority to Level 1 inputs.

Level 2 — Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in inactive markets or model-derived valuations in which all significant inputs are observable or can be derived principally from or corroborated with observable market data.

Level 3 — Unobservable inputs are used when little or no market data is available. The fair value hierarchy gives the lowest priority to Level 3 inputs.

In determining fair value, the Plan utilizes valuation techniques that maximize the use of quoted and observable inputs and minimize the use of unobservable inputs to the extent possible as well as considers counterparty credit risk in its assessment of fair value.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds — Valued at the net asset value (NAV) of shares held by the Plan at year end using market prices on active markets (Level 1). Level 1 instrument valuations are obtained from real-time quotes for transactions in active exchange markets involving identical assets.

Collective Investment Trust — Valued at the net asset value (NAV), as calculated by the fund. The NAV is computed by dividing the total assets of the fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the fund and included in the determination of unit value.

Note 3: FAIR VALUE MEASUREMENTS (continued)

The collective investment trust consists of investment in the MetLife Group Annuity Contract No. 25053, Class 65, which is a guaranteed investment contract. The guaranteed investment contract is fully benefit - responsive and valued at fair value. The fair value of the contract is determined by MetLife based on quoted market prices of the underlying investments owned by MetLife. The contract's issuer guarantees that all qualified participant withdrawals will be at contract value. If a participating plan terminates participation in the Trust, the lesser of the guaranteed value or the fair value will be received. The contract simulates the performance of a guaranteed investment contract through the guarantee of a specific interest rate and a portfolio of financial instruments that are owned by MetLife. The fixed interest rate is reset every quarter as determined by MetLife.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)

The Plan management has elected the method of compliance permitted by 29 CFS 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule Form 5500, Schedule H, Part IV, Line 4i—Schedule of Assets (Held at End of Year) as of December 31, 2024; the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

Note 5: RELATED PARTY TRANSACTIONS

The Association has retained the services of a third-party administrator to perform certain other administrative functions. Administrative expenses of \$70,454 and \$59,223 have been charged by the third-party administrator and investment advisors for 2024 and 2023, respectively. All administrative expenses are paid by the Plan.

The Plan's investments managed by the trustee are considered exempt party-in-interest transactions. The Plan allows participants to take loans against their account balance which are also considered exempt party-in-interest transactions.

Note 6: PLAN TERMINATION

Although it has not expressed any intent to do so, the Association has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their entire account.

Note 7: FEDERAL INCOME TAX STATUS

The Association adopted a prototype plan which received an Internal Revenue Service opinion letter dated June 30, 2020. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.
