Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Times Publishing Company Profit-Sharing & Tax-Deferred Savings Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. (1) Description of the Plan

(a) General

Effective October 1, 1995, Times Publishing Company and its subsidiaries, Congressional Quarterly, Inc. and Trend Magazines, Inc. (collectively, the “Company”), merged the Times Publishing Company Profit-Sharing Plan into the Times Tax-Deferred Savings Plan. This merged plan, as amended and restated, is known as the Times Publishing Company Profit-Sharing and Tax-Deferred Savings Plan (the “Plan”). The Plan is a defined contribution plan that provides benefits for and allows its members to defer a portion of their compensation until retirement, disability, termination or death, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Information about the Plan is contained in the pamphlet, *Times Publishing Company Profit-Sharing & Tax-Deferred Savings Plan*, available from the Company’s Human Resources department.

(b) Eligibility

Employees of the Company (excluding collectively bargained and carrier employees) are eligible to become a participant in the Plan as of the first day following their date of employment. To be eligible for employer contributions the participant must have completed one year of service with the Company. A year of service is defined as working 1,000 hours for the Company during the 12-month period immediately following the employee’s date of hire.

Upon meeting eligibility requirements above, participants are automatically enrolled in the Plan at a default rate of 2% of eligible compensation unless the participant opts out of the Plan.

(c) Contributions

Each year, participants may elect to contribute up to 75% of their annual compensation as pre-tax or Roth contributions, as defined by the Plan, not to exceed \$23,000 in 2024. As allowed by the Internal Revenue Service, the limit on catch-up elective deferrals for participants age 50 and over was an additional \$7,500 for the 2024 plan year.

The Company’s profit-sharing contribution to the Plan, which is at the discretion of the Board of Directors of the Company, is based on a participant’s salary as a percentage of all participants’ eligible compensation, as defined in the plan document. The Company elected not to make a profit-sharing contribution for the year ended December 31, 2024.

(c) Contributions - Continued

The Company's employer contribution, which is at the discretion of the Board of Directors of the Company, is based on a discretionary percentage of the participant's compensation, as defined in the plan document. The Company elected not to make a Company tax-deferred savings contribution for the year ended December 31, 2024.

(d) Participant Accounts

Each participant's account is credited with the participant's contribution, an allocation of the Company's contributions (profit-sharing and tax-deferred savings) and plan earnings based on their investment mix selection.

(e) Participant Investment Account Options

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers a common/collective trust and several registered investment companies as investment options for participants.

(f) Vesting

Participants' contributions plus actual earnings are 100% vested immediately. Participants in the Plan as of December 31, 2004 are fully vested at all times in all Company contributions. New participants subsequent to December 31, 2004 vest in their Company contributions as follows:

During 2009, substantially all assets of Congressional Quarterly, Inc. ("CQ") were sold. In conjunction with this action, the Plan was formally amended to fully vest all CQ employees in their plan account balances.

(g) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum of \$50,000 or 50% of their account balance. Participants may have no more than two plan loans outstanding, and loan terms range from one to five years or up to ten years for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at the prevailing prime rate at the beginning of the month in which the loan is made. Interest rates for participant loans outstanding at December 31, 2024 range from 3.25% to 8.50%. Principal and interest are paid through payroll deductions.

(h) Forfeitures

Forfeitures related to the Plan are first used to pay plan expenses and then may be used to reduce the Company's contributions or be reallocated to participants. As of December 31, 2024 and 2023, the balance in the forfeiture account was approximately \$50,000 and \$103,000, respectively. Approximately \$20,000 of forfeitures were used during the year ended December 31, 2024 to pay plan expenses and \$771,000 of forfeitures were reallocated to participant accounts.

(i) Payment of Benefits

A participant is eligible to receive payment of benefits at termination of employment, disability, or retirement (age 65). Upon death of a participant, the designated beneficiary is eligible to receive distributions of the participant's interest under the Plan. Before age 65, the participant or beneficiary may receive payment in an amount equal to the value of the participant's vested interest of Company contributions and 100% of the participant's contributions (see Note 1(f)). On or after age 65, a participant shall be entitled to 100% of the participant's contributions and Company contributions as a single lump sum payment subject to withholding for income taxes, rollover to a qualified plan, or receive installment payments. The Plan permits hardship withdrawals of the participant's elective withdrawals during service upon meeting certain plan provisions.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements of the Plan have been prepared under the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

(c) Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Shares of registered investment companies are valued at quoted market prices which represent the net asset value ("NAV") of the shares held by the Plan at year end. Units of the common collective trust are valued at NAV at year end.

The Vanguard Retirement Savings Trust (the "Fund") is a common/collective trust stable value fund. The Fund invests principally in guaranteed interest contracts ("GICs") issued by insurance companies, investment contracts issued by banks, synthetic investment contracts ("SICs") issued by banks, insurance companies and other issuers, and securities supporting such SICs, and other similar instruments which are intended to maintain a constant NAV. The Fund is valued by Vanguard Fiduciary Trust Company ("Vanguard"), also the trustee, based on the unit value of the funds. Unit values are determined by dividing the Fund's net assets, which represents the fair value of the underlying investments, by its units outstanding at the valuation dates. This common/collective trust has underlying investments in investment contracts which are valued at estimated fair value and then adjusted to contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value, which may occur on a daily basis.

Certain events could limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) total or partial plan termination of the Trust; (2) tax disqualification of the Trust or unitholder; (3) certain Trust amendments if issuers' consent is not obtained. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants. The Fund had no unfunded commitments or redemption notices.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes plan gains and losses on investments bought and sold, as well as held during the year.

(d) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

(e) Risks and Uncertainties

The Plan provides for various investment options in any combination of investment securities based upon participant requests. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(f) Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

(g) Payment of benefits

Benefits are recorded when paid.

(h) Administrative Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of change in net assets available for benefits. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

(3) Information Prepared and Certified by Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Total investments and notes receivable from participants, as shown in the statements of net assets available for benefits, as of December 31, 2024 and 2023;
- Net investment income and related investment activity for the year ended December 31, 2024, as shown in the statement of changes in net assets available for benefits;
- The Schedule of Assets (Held at End of Year) as of December 31, 2024 as shown in the supplemental schedule.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(4) Determination of Tax Qualification

The Plan obtained its latest determination letter on June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan is qualified, and the related trust is exempt from income taxes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(5) Party-in-Interest Transactions

The Plan invests in shares of registered investment companies and a common/collective trust managed by an affiliate of Vanguard. Vanguard acts as trustee for only those investments as defined by the Plan. The Plan made direct payments to Vanguard of approximately \$76,000 during the year ended December 31, 2024 for these services. Transactions in such investments qualify as party-in-interest transactions, as defined in Section 3(14) of ERISA, but are expressly exempted from prohibited transactions rules.

(6) Fair Value Measurements

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- (a) Quoted prices for similar assets or liabilities in active markets;
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- (c) Inputs other than quoted prices that are observable for the asset or liability;
- (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

(6) Fair Value Measurements - Continued

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Registered Investment Companies are valued at quoted market prices in an exchange and active markets, which represent the NAV of shares held by the Plan at year end and are classified as Level 1 investments.
