## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

## Supplemental Schedule Required by ERISA

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**1. Description of Plan**

The following description of New England Controls 401k Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a participant directed defined contribution 401(k) plan covering substantially all employees of Stellix Group, Inc. and Subsidiaries (the Plan Administrator), who have attained the age of 21. Employees are eligible to participate in the Plan as of their start date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is maintained by an administrator and a trustee. The administrator maintains participant account records and instructs the trustee to execute transactions such as benefit payments to participants. The trustee reports to the Plan's management regarding investments and changes in those investments. The trustee of the Plan is Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal).

***Contributions***

Participants may elect to contribute an amount or percentage up to 90% of their eligible compensation, on a pre-tax or after-tax basis, not to exceed annual limitations as permitted by the Internal Revenue Code (IRC). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (participant rollovers).

The Plan Administrator may contribute a discretionary contribution or a non-elective contribution equal to a percentage of each eligible participant's compensation. To be eligible to receive a discretionary Plan Administrator contribution, an employee must have been employed on the last day of the Plan year, unless not employed due to disability, death, or retirement. During 2024, the Plan Administrator did not elect to make a discretionary contribution.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Plan Administrator's contribution, if any, and their allocation of Plan earnings and losses and any expenses incurred. Allocations are based on participant compensation or individual participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions and Plan Administrator non-elective contributions plus the allocation of Plan earnings on those contributions, at the time of allocation.

Participants become vested in the Plan Administrator discretionary contribution and the allocation of Plan earnings on those contributions as follows: 20% after 2 years, 40% after 3 years, 60% after 4 years, 80% after 5 years, and 100% after 6 years.

***Participant Notes Receivable***

Participants may borrow from their account a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of the vested value of their account balance. A participant can only have three notes outstanding at a time. Note terms range from 1 to 5 years or up to 30 years for the purchase of a primary residence. The notes are secured by the participant's vested balance and bear interest at a rate of prime plus one percent. Principal and interest is paid ratably through payroll deductions.

***Payment of Benefits***

Benefits are available for distribution upon retirement, death or disability in a single lump-sum distribution or an annuity option. In the event of termination for any reason other than retirement, death or disability, payment of vested benefits will be made by the Plan Administrator in accordance with the procedures described in the Plan. Participants who have attained age 59½ may elect to withdraw all or a portion of their vested account while still employed. If a participant's vested balance is less than \$1,000, the participant will receive an immediate cash-out of their vested account balance. If a participant's vested balance exceeds \$1,000 but is less than \$5,000, the amount will be rolled over to an individual retirement plan designated by the Plan Administrator.

Hardship withdrawals from the Plan are also permitted subject to the applicable Internal Revenue Service (IRS) laws.

During 2023, the Plan adopted certain provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE) Act 2.0, which increased the age of the required distributions to begin from 72 to 73 (or, if later, termination of employment).

***Forfeitures***

Participants in the Plan who leave the employment of the Plan Administrator before completing six years of service forfeit the non-vested portion of the Plan Administrator discretionary contributions to their accounts. Forfeitures may be used to reduce future Plan Administrator contributions or to pay administrative expenses. There were no forfeited non-vested accounts available to be used at December 31, 2024 and 2023.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Valuation of Investments and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Participant Notes Receivable***

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the respective participant's account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms. Delinquent participant notes receivable from participants are reclassified as distributions based on terms of the Plan document.

***Contributions***

Participant contributions are recorded biweekly when the Plan Administrator remits the payroll deductions for investment into the Plan. Discretionary Plan Administrator contributions and non-elective contributions are made at year end, if applicable.

***Payment of Benefits***

Benefits are recognized when paid to participants or their designated beneficiaries.

***Administrative Expenses***

Certain administrative expenses of the Plan are paid by the Plan Administrator, unless the Plan Administrator directs that the expenses be paid by the Plan. Expenses that are paid by the Plan Administrator are excluded from these financial statements. Participant notes receivable set up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

***Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan invested in two mutual funds that accounted for approximately 27% of total Plan investments as of December 31, 2024. The Plan invested in a mutual fund that accounted for approximately 15% of total Plan investments as of December 31, 2023.

***Financial Instruments with a Concentration of Credit Risk***

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside entity's non-performance of its fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

***Subsequent Events***

The Plan Administrator has evaluated subsequent events through October 9, 2025, which is the date these financial statements were available to be issued.

**3. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

As of December 31, 2024 and 2023, the Plan's investments in mutual funds are reported at level 1 within the fair value hierarchy.

**4. Plan Termination**

The Plan Administrator expects to continue the Plan indefinitely. However, the Plan Administrator reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. In the event of Plan termination, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

**5. Income Tax Status**

The Plan is an adoption of a prototype plan that was designed and sponsored by the Principal Life Insurance Company. The Principal Life Insurance Company has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the IRC; and therefore, the related trust is tax exempt.

Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Summary of Financial Data Certified by the Trustee**

The following is a summary of financial information and data certified by the trustee, Principal:

Statements of Net Assets Available for Plan Benefits at December 31, 2024 and 2023, except for contributions receivable, if any;

Investment income and interest income from participant notes receivable on the Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024; and

Investment information provided in the supplementary schedule, Schedule of Assets (Held at End of Year) at December 31, 2024.

**7. Differences from Form 5500**

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

**8. Related Party Transactions and Party-in-Interest Transactions**

Plan investments are held and managed by Principal, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to Principal for administrative services totaling \$101,228 for the year ended December 31, 2024. In addition, participant notes receivable qualify as party-in-interest transactions.
