The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter—Supplemental Schedule Required by ERISA**

#### Note 1. Plan Description

The following brief description of Rauland-Borg Corporation Profit Sharing and Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering certain employees of Biamp Systems Corporation, Lomar Corporation, Responder Systems Corporation, Rauland-Borg Corporation and Rauland-Borg Corporation of Florida (collectively, the Company).

The Plan was amended on September 1, 2017 and effective January 1, 2018. The amendment excluded previously participating employers, Responder Systems Corporation, Rauland-Borg Corporation of Florida, Lomar Corporation and non-Illinois Union employees of Rauland-Borg Corporation. Employees of these companies were allowed to keep their balances in the Plan. The participants' balances in the Plan assets for the previously participating employers became 100% vested upon amendment date.

**Eligibility:** Employees who are subject to a collective bargaining agreement and who have completed one month of service are eligible to participate in the Plan. The entrance dates to the Plan are the first of each month following meeting eligibility requirements. Eligible employees are automatically enrolled in the Plan at 3% of their total compensation unless they elect not to enroll or elect to defer a different amount. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Participants may contribute up to 88% of pretax annual compensation through payroll deductions not to exceed regulatory limits according to the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions, as defined. Unless an eligible employee affirmatively elects otherwise after receiving appropriate notice, deferral contributions for each new active participant having automatic enrollment contributions made on his or her behalf shall be increased annually by 1% until the deferral percentage reaches 10%.

For each plan year, the Company may contribute discretionary profit sharing contributions to the Plan. Participants must have worked at least 501 hours of service in the plan year and be employed on December 31 to share in the allocation of the profit sharing contribution. The Company did not make a profit sharing contribution to the Plan for the year ended December 31, 2024. Additional Company matching and discretionary nonelective contributions may be contributed at the option of the Company's Board of Directors. In 2024, the Company made discretionary matching and discretionary nonelective contributions. The Company matched 100% of participant deferrals up to 2% of compensation. The Company made nonelective contributions of 1% of compensation during the plan year. The Company did not make a nonelective fixed contribution during the plan year. Contributions are subject to limitations.

**Participant accounts:** Each participant's account is credited with the participant's contribution and allocations of the Company's contributions, if any, Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions as defined. Earnings include interest, dividends and changes in the fair value of investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service, with 20% vesting credited to the participant per year of service, as defined, commencing in the second year of employment.

#### Note 1. Plan Description (Continued)

**Investment options:** Upon enrollment in the Plan, a participant may direct their account balance in a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

**Payment of benefits:** On termination of service, a participant may elect to receive either (a) a lump-sum amount equal to the vested value of his or her account or (b) a deferred payment to begin no later than April 1 of the year following the date that the participant attains the age of 70½. Vested benefits in amounts less than \$5,000 are distributed in a lump-sum amount. Participants may make in-service withdrawals in cases of financial hardship only and may not withdraw an amount greater than the amount that the participant has contributed to their account.

**Forfeitures:** At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$15,900 and \$174,200, respectively. These accounts will be used to reduce Plan expenses or future Company contributions. During 2024, \$162,713 was used to reduce the Company's contributions and \$133 was used to reduce the Plan's administrative expenses.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Accounting estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Administrative expenses:** The Plan's administrative expenses are paid by either the Plan or the Company as provided by the Plan's provisions. Expenses that are paid by the Company are excluded from these financial statements.

**Payment of benefits:** Benefits are recorded when paid.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets and income:

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the framework are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

**Level 2:** Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly such as:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### Note 4. Fair Value Measurements (Continued)

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Shares of registered investment companies:** Shares of registered investment companies are valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Changes in fair value levels:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

#### Note 5. Related-Party Transactions

Certain Plan investments are managed by Fidelity Management Trust Company, the trustee, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the trustee were \$29,783 for the year ended December 31, 2024.

Certain employees of the Company are performing services for the Plan and are not compensated by the Plan. Certain other expenses of the Plan are paid by the Company.

The Plan also has a revenue sharing agreement with the trustee. The Plan's record-keeping fees are covered by revenue sharing arrangements with investment management companies for those funds available in the Plan. For the year ended December 31, 2024, the amount earned and paid was \$36,600 and reported as other income in the statement of changes in net assets available for benefits.

#### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### Note 8. Income Tax Status

Effective June 30, 2020, the Plan has adopted a volume submitter form of a plan sponsored by Fidelity Management & Research Co. The volume submitter plan has received an opinion letter from the Internal Revenue Service as to the volume submitter plan's qualified status. The Plan has been amended since receiving the opinion letter. The volume submitter plan opinion letter has been relied upon by this Plan.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
