**INDEPENDENT AUDITOR'S REPORT**

To the Trustees of  
Wolfram Research, Inc. 401(k) Plan:

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Wolfram Research, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Wolfram Research, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan provisions.

General

The Plan is a contributory defined contribution plan covering substantially all employees of Wolfram Research, Inc. and Wolfram Alpha LLC (collectively, the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may elect to contribute between 1% and 60% of their annual compensation to either a Traditional 401(k) or a Roth 401(k), which is remitted to the Plan by the Plan Sponsor. The maximum dollar amount that participants can contribute to the Plan each year is \$23,000 (for 2024), with an additional \$7,500 catch-up contribution for those participants who have attained age 50 before the end of the plan year, and includes contributions made to other deferral plans (e.g., other 401(k) plans, salary deferral SEP plans, 403(b) tax-sheltered annuity plans, etc.). The amount will increase as the cost of living increases. The Company may further limit the amount that a participant can contribute to the Plan to help the Plan satisfy certain nondiscrimination requirements. The Company will notify participants if they are a Highly Compensated Employee, subject to any additional limits. Participants are not permitted to make additional voluntary contributions to the Plan from after-tax compensation. The Company makes discretionary contributions each plan year, as allowed by the Plan. These discretionary contributions allow the Company to match 50% of participant contributions up to 6% of the participant's compensation, allowing a maximum of 3% of the participant's compensation to be matched by the Company.

Administration

The Vanguard Fiduciary Trust Company (Vanguard) is the trustee and custodian of the Plan. As trustee, Vanguard maintains the Plan's records, receives contributions, manages investments, and initiates distributions of benefits to eligible employees pursuant to the provisions of the Plan.

Participant Accounts

Employees, who are age 18 or older are eligible to participate in the Plan. After age requirements are met, employees may enter the plan on the first day of the next month. Generally, leased employees, interns, and nonresident aliens who received no earned income from within the United States are not eligible to participate in the Plan. Each participant's account is credited with the participant's contributions and Company matching contributions, as well as plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested with respect to both their own contributions (and investment earnings thereon) and to employer's discretionary contributions (and investment earnings thereon) immediately upon participation.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Principal and interest is paid ratably through bi-weekly payroll deductions. Loans must be repaid, including interest at prime rate plus 1%, over a period not to exceed five years. However, if the purpose of the loan is to acquire a principal residence dwelling unit for the participant within a reasonable time of the loan, the loan may be repaid over 30 years. Interest rates applicable to all outstanding loans ranged from 4.25% to 9.5% at December 31, 2024.

Payment of Benefits

At age 55, participants are entitled to their vested account balance. Upon termination of employment, participants may elect to receive 1) a lump sum amount equal to the value of the participant's vested interest in his or her account; or 2) annual or more frequent periodic installment payments of substantially equal amounts over a period of time as defined in the Plan. For balances under \$1,000 at the time of termination, payment is made in a lump sum distribution. Hardship withdrawals are permitted.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, and custodians. See Note 3 for discussion of fair value measurements.

Investments Valuation and Income Recognition (Continued)

The Vanguard Retirement Savings Trust VIII (comprising the Stable Value Fund) is a tax-exempt collective trust that invests in fully benefit-responsive investments contracts issued by insurance companies and commercial banks, and similar types of fixed principal investments. The fund is recorded at fair value. See Note 3 for additional fair value information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction to the contributions. There were no excess contributions payable as of December 31, 2024 and 2023.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments. Additionally, \$31,098 of service fees were paid to Vanguard directly by the Plan in 2024.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trusts:* Valued based on the year-end market value of each unit held, using NAV, which is derived from the market value of the underlying net assets. This includes the Stable Value Fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Stable Value Common Collective Trust includes a common collective trust fund that is designed to deliver safety and stability by preserving principal and accumulating earnings. This fund is primarily invested in guaranteed investment contracts and synthetic investment contracts. Participant-directed redemptions have no restrictions; however, the Plan is required to provide a one-year redemption notice to liquidate its entire share in the fund.

Certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been categorized in the fair value hierarchy. The fair value amounts presented in the table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statement of financial position.

NOTE 4. PLAN TERMINATION

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to ERISA requirements. If the Plan is terminated, benefits will be distributed in accordance with the provisions of the Plan.

NOTE 5. TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan invests in shares of mutual funds and a common/collective trust managed by an affiliate of Vanguard. Vanguard acts as trustee for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. In addition, loans to participants also qualify as party-in-interest transactions. Participant loans as of December 31, 2024 and 2023 totaled \$415,553 and \$323,677, respectively.

NOTE 6. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation/depreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, were obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (the trustee of the Plan).

NOTE 7. TAX STATUS

The Plan has adopted The Vanguard Group Non-Standardized Pre-Approved Profit Sharing Plan with CODA, which is a non-standardized proto-type plan. The Plan has received a favorable determination letter from the IRS dated June 30, 2020, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan provides for various investment options in any combination of shares of registered investment companies or a common collective trust that invest in stocks, bonds, fixed income securities and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**INDEPENDENT AUDITOR'S REPORT**

To the Trustees of  
Wolfram Research, Inc. 401(k) Plan:

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Wolfram Research, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

***Opinion***

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Wolfram Research, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan provisions.

General

The Plan is a contributory defined contribution plan covering substantially all employees of Wolfram Research, Inc. and Wolfram Alpha LLC (collectively, the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may elect to contribute between 1% and 60% of their annual compensation to either a Traditional 401(k) or a Roth 401(k), which is remitted to the Plan by the Plan Sponsor. The maximum dollar amount that participants can contribute to the Plan each year is \$23,000 (for 2024), with an additional \$7,500 catch-up contribution for those participants who have attained age 50 before the end of the plan year, and includes contributions made to other deferral plans (e.g., other 401(k) plans, salary deferral SEP plans, 403(b) tax-sheltered annuity plans, etc.). The amount will increase as the cost of living increases. The Company may further limit the amount that a participant can contribute to the Plan to help the Plan satisfy certain nondiscrimination requirements. The Company will notify participants if they are a Highly Compensated Employee, subject to any additional limits. Participants are not permitted to make additional voluntary contributions to the Plan from after-tax compensation. The Company makes discretionary contributions each plan year, as allowed by the Plan. These discretionary contributions allow the Company to match 50% of participant contributions up to 6% of the participant's compensation, allowing a maximum of 3% of the participant's compensation to be matched by the Company.

Administration

The Vanguard Fiduciary Trust Company (Vanguard) is the trustee and custodian of the Plan. As trustee, Vanguard maintains the Plan's records, receives contributions, manages investments, and initiates distributions of benefits to eligible employees pursuant to the provisions of the Plan.

Participant Accounts

Employees, who are age 18 or older are eligible to participate in the Plan. After age requirements are met, employees may enter the plan on the first day of the next month. Generally, leased employees, interns, and nonresident aliens who received no earned income from within the United States are not eligible to participate in the Plan. Each participant's account is credited with the participant's contributions and Company matching contributions, as well as plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested with respect to both their own contributions (and investment earnings thereon) and to employer's discretionary contributions (and investment earnings thereon) immediately upon participation.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Principal and interest is paid ratably through bi-weekly payroll deductions. Loans must be repaid, including interest at prime rate plus 1%, over a period not to exceed five years. However, if the purpose of the loan is to acquire a principal residence dwelling unit for the participant within a reasonable time of the loan, the loan may be repaid over 30 years. Interest rates applicable to all outstanding loans ranged from 4.25% to 9.5% at December 31, 2024.

Payment of Benefits

At age 55, participants are entitled to their vested account balance. Upon termination of employment, participants may elect to receive 1) a lump sum amount equal to the value of the participant's vested interest in his or her account; or 2) annual or more frequent periodic installment payments of substantially equal amounts over a period of time as defined in the Plan. For balances under \$1,000 at the time of termination, payment is made in a lump sum distribution. Hardship withdrawals are permitted.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, and custodians. See Note 3 for discussion of fair value measurements.

Investments Valuation and Income Recognition (Continued)

The Vanguard Retirement Savings Trust VIII (comprising the Stable Value Fund) is a tax-exempt collective trust that invests in fully benefit-responsive investments contracts issued by insurance companies and commercial banks, and similar types of fixed principal investments. The fund is recorded at fair value. See Note 3 for additional fair value information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction to the contributions. There were no excess contributions payable as of December 31, 2024 and 2023.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments. Additionally, \$31,098 of service fees were paid to Vanguard directly by the Plan in 2024.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1        Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2        Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3        Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trusts:* Valued based on the year-end market value of each unit held, using NAV, which is derived from the market value of the underlying net assets. This includes the Stable Value Fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Stable Value Common Collective Trust includes a common collective trust fund that is designed to deliver safety and stability by preserving principal and accumulating earnings. This fund is primarily invested in guaranteed investment contracts and synthetic investment contracts. Participant-directed redemptions have no restrictions; however, the Plan is required to provide a one-year redemption notice to liquidate its entire share in the fund.

Certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been categorized in the fair value hierarchy. The fair value amounts presented in the table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statement of financial position.

NOTE 4. PLAN TERMINATION

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to ERISA requirements. If the Plan is terminated, benefits will be distributed in accordance with the provisions of the Plan.

NOTE 5. TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan invests in shares of mutual funds and a common/collective trust managed by an affiliate of Vanguard. Vanguard acts as trustee for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. In addition, loans to participants also qualify as party-in-interest transactions. Participant loans as of December 31, 2024 and 2023 totaled \$415,553 and \$323,677, respectively.

NOTE 6. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation/depreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, were obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (the trustee of the Plan).

NOTE 7. TAX STATUS

The Plan has adopted The Vanguard Group Non-Standardized Pre-Approved Profit Sharing Plan with CODA, which is a non-standardized proto-type plan. The Plan has received a favorable determination letter from the IRS dated June 30, 2020, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan provides for various investment options in any combination of shares of registered investment companies or a common collective trust that invest in stocks, bonds, fixed income securities and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## INDEPENDENT AUDITOR'S REPORT

To the Trustees of  
Wolfram Research, Inc. 401(k) Plan:

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Wolfram Research, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

***Opinion***

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Wolfram Research, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan provisions.

General

The Plan is a contributory defined contribution plan covering substantially all employees of Wolfram Research, Inc. and Wolfram Alpha LLC (collectively, the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may elect to contribute between 1% and 60% of their annual compensation to either a Traditional 401(k) or a Roth 401(k), which is remitted to the Plan by the Plan Sponsor. The maximum dollar amount that participants can contribute to the Plan each year is \$23,000 (for 2024), with an additional \$7,500 catch-up contribution for those participants who have attained age 50 before the end of the plan year, and includes contributions made to other deferral plans (e.g., other 401(k) plans, salary deferral SEP plans, 403(b) tax-sheltered annuity plans, etc.). The amount will increase as the cost of living increases. The Company may further limit the amount that a participant can contribute to the Plan to help the Plan satisfy certain nondiscrimination requirements. The Company will notify participants if they are a Highly Compensated Employee, subject to any additional limits. Participants are not permitted to make additional voluntary contributions to the Plan from after-tax compensation. The Company makes discretionary contributions each plan year, as allowed by the Plan. These discretionary contributions allow the Company to match 50% of participant contributions up to 6% of the participant's compensation, allowing a maximum of 3% of the participant's compensation to be matched by the Company.

Administration

The Vanguard Fiduciary Trust Company (Vanguard) is the trustee and custodian of the Plan. As trustee, Vanguard maintains the Plan's records, receives contributions, manages investments, and initiates distributions of benefits to eligible employees pursuant to the provisions of the Plan.

Participant Accounts

Employees, who are age 18 or older are eligible to participate in the Plan. After age requirements are met, employees may enter the plan on the first day of the next month. Generally, leased employees, interns, and nonresident aliens who received no earned income from within the United States are not eligible to participate in the Plan. Each participant's account is credited with the participant's contributions and Company matching contributions, as well as plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1. DESCRIPTION OF THE PLAN (Continued)

Vesting

Participants are fully vested with respect to both their own contributions (and investment earnings thereon) and to employer's discretionary contributions (and investment earnings thereon) immediately upon participation.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Principal and interest is paid ratably through bi-weekly payroll deductions. Loans must be repaid, including interest at prime rate plus 1%, over a period not to exceed five years. However, if the purpose of the loan is to acquire a principal residence dwelling unit for the participant within a reasonable time of the loan, the loan may be repaid over 30 years. Interest rates applicable to all outstanding loans ranged from 4.25% to 9.5% at December 31, 2024.

Payment of Benefits

At age 55, participants are entitled to their vested account balance. Upon termination of employment, participants may elect to receive 1) a lump sum amount equal to the value of the participant's vested interest in his or her account; or 2) annual or more frequent periodic installment payments of substantially equal amounts over a period of time as defined in the Plan. For balances under \$1,000 at the time of termination, payment is made in a lump sum distribution. Hardship withdrawals are permitted.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, and custodians. See Note 3 for discussion of fair value measurements.

Investments Valuation and Income Recognition (Continued)

The Vanguard Retirement Savings Trust VIII (comprising the Stable Value Fund) is a tax-exempt collective trust that invests in fully benefit-responsive investments contracts issued by insurance companies and commercial banks, and similar types of fixed principal investments. The fund is recorded at fair value. See Note 3 for additional fair value information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction to the contributions. There were no excess contributions payable as of December 31, 2024 and 2023.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments. Additionally, \$31,098 of service fees were paid to Vanguard directly by the Plan in 2024.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trusts:* Valued based on the year-end market value of each unit held, using NAV, which is derived from the market value of the underlying net assets. This includes the Stable Value Fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Stable Value Common Collective Trust includes a common collective trust fund that is designed to deliver safety and stability by preserving principal and accumulating earnings. This fund is primarily invested in guaranteed investment contracts and synthetic investment contracts. Participant-directed redemptions have no restrictions; however, the Plan is required to provide a one-year redemption notice to liquidate its entire share in the fund.

Certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been categorized in the fair value hierarchy. The fair value amounts presented in the table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statement of financial position.

NOTE 4. PLAN TERMINATION

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to ERISA requirements. If the Plan is terminated, benefits will be distributed in accordance with the provisions of the Plan.

NOTE 5. TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan invests in shares of mutual funds and a common/collective trust managed by an affiliate of Vanguard. Vanguard acts as trustee for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. In addition, loans to participants also qualify as party-in-interest transactions. Participant loans as of December 31, 2024 and 2023 totaled \$415,553 and \$323,677, respectively.

NOTE 6. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation/depreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, were obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (the trustee of the Plan).

NOTE 7. TAX STATUS

The Plan has adopted The Vanguard Group Non-Standardized Pre-Approved Profit Sharing Plan with CODA, which is a non-standardized proto-type plan. The Plan has received a favorable determination letter from the IRS dated June 30, 2020, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan provides for various investment options in any combination of shares of registered investment companies or a common collective trust that invest in stocks, bonds, fixed income securities and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
