Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Wunderlich-Malec Engineering, Inc. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information,

NOTE 1 DESCRIPTION OF PLAN

The following description of Wunderlich-Malec Engineering, Inc. Profit Sharing and Salary Reduction Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established effective January 1, 1984, and amended and restated throughout the years to comply with tax legislation. The Plan was most last amended and restated effective August 3, 2023. The Plan is a defined contribution plan covering all employees of Wunderlich-Malec Engineering, Inc. (the Employer) and participating employers of Wunderlich-Malec Services, Inc., Case RMC, LLC, and Wunderlich-Malec AECM, Inc. During the 2023 Plan year, both Case RMC, LLC and Wunderlich-Malec AECM, Inc. were removed and are no longer participating employers. It is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Prior to August 3, 2023, employees are eligible for the Plan on the first day of each Plan year month upon completion of certain eligibility requirements, including completing six months of service with at least 500 hours and attaining the age requirement of 21. The Plan excludes employees covered by collective bargaining agreements, nonresident aliens, and leased employees.

Effective August 3, 2023, employees are eligible for the Plan on the first day of each Plan year month upon attaining the age requirement of 18. Also, the Employer contributions require completing six months of service with at least 500 hours. The Plan excludes employees covered by collective bargaining agreements, nonresident aliens, leased employees, interns and part-time/temporary/seasonal employees scheduled to work 1,000 hours or less.

Contributions

Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) and Roth contributions to the Plan. The Plan includes an auto-enrollment provision whereby a participant will be automatically enrolled in the Plan to defer at 6%, unless they elect otherwise. Participants are allowed to change the automatic deferral election. The Plan has an automatic increase feature which automatically increases participant deferral elections by 1% up to a maximum of 6%, unless the participant chooses to opt-out of automatic increases. The Plan allows participants age 50 and older to make catch-up contributions.

Employee after-tax contributions are also a contribution option to the Plan. These contributions are not eligible for Employer matching contributions.

Contributions (Continued)

Each year, at its discretion, the Employer may choose to make additional contributions to the Plan. Such contributions may be in the form of a discretionary matching contribution or profit sharing contribution allocated to all eligible participants. In order to receive an allocation of a discretionary profit sharing contribution, a participant must complete 1,000 hours of service during the Plan year, and be employed on the last day of the Plan year, unless termination is due to death, disability or attainment of normal retirement age (65). For the 2024 and 2023 Plan years, the Employer contributed a matching contribution of 50% of pre-tax 401(k) and Roth deferrals up to 6% of compensation deferred. For the years ended December 31, 2024 and 2023, the Employer also approved a discretionary profit sharing contribution at a rate of 2.3% and 2.1% of eligible compensation, respectively.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's profit sharing and matching contributions, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Employee contributions, plus actual earnings thereon, are immediately 100% vested. The Employer contributions, plus actual earnings thereon, vest at a rate of 20% per year starting with the second year of credited service. A participant is 100% vested after the completion of six years of credited service. Notwithstanding the above, participants shall, however, become 100% vested in their account upon reaching age 65, their death, or becoming totally and permanently disabled.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range up to five years or longer if used for the purchase of a principal residence. The notes are secured by the balance in the participant's account and bear interest at Prime plus 1%. Principal and interest is paid ratably through payroll deductions.

Benefit Payments

Upon termination of service, death, disability, or retirement (65), the participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum payment. If a participant terminates employment and the participant's account balance is not greater than \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, prior to January 1, 2024, or \$1,000 and \$7,000 effective January 1, 2024, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name. The Plan allows for hardship distributions, and also in-service distributions upon attaining age 59½, subject to Plan provisions.

Forfeitures

Forfeited nonvested amounts may be used to pay Plan expenses or to reduce future Employer contributions. There were no forfeitures used to pay Plan expenses during the years ended December 31, 2024 and 2023. Forfeitures in the amount of \$147,625 and \$130,379 were used to reduce Employer contributions that related to the years ended December 31, 2024 and 2023, respectively. The balance of forfeited nonvested accounts at December 31, 2024 and 2023 was \$186,496 and \$155,373, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian, and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses, including revenue sharing credits, are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Empower Trust Company, LLC, the qualified institution effective August 3, 2023, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the year ended December 31, 2024 and the period from August 3, 2023 through December 31, 2023, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

Charles Schwab Trust Bank, the qualified institution through August 2, 2023, has supplied the Plan administrator with certifications as to the completeness and accuracy of all investment information reflected on the accompanying statement of changes in net assets available for benefits for the period from January 1, 2023 through August 2, 2023.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Fund: Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts.

NOTE 6 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter received from the IRS on the pre-approved plan indicated that the pre-approved plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The pre-approved plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the qualified institutions of the Plan. Therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
