INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Identity Digital 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Identity Digital 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Identity Digital 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Responsibilities of Management for the Financial Statements

1. DESCRIPTION OF THE PLAN

The following description of the Identity Digital 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General

The Plan, a defined contribution savings plan sponsored by Identity Digital (the "Company" or "Employer"), pursuant to Section 401(a) and related provisions of the Internal Revenue Code ("IRC"), was established on January 1, 2013, and most recently amended and restated August 15, 2022, and amended on October 6, 2022. The Plan is designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination or financial hardship. The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan Sponsor has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan administration

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan. The Company has delegated certain responsibilities for the operation and administration of the Plan. Trustee services are provided by Ascensus (the "Trustee"), and record-keeping and administrative services are provided by Ascensus, LLC, an affiliate of the Trustee.

Eligibility

Employees of the Company are eligible to participate in the Plan upon reaching the age of 21, except union employees and nonresident aliens. Nonexcluded employees of the Company are eligible to enter the Plan immediately upon hire. Participants are eligible for matching contributions immediately upon hire and profit sharing contributions after completion of 1,000 hours of service, as defined in the Plan document.

Participant contributions

Each year, participants may contribute up to 50% of annual eligible compensation, as defined by the plan documents, as either pretax or after-tax Roth contributions, up to the maximum amount allowed by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. For the 2024 calendar year, maximum allowed deferral amounts per the IRC were \$23,000 plus an additional \$7,500 for participants age 50 or over. The Plan has auto enrollment and auto escalation provisions. Eligible participants are automatically enrolled to defer three percent of eligible compensation, unless the participant makes a contrary election. Elective deferrals will increase automatically each year, one percent per year up to a maximum of eight percent, for employees who are auto enrolled. Participants are also allowed to rollover contributions from other qualified employer-sponsored retirement plans and individual retirement accounts ("IRA").

Employer contributions

The Company may elect to make discretionary Employer matching or profit sharing contributions to the Plan. Discretionary profit sharing contributions are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. The Company made discretionary Employer matching contributions of \$975,450 for the year ended December 31, 2024. There were no discretionary profit sharing contributions for the year ended December 31, 2024.

Participant accounts

Each participant's account is credited with the participant's contributions, including rollovers, and an allocation of (a) the Employer discretionary matching or profit sharing contributions, if any, and (b) Plan earnings, and charged with an allocation of investment losses and administrative expenses not paid directly by the Company. Allocations of investment earnings are based strictly on the participant's selection of investments and timing of purchase. Other allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account and bear interest at a fixed rate that ranges between 4.25% and 9.50% as of December 31, 2024 and mature at various dates through May 2029. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a maximum period of fifteen years. Principal and interest is paid ratably through bi-weekly payroll deductions.

Vesting

Participants are immediately vested in their contributions along with Company discretionary matching and profit sharing contributions, plus actual earnings or losses thereon.

Payment of benefits

Distributions and withdrawals are payable upon retirement, termination, financial hardship, attainment of age 59 ½, disability, or death. A participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, installments over a period not exceeding the participant's assumed life expectancy, or partial withdrawals. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Upon termination of employment, if a participant's account balance is equal to or less than \$1,000 and the participant does not elect a distribution, the balance may be automatically distributed in a lump-sum cash payment. If a participant's account balance is greater than \$1,000 and less than or equal to \$5,000, the balance may be automatically rolled over into an IRA as designated by the Plan administrator. If the account balance is over \$5,000, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, a partial payment, direct rollover into another qualified plan, installments payments or may postpone payment to a later date and remain in the Plan as described in the plan documents.

Participants are permitted to request in-service distributions from their vested Plan accounts at any time after having attained age 59 ½. The Plan also allows participants to obtain a hardship distribution to satisfy certain immediate and heavy financial needs.

Effective January 1, 2024, the Plan's involuntary cash-out distributions was increased from \$5,000 to \$7,000.

Administrative expenses

Certain administrative expenses of the Plan, including recordkeeping and audit fees, were paid directly by the Company for the year ended December 31, 2024. Investment fees, which may vary according to the individual funds selected, are paid indirectly out of the assets of the Plan and impact Plan earnings.

Participants may be charged for some or all the costs and expenses of operating the Plan. Such expenses include, but are not limited to investment expenses and costs to process distributions, loans, and domestic relations orders. Generally, the Company pays for any administrative expenses of the Plan. The Plan is not required to reimburse the Company for expenses paid on its behalf.

Forfeitures

Forfeitures are the nonvested portion of a participant's account that is lost upon termination of employment. Forfeitures are retained in the Plan, and are first used to pay the Plan's administrative expenses, with any remaining amount used to reduce future Company contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10,402 and \$0, respectively. For the year ending December 31, 2024, no forfeitures were used to reduce Employer matching contributions or pay Plan expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and financial statement presentation

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent liabilities. Accordingly, actual results may differ from those estimates. Significant items subject to such estimates and assumptions include the fair value of investments.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and changes therein.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions and contributions receivable

Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by the Company, which is the pay date. Company discretionary profit sharing contributions are recorded in the year they are earned and coincide with the year in which the Company records the contributions in its general ledger. The Plan records receivables for contributions based upon the contribution recognized, less amounts received by the Plan as of the last day of the Plan year. Rollover contributions from participants are recorded based on the date the rollover contributions are received by the Trustee.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable is recorded when it is earned. Related fees are recorded as administrative expenses and expensed when they are incurred.

If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Administrative expenses are recorded when paid.

Subsequent events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued. Plan management is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

3. FAIR VALUE MEASUREMENTS

Accounting standards define fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Such standards establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date;

Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities;

Level 3 - inputs are unobservable for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following methods and assumptions were used to estimate the fair value of financial instrument. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds and Money Market Funds - valued at the net asset value ("NAV") of shares held by the Plan at year end which are quoted in an active market. Investments are valued using market quotations or prices obtained from independent pricing services and used to determine the NAV of the fund. The mutual funds held by the Plan are deemed to have a readily determinable fair value and are classified within Level 1 of the fair value hierarchy.

4. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the Plan's investment information, and related activity, certified by the Trustee, determined to be a qualified institution by the Plan administrator, as complete and accurate, except for comparing such information to corresponding information included in the Plan's financial statements and supplemental schedule of assets (held at end of year). The Trustee has certified that the following data included in the financial statements is complete and accurate:

- Investments and notes receivable from participants reflected on the accompanying statement of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and,
- Investments and notes receivable from participants reflected on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines party-in-interest similar to a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Plan management did not identify any related parties to the Plan that were not also considered to be parties-in-interest.

Party-in-interest include those with fiduciaries or employees of the, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Notes receivable from participants and the related interest income are also considered party-in-interest transactions.

In addition, the Company pays certain fees and expenses on behalf of the Plan. The Plan is not obligated to reimburse the Company for expenses paid on its behalf. These transactions qualify as party-in-interest transactions permitted under provisions of ERISA.

The Trustee retains as compensation for services provided to the Plan any interest on amounts earned while certain transactions are pending. This applies to both contributions and distributions. Earnings are at institutional money market rates. Additionally, certain fund level fees incurred by the funds in which the Plan invests for such services as investment management and sub-transfer agency fees are paid through fund level revenue sharing arrangements. These fees reduce fund earnings thereby impacting Plan revenue applied to participants' accounts.

Certain investments offered under the Plan are managed by Vanguard, an affiliate of Ascensus. Ascensus provides trustee, recordkeeping and administrative services to the Plan, therefore, these transactions qualify as exempt party-in-interest transactions specifically exempted from the prohibited transaction rules of ERISA.

7. TAX STATUS

The Plan has adopted the Ascensus LLC Non-standardized Pre-Approved Profit Sharing Plan with CODA. The Internal Revenue Service informed Ascensus LLC by a letter dated June 30, 2020, that its plan document is designed in accordance with applicable sections of the IRC, and any employer adopting this form of the plan will be considered to have a plan qualified under applicable sections of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.
