Note 1 - Plan Description

The following description of Honigman LLP Income Deferral and Profit Sharing Plan (the "Plan") provides only general information. A comprehensive outline of plan provisions, eligibility requirements, termination, and other information is included in the plan document and should be consulted for more details.

The Plan was established under provisions of Section 401(k) of the Internal Revenue Code on November 18, 1983 and was amended and restated effective November 3, 2008. The most recent amendment to the restated plan document effective January 1, 2024 provides eligibility to Professional Track Attorneys to participate in the Plan, reduces the years of service required to be eligible for the profit-sharing component of the Plan from two years to one year for covered employees, and removes certain requirements allowing prior service in the legal industry to count toward the Plan's years of service requirements. The amendment and any applicable changes in law were not significant to the Plan. The Plan is administered by a committee of partners of Honigman LLP (the "Firm" or the "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

General

For participation in the income deferral component of the Plan, 90 days of service are required. For participation in the profit-sharing component of the Plan, two years or more of service completed on or after January 1, 1991 are required. The plan amendment effective January 1, 2024 allows eligible employees to participate in the profit-sharing component after one year of service. Employees and partners (excluding partners who have, at any time, held more than a 10 percent interest in capital or profits of the Firm) become participants in the Plan as soon as participation requirements are met and necessary applications are submitted.

Contributions

The Plan provides for employee deferral contributions up to a maximum of 50 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Matching contributions are made to the Plan by the Firm and are allocated to the accounts of eligible participants, as defined and limited by the Plan. The Plan provides for employer matching contributions of 25 percent of the participant's contribution, not to exceed 5 percent of the employee's creditable compensation, as defined by the Plan. All contributions are invested in the Plan, as directed by the Plan's participants. Participants' accounts are 100 percent vested and nonforfeitable at all times.

For the profit-sharing component of the Plan, contributions are made by the Firm in each plan year. In 2024, annual contributions per participant were equal to 5 percent of creditable compensation, as defined by the Plan, up to the 2024 Social Security wage base of \$168,600 plus 8 percent to 22 percent of creditable compensation in excess of \$168,600 to a maximum contribution of \$46,000. Contributions to the Plan are required and are without regard to the Firm's actual profits. The profit-sharing component is paid subsequent to the Plan's year end, and is shown as a contributions receivable on the accompanying statement of net assets available for benefits. Participants' accounts are 100 percent vested and nonforfeitable at all times. Participants' accounts are participant directed. Participants can also elect to direct their investments among the various investment options offered by the Plan.

Participant Distributions

Upon termination of employment, attainment of age 59½, or death, participants (or their beneficiaries) are entitled to payment of all or a portion of their plan account balances. Distributions are payable in a lump sum or in fixed periodic payments, as limited by the Plan and elected by the participant. A participant who experiences a financial hardship is eligible to receive a distribution subject to certain restrictions.

Note 1 - Plan Description (Continued)

Participant Accounts

Each participant's account is adjusted on a daily basis to reflect net earnings, including realized and unrealized gains or losses of the Plan, and investment appreciation or depreciation. Adjustments are allocated based on each participant's proportionate share of the aggregate account balances. Each participant's account is credited with the participant's contribution and allocations of the Firm's contributions. Administrative expenses are related to transactions initiated by participants and are charged to individual participant accounts.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Additions, Deductions, and Changes in Net Assets

The accounting records of the Plan are maintained on the accrual basis. Assets of the Plan are recorded at fair value; accordingly, unrealized appreciation or depreciation of plan assets is included in the statement of changes in net assets available for benefits. Contributions, including contributions receivable, are recorded on the accrual basis in the plan year to which the contribution applies. Distributions to beneficiaries are recorded when distributed by the Plan. Administrative expenses are recorded when incurred.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 8, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Charles Schwab Trust Bank (the "Trustee") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year is based solely on information certified by the Trustee.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Note 5 - Fair Value Measurements (Continued)

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Common/Collective Trust Funds

The common/collective trust funds are valued at net asset value per share (NAV) or its equivalent of the funds, which is based on the fair value of the funds' underlying net assets. There were no unfunded commitments or redemption restrictions on the common collective trust funds.

Self-directed Brokerage Accounts

The Plan allows participants to invest in self-directed brokerage accounts. The self-directed brokerage accounts include cash; certificates of deposit; and various investments, such as corporate stock, money market accounts, U.S. government securities, corporate debt securities, and mutual funds. The U.S. government securities and corporate debt securities are valued using quoted market prices and/or other market data for the same or comparable instruments and transactions in establishing the prices, discounted cash flow models, and other pricing models. These models are primarily industry-standard models that consider various assumptions, including time value and yield curve, as well as other relevant economic measures. The cash and certificates of deposit accounts are valued at fair value based on their outstanding balances. All other investments are valued based on quoted market prices.

Although the Plan has been amended since receiving the determination letter, management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for income taxes has been made in the accompanying financial statements.

Note 7 - Plan Modification, Amendment, and Termination

The Firm may modify, amend, or terminate the Plan at any time at its sole discretion by a duly authorized representative. In the event of complete termination of the Plan, the balance in each participant's account will be distributed in cash if no successor plan, as defined in the plan agreement, exists within 12 months of the Plan's termination. The Firm periodically considers modifications and amendments to the Plan, but no such modifications or amendments have been formally recommended at present, nor is the Firm currently contemplating termination of the Plan.

Note 8 - Party-in-interest Transactions

Certain of the Plan's common/collective trust fund investments are sponsored by an affiliate of the Trustee; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. In addition, the Firm paid certain administrative expenses of the Plan during the year ended December 31, 2024. These expenses are not significant to the Plan's net assets.
